The joint standing committee of the Legislature having jurisdiction over marine resources
 matters may report out a bill on the subject of the report to the First Regular Session of

SUMMARY

24 This amendment provides that the Commissioner of Marine Resources may enter into agreements with the United States Department of Commerce, National Oceanic and 25 Atmospheric Administration and seafood producers for the issuance of certificates of 26 compliance required by international regulations and may seek reimbursement from the 27 National Oceanic and Atmospheric Administration for the costs incurred by the 28 29 Department of Marine Resources for the inspection and certification program. Such 30 agreements would allow the department to perform inspections that are otherwise 31 performed by National Oceanic and Atmospheric Administration. The amendment also requires the commissioner to submit a report to the joint standing committee of the 32 Legislature having jurisdiction over marine resources matters detailing the department's 33 progress regarding a voluntary fishery product inspection program, including draft 34 legislation if necessary to implement the program. It also gives the committee permission 35 36 to report out a bill to the First Regular Session of the 126th Legislature.
