19 20	(1) "Appointing authority" means an entity authorized pursuant to law or resolve to appoint a member to a citizen advisory committee.

- 1(2) To each municipality and any other appointing authority, a copy of the2license or amendment application. The copy must be sent by United States Postal3Service, certified mail, return receipt requested or by a commercial mail delivery4service with a comparable proof of delivery.
- 5 C. When filing a license or amendment application, the owner or operator of a solid 6 waste disposal facility shall submit to the department a copy of the certified mail 7 receipts or comparable proof of delivery received under paragraph B.
- 8 The department may not issue a license or an amendment to a license prior to 30 days 9 after the latest date of mailing of an application or notice sent in accordance with 10 paragraph B.'

## SUMMARY

- 12 This amendment is the majority report of the committee. The amendment prohibits 13 the Department of Environmental Protection from issuing a license, permit, order or 14 approval, or an amendment to a license, permit, order or approval for alterations that are 15 not minor alterations, to a state-owned solid waste disposal facility unless the owner or 16 operator of the facility sends:
- 17 1. To each municipality and any other entity that appoints members to the relevant 18 citizen advisory committee, a copy of the application; and
- 192. To each member of the citizen advisory committee, a notice that the application20 has been sent to the appointing authorities as required.
