10 11 12 13 14 15 16 17	Like the bill, this amendment restructures the system of compensating workers who are injured on the job. Unlike the bill, which proposes changes to the current laws governing workers' compensation, this amendment repeals the laws establishing the Maine Workers' Compensation Act of 1992. Under this amendment, beginning July 1, 2013, an employee injured while on the job would seek compensation for the employee's damages through the judicial system. This amendment directs the Workers' Compensation Board to develop a plan for the transition and transfer of jurisdiction to the judicial branch.
