1	SUMMARY
2	This amendment is the majority report of the committee and it replaces the bill. It
3	requires a person applying for licensure with the State Board of Nursing to submit to
4	having fingerprints taken by a law enforcement officer in order for the board to obtain
5	state and national criminal history record information from the Federal Bureau of
6	Investigation. It provides that the criminal history record information is confidential and
7	any action taken by the board based upon this information against an applicant is subject
8	to the procedures under state law for occupational license disqualification based upon
9	criminal record. It establishes a fund to reimburse the Department of Public Safety for
10	the cost of conducting the fingerprinting and state and national criminal history record
11	checks. It also adds an appropriations and allocations section.
