The SPEAKER: The Chair recognizes the Representative from Auburn, Representative Bolduc.

Representative **BOLDUC**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House. Good morning. I rise today to briefly address LD 29, a bill that was unanimously reported out of the Health and Human Services Committee. I am very proud to say that I always receive a unanimous report out of the committees on my bills.

As we all know, the healthcare system in this country is in a state of crisis. A President is elected on a platform to overhaul the system and two years later after fierce debate, a congress is elected on a platform to reverse these healthcare initiatives. Doctors blame administrators, administrators blame insurance companies, insurance companies blame poor lifestyle choices of the patients and on and on it goes. What has happened, how is it that healthcare has become a lucrative industry for so many? Why isn't the care of the sick and ill in our society considered a public service like teaching or legislating or firefighting? Why is it that so many individuals are becoming millionaires off the sickness of others? It is in my opinion a microcosm of the greed and rampant consumerism our modern society falls prey to. It baffles me that we have somehow gotten to a point as a society that we consider it acceptable to pay hospital administrators millions of dollars a year, not just here in Maine but nationally. It is an indication of big time moral corruption in the nation's healthcare industry.

LD 29 is an attempt to address one of the many injustices present in our healthcare system. These so called "non profit" hospitals which are heavily subsidized by the federal, state and local government and taxpayers should not be doling out these shameless and astronomical salaries. It is an insult to every wage earner in the state. I also don't buy the argument that these positions are so competitive at the national level that hospitals need to offer these outrageous salaries to find qualified applicants. This reasoning does not pass the straight face test. If the board of directors can't find an individual who can run a hospital and want to move to our beautiful state for let's say half a million dollars a year, then the board is not doing their job. Thank you very much, Mr. Speaker.
