I am putting us in the position to be able to make the technical amendment to this very important piece of legislation. I want to thank the Criminal Justice and Public Safety Committee for their important work in bringing this issue forward. I want to thank Representative Plummer and Representative Haskell, who yesterday helped me along with my chair, Representative Flood, in addressing some minor technical issues that will move this forward and expedite the dealing with this difficult and challenging public safety problem. Thank you, Mr. Speaker.

Representative **WEBSTER**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House. I want to again thank the committee and all those involved. This is a very difficult and challenging issue regarding a synthetic drug that has a name bath salts, but is much more, which sounds innocuous but is actually a very difficult drug. There was again another article today in the paper regarding an incident. Again I want to thank the committee. We have had to make some adjustments in the structure of the bill in order to address some fiscal concerns and then again some changes, in order to address some concerns that were raised to us by those who need these tools in order to provide the proper response and provide public safety. So I want to thank the committee, Representative Plummer, Representative Haskell, and in the other body, Senator Katz, who has assisted in making this happen. Thank you.

The SPEAKER: The Chair recognizes the Representative from Windham, Representative Plummer.

Representative **PLUMMER**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I just want to be sure people understand what we are voting on. Bath salts are

not something that you would dump in the bathtub. Bath salts are a very hallucinogenic drug that has recently become available and it has unfortunately made its way to Maine. The committee had originally wanted harsher penalties than the penalties that are imposed in the Representative from Freeport, Representative Webster's, amendment. However, we understand the reality of financing this bill. We understand that the longer you put people in prison the more it costs. So this is a way that we see that this bill can pass, can become effective, and I believe it does have an emergency preamble, so it will become effective right away. I know that this has the support of the sponsor, Representative Berry, of Bowdoinham. It also has the support of the Democratic lead, Representative Haskell, from Portland, as well as myself. So I would urge everyone to vote for this bill and Representative Berry also suggested that I ask for a roll call, so I will do that as well, Mr. Speaker. Thank you.

Governor **LePAGE**: As the session is coming to a close, I think it appropriate for me to come up and, one, to thank you all for all the hard work, difficult work, challenging work at times, and at the same time to remind everyone that we have been sent here to do a job by the people of the State of Maine. In the last six months, we have attempted to put forth to you, and in front of the Senate, those items that we campaigned on very strenuously over a year and a half.

Recently, and many of you have seen it, we had polls taken on where we stand on certain issues and I'd like to say to all of you that some of the key reforms that were necessary to, one, keep our bond rating, you've addressed. At least we've addressed it and made a start with it. I think it was very important that to the rating agencies that we improve our cash flow, that we put some money into the rainy day fund, and that we reform or we address our unfunded liability. I commend you all for the fine work that was done on the pensions. I think that the work done on the state pensions is fabulous. I think it's really good work, it was hard work, but we got through a very, very difficult challenge.

Tax reform is another area where I believe we have done something that has not been done for a long time, probably never in the State of Maine. We've addressed the poorest people in the state and we've taken them off paying income tax and at the same token we've looked at business and we've opened up areas where if we're going to prosper, we are addressing it and we're giving them some opportunities.

We've corrected a major reform in health care. I believe LD 1333, it is the one piece of legislation that I particularly take pride of and I thank you all so much. That is a wonderful piece of legislation and over the years you are going to see Maine being a top notch, it's going to go back to the top, not only in affordable health care but in quality health care.

There still needs a lot to be done. By reforming the tax side, one area that we need to look at when we come back in January is the spending side because you can lower the taxes, but if you don't address spending in the same way that you lower the taxes, you're just making it a short-term reform. If we're going to improve Maine we have to make it a long-term reform and we have to address some of the issues that are some of our spending challenges.

In the next six months, we are going to go through every agency and look at every line item that they spend and we will have a package for you in January to address, to see how we can reform and make government more efficient. We are going to have to address education and welfare. I think we've started on education. I think that we have the opportunity to lower the cost and improve the product, and I think that's the goal and Commissioner Bowen is dedicated and committed to doing just that.

In the welfare areas I will say that we've made and started, but we need to address the big picture. We need to be competitive with 49 other states on welfare and we are not. There are 47 states that are less generous than Maine. And it's nice to be generous and I wish we could afford it, but generosity starts at home. I'm urging you to make the reforms necessary in the next session to help Maine people.

This morning I got a report on energy. Last year, we were ranked number 12th of the highest cost of energy in the country. This week we are now ranked number eight. We have some of the highest energy costs in the nation and if we want to prosper, if we want to put our natural resources and our farms and our fishing industry back into a position where they are going to be profitable, we simply need to address our energy costs.

Now we have the highest renewable portfolio in the nation. We are at 34 percent, and with the energy bill passed this year,

we're heading to 44 percent. I would love to tell you that renewable energies are the way to go and that's going to lower the costs, but it isn't. It's the simple fact, we can agree or disagree, but right now we are paying 15.9 cents per kilowatt hour, on average, with a nation that is just around 12. We cannot attract businesses that are energy users in that environment. We have started the job. I'm going to ask you to finish it in the January session.

The other thing and I do want to thank each and every one of you, we haven't completed the job, but at least we have it on the table for discussion. When you go home this summer, I would urge you all to speak to your constituents about some of the things that they want because the one thing that I'm finding out on a monthly basis when we go do our Capitol for a Day is there are several issues, energy being one of them, but we had a discussion on the right to work that went down to fair share.

I'm going to ask you all to look deep in your heart and say is it right, is it right to force someone to pay to keep a job? I maintain that there's absolutely nothing wrong with being in organized labor and the success of organized labor is if they add value to their product. If they add value and they have a good product like many unions around the country, many unions around the country, instead of getting involved in political campaigns, they get involved in self development for their people and provide training for their people so that we have a better product.

So I'm going to ask you for fair share next year again. It's very, very important for the people that work for the state, it's important for the morale of the people who work for the state that don't want to have to pay. Now do they lose protection? Absolutely and they ought to, but I think we have to have an equal playing field. I find it very disheartening to say you can't work here unless you pay so much a week.

With that, I think there was a lot, a lot of good work done this year. I think we probably moved the state forward in legislation, in actual bipartisan legislation, far more than we have in many, many years. I thank you all. Have a good summer. Rest up because we're going to have a tough agenda in January. Thank you.

Representative **PILON**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. LD 98 is a Resolve, Directing the Commissioner of Education To Adopt a Policy Regarding Management of Head Injuries in Youth Sports. This Resolve would bring stakeholders together over the summer and they include organizations like the Maine Principals' Association, the Maine School Superintendents Association, the Maine School Board Association, the Maine School Management Association, and the Acquired Brain Injury Advisory Council, sports medicine practitioners, medical providers, and school athletic directors and trainers to work on a policy on head injuries in athletics for children.

Head injuries have been a big issue in sports for children, Mr. Speaker, in youth sports, whether it's soccer, basketball, football,

lacrosse. Young children in their early ages, their brain hasn't developed and they don't have, as this neurologist described to me, the insulation around the brain. So if they incur a number of impacts, the brain is jostled around and as it hits the interior wall of the skull, if a young child incurs a number of these experiences, it will impair that child's ability to learn. Though what we're trying to do is bring these working groups together to draft some protocols for schools to address this issue, so if a child is at a soccer game or a football game and the coach believes that that child has incurred a slight concussion because he or she is dazed, walking around dazed on the field, the coach brings that child off the field, there is someone on the sideline that can evaluate the child before the child is allowed to go back on the field.

During the committee and the public hearing and the work session, there was some discussion about what is the appropriate evaluator. Is it a neurologist? Is it a physical therapist? Is it an EMT? What we learned, Mr. Speaker, that up north at some of these football games, the best they can provide to evaluate a child is an EMT. Now does the EMT have the proper training to evaluate a child, perhaps not. So this is the kind of thing that needs to be discussed during this session to see if we have the right people or do these people have the right training to evaluate if the child has had a concussion, or do we need to discuss expanding the evaluators to include EMTs and make sure the EMTs have the proper training to evaluate if the child should be allowed to go back on the field and continue play.

Now the other problem as we all know is that the child wants to go back on the field because the child wants to make sure that he does a good job for mom and dad who's up in the stands yelling "Go back on the field, Johnny. We want you to be playing on the field." Or the coach, he wants to be a good player for the coach and if he or she feels that they have to fulfill or finish the game. So there is a lot of peer pressure to finish the game as well, but we have to make sure, Mr. Speaker, that we have the right evaluators on the sidelines to make sure that that child does not have a concussion and should be allowed on the field. So all this Resolve does is bring all the stakeholders together and draft some kind of a policy for all schools and sports activities. Thank you, Mr. Speaker.

Representative **MAZUREK**: Thank you, Mr. Speaker. Mr. Speaker, Ladies and Gentlemen of the House. I speak to you today as a former coach and am quite familiar with head injuries and players getting hurt. I was one of the fortunate coaches that in the many years that I coached, I never really lost a player to a head injury. Whether it was pure luck or the fact that we didn't allow our kids to go out if they came off the field with what I would call a dinger, but never lost a kid to a concussion in over 25 years of coaching. But that, I was lucky. I was lucky in a lot of respects and having the proper people on the sideline to evaluate when a kid is injured is very important.

I'll tell you a story. This is a true story. I was coaching at the high school level. My son was playing at the junior high level. It was a Tuesday afternoon. I finished my varsity practice and I went down to the eighth grade game to watch my son play. I got there at halftime just to watch the kickoff and Richard was the kickoff man, so he kicked the ball down, the other team made the tackle, another kid made the tackle and he came off the field. I watched the coach. The coach was talking to him and at that

time we did have a lady who was an EMT, she came over and then the next thing I looked over and there was Richard laying on the ground with a board strapped to his head, his head wrapped around, and he was rushed to the hospital and we found out he had a broken neck. How close he came, if he had ever made that hit, I don't know. But I was very thankful that when he came off, we had a person on the sidelines who was able to recognize the fact that something was wrong and put him down and strapped him in and didn't allow him to move. Today he is a healthy father of a boy and a girl and a good worker.

The proper authority on the sideline is vital. This Resolve brings an awareness to injuries, not only just in football but in all sports. Soccer, basketball. I've seen kids take tremendous hits falling on a basketball floor. I've seen kids bump heads. I've seen knees go into kids in soccer games. In softball I've seen kids take pitches off their helmets. You cannot be overly cautious when you're dealing with the health of the student athletes and what we do at the high school level is very important, Mr. Speaker, because the pee-wee coaches, they follow the high school coaches and so do the players. We see today kids are bigger, they are stronger, they are quicker, they hit harder than 20 years ago, so the risk of injury is greater many times. So I am asking to put aside partisan politics on this issue. This, to me, is very important because we always hear we worry about our kids and our education. Well, here's something we can do as a Legislature. We can help the kids of Maine play safer and better sports. I hope we can find it in our collective hearts and brains to pass a Resolve that is only going to benefit the students of Maine. Thank you, Mr. Speaker.

Representative **CAIN**: Thank you, Mr. Speaker. Mr. Speaker, Men and Women of the House. We have done some great work this session. The budget and regulatory reform are the two most significant bipartisan pieces of legislation we accomplished together this session. Both the Appropriations Committee and the Regulatory Fairness and Reform Committee deserve high praise and thanks for bringing us unanimous reports that we could support on behalf of Maine people. We have not always agreed and that is okay. House Democrats have left their mark this session by standing up for the environment, for working families including our public employees, small businesses and Maine's elderly. To my staff in the Speaker's Office, I say thank you. The whole staff has been great to work with. It was an assemblage of people who had worked here in the past and new people, people I knew and some people I didn't. I think their work has been exemplary.

To the staff in the House Republican Office and in the House Democratic Office, I thank you. Every time I needed help, every time I needed to make contacts with somebody, it didn't matter which one of those two offices it was that I went to, I felt welcome and I got the information that I needed.

To Representatives Cain and Hayes and Curtis and Cushing, my deepest thanks for helping bring together all 153 of you to do the good work that we have done. We have, as Representative Cain has told you, we don't always agree. I don't agree all the time with anybody in this room. The only person that I can think of that I agree with every time is my wife. If she is listening, this is points for me. We don't agree with each other on everything, but when we all come together and when we all work with respect, we do great things. I think we did great things this time. There were things that people would have enjoyed doing or would like to have done or came here to do on both sides of the aisle that didn't come to pass. They take bets downstairs on how many times I will say "The House is really in order" or "The House is in order," but it hasn't been that hard. This is a great group of people. It is my pleasure and my privilege to be here and I thank you for that opportunity.
