- D. The Director of the Bureau of Child and Family Services or the director's designee;
- E. The Executive Director of the Maine State Employees Association or the executive director's designee; and
- F. One representative of the employees of the Legislative Council and one representative of local day-care providers in the greater Augusta area, appointed jointly by the President of the Senate and the Speaker of the House. These 2 members must be selected from among applications submitted to the Executive Director of the Legislative Council.
- 3. Appointments; convening committee. All appointments must be made no later than 15 days following the effective date of this order. The Executive Director of the Legislative Council must be notified by all appointing authorities once the selections have been made. Within 7 days after appointment of all members, the Chair of the Legislative Council shall call and convene the first meeting of the committee. At its first meeting, the committee shall select a chair from among its legislative members.
- 4. Duties. The committee shall develop a plan for locating a day-care center in the capitol complex. This plan must include the number of children to be served; the financial needs involved in establishing and operating a day-care center in the capitol complex; the staffing and other support services necessary for the operation of a day-care center; and the desired location of the day-care center.
- 5. Staff assistance; consultant. The committee may request staffing assistance from the Legislative Council. The committee may also consult with other professionals who provide day-care services.
- 6. Expenses. Legislative members of the committee are entitled to receive the legislative per diem and reimbursement of necessary expenses for their attendance at authorized meetings of the committee.

7. Report. The committee shall submit its findings and plan, along with any necessary implementing legislation, to the First Regular Session of the 119th Legislature by May 14, 1999. If the committee requires an extension of time to make this report, it may apply to the Legislative Council, which may grant the extension.
