THE PRESIDENT PRO TEM: The Chair is pleased to recognize in the rear of the Chamber the Teacher of the Year for 1999, Mr. Todd Fields from Biddeford. Mr. Fields teaches in Westbrook at Westbrook High School and lives in Biddeford. He is the guest today of the Senators from York, Senator LaFountain and Senator MacKinnon, and the Senator from Cumberland, Senator O'Gara. Senator LAFOUNTAIN: Thank you Mr. President. Men and women of the Senate. I am pleased to address the Senate today in order to recognize the achievement of my constituent and neighbor, Todd Fields of Biddeford. Todd was one of three finalists for the Year 2000 Teacher of the Year Program and in a surprise assembly held last fall at Westbrook High School he was notified of this distinction as being named the Year 2000 Teacher of the Year. Todd has a distinguished 15 year career in technology, vocational and technical education, including 11 years experience as drafting instructor for Westbrook Regional Vocational Center, 7 years as computer aided drafting instructor for Westbrook Adult Education, and 3 years teaching industrial arts in Maine and New Hampshire. Todd's dedication to growth and development of his students has been manifested not only in his decade long service as advisor of the Westbrook Chapter of the National Vocational Technical Honor Society but also in the numerous awards won by his students, including 15 Skills USA VICA medals; 1 National, 2 Regional and 1 State championship in the National Association of Women in Construction; the WCSH TV award; and the Maine Vocational Association Outstanding Non-Traditional Student award and in the exceptional high percentage of his students that successfully complete his program and go on to more specialized training, technical colleges, and four year baccalaureate degree programs. Todd comes from an extended family of teachers and educators. His wife, Ellen, who is a lifelong friend of mine, is a teacher at the Middle School at Westbrook High School. His sister-in-law, Kathy, who served as my babysitter growing up, teaches elementary school at Kennedy School in Biddeford. His mother-in-law, Mary Chenard, who passed away last year, taught in Biddeford for approximately 25 vears and was one of the most popular and respected educators from the Biddeford system. I wish to personally congratulate Todd on his achievement and I wish him luck this spring as he travels to Washington DC to represent the State of Maine as Maine's Teacher of the Year. Thank you.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Cumberland, Senator O'Gara.

Senator **O'GARA**: Thank you Mr. President. Mr. President and ladies and gentlemen of the Senate, the Senator from York has spoken eloquently of Mr. Fields and I will not attempt to add very much more to that except to say that I just want the Senate to know that Mr. Fields' colleagues and his students are very proud of his work and of his teaching skills and his teaching style, which has had such a marked impression on the students that he has had and I know will continue to have in the future. We just wanted to express, on behalf of the Westbrook delegation, our pride and our sincere congratulations and to add to the Senator's best wishes as you travel and compete with the National level. Thank you Mr. President.

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from York, Senator MacKinnon.

Senator **MACKINNON**: Thank you Mr. President. Men and women of the Senate, it gives me a great deal of pleasure to stand today to recognize Todd Fields as Maine's Teacher of the Year. Prior to listing all those years of experience, he had to go

through one year of experience in U.S. History as I was his history teacher in his Junior year of High School. So some of the things he may have had now. I may be able to bury and bring up from the past. I certainly would not do that because, as an educator and a former educator, it gives me great deal of pleasure to stand before you to recognize, not only a former student, but somebody that you've watched and admired. As a teacher you sometimes never get to see a person fulfill their dream or fulfill things in their lives that make you very proud and also know that you had, or hopefully had some type of impact, on this person. Personally, last year I had a tremendous amount of pride when I walked down to the Rotunda and saw Todd and watched his portfolio he developed being shown. Not only the pride that he took into that but the pride of the people and his parents around him, it was very nice for me to see. I'm certainly very, very happy that he is here today representing the good educators of the State of Maine and will go on to other places. But more importantly, he's giving back to his community and to his State in the form of education, when he could have been out in private business and doing things, I'm sure, monetarily. But the things and the people that he is affecting are affecting our future and for that I'm very proud of him, very proud to have known him as a former student and to be associated with him in school activities. I know his family very well and today is a nice day in the Rotunda. Our color of the bright sun in here not only shines here but also on him. For that I'm very appreciative. Thank you.
