The President laid before the Senate the following: "Shall the recommendation of the Committee on **JUDICIARY** be overridden?"

**THE PRESIDENT**: The Chair recognizes the Senator from York, Senator Hobbins.

Senator HOBBINS: Thank you, Madame President, men and women of the Senate. I stand before you to recommend confirmation of Charles A. Dow for appointment as a Maine District Court Judge. Chuck was born and raised in Ft. Kent, Maine. Following his graduation from Ft. Kent High School, he attended the University of Maine at Ft. Kent. He graduated magna cum laude with a Bachelor's degree with a double major in English and Social Studies. Chuck then went on to receive his law degree from the University of Maine Law School in 1997. After attending the Law School, he was simultaneously taking courses in pursuit of his Master's degree in Public Policy and working part-time to defray expenses. He gained hands-on experience in Maine's District Court by participating in the Law School's Legal Aide Clinic in 1996 and 1997. He was also President of the Maine Association for Public Interest Law at the University of Maine Law School. After graduation he received a coveted Student Bar Association Award for Distinguished Service. which is annually given to a student of excellent ability.

Chuck Dow is an admired member of the Attorney General's Office and in state government in general. He is a son of a Northern Mainer who has consistently excelled in positions that require superior legal, analytical, and communicating skills. This, coupled with his energy, his enthusiasm, and time tested commitment to public service, will make Chuck a credit to the Judiciary for years to come.

During his confirmation hearing there were many testimonials in favor of his nomination. One was from a childhood friend, Attorney Robert Nadeau, who is a practicing attorney and partner in the firm of Drummond, Woodsom, and MacMahon in Portland. He spoke in strong favor and enthusiastically supported without reservation this nomination. If I may just quote a couple of phrases from Mr. Nadeau, who probably knows Chuck Dow as well as anyone, maybe except someone who's a member of this Body. It says here that, 'Chuck and I were both raised in Ft. Kent. I have known him for approximately 16 years, since the time that we were both undergraduates at the University of Maine at Ft. Kent. Chuck is a bright, thoughtful, and engaging person. I believe that he will approach the matters brought before him in his capacity as a judge reasonably and objectively. He will be fair, careful, and deliberate. Chuck is analytically skillful and has the intelligence and temperament to be an outstanding judge.' He goes on to say that he is familiar with Chuck's reputation among the people of Ft. Kent and his reputation is excellent. Everyone he knows likes and respects Chuck because he is an exceptionally smart and sincere individual. I think I can say that if it was not in the month of January when this hearing was held, and Ft. Kent was not five hours away, the room would have been filled with supporters. Mr. Nadeau goes on to say, 'Chuck is a very good person. He's prudent and has genuine concerns for those around him. I would trust him to handle fairly and skillfully

any matter that I, as an attorney, would take before him. Chuck is a quick study and he unquestionably has the ability to come up to speed readily on the various issues that would be presented in a courtroom. If I found myself representing a client in Chuck's courtroom I would know that he would conduct any hearing objectively and would pursue his duties conscientiously. I know that he would be fair and skillful.'

There were other accolades that were brought up at the hearing. He was supported, without reservation, by the Attorney General of the State of Maine. He was also supported and had comments made by Representative Patrick Flood, who appeared before our committee and whom I have a great deal of respect for. In summary, what the letter from Representative Flood says is, 'He is a good listener when I have brought issues to him for discussion. Most memorable is our conversation last year reviewing and clarifying the various maps provided by the late Governor Percival Baxter regarding his wishes for Baxter Park and how the late Governor's beliefs could be applied appropriately to last year's discussions regarding the Park and potential additions to the Park. This information was helpful in formulating potential solutions to the discussions before the Agriculture, Conservation and Forestry Committee at that time. Those discussions led to further reviews with the Baxter Park Authority and the ACF Committee, leading to an eventual resolution to that transaction. The time Chuck spent with me was very helpful in pinning down what was possibly and practical for this transaction.'

I urge you today to join me in supporting this recommendation of the Judiciary Committee for the confirmation of Charles Dow to the position of Maine District Court Judge. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Oxford, Senator Hastings.

Senator HASTINGS: Thank you, Madame President, ladies and gentlemen of the Senate. I take no pleasure in rising today to speak against the nomination of Mr. Dow. I do so without a sense of partisanship. I take no pleasure in doing this. I voted against his nomination in the Judiciary Committee. I take no pleasure because Mr. Dow is, as the good Senator from York, Senator Hobbins, has stated, a fine man. A man of intelligence. A man of sincere desire to serve the people of Maine. A man of compassion. In sum, he has the temperament that I would expect of a judge. He's a fine man. I sincerely regret any embarrassment that opposition to his nomination creates for him. I don't rise in partisanship. I do not believe partisanship plays any role in the nomination or appointment of a judge. It's a great obligation we have to confirm and that means to review and confirm. I never opposed a nomination of this Governor during my term in the Judiciary Committee and I wholeheartedly support all of the other nominees before us today. I do believe that Judiciary Committee, by law and this Body, has an obligation to not simply rubber stamp a nomination but to inquire as to the qualifications, because we really are the protectors of the public. The public deserves highly qualified judges to preserve our rule of law.

I looked to the Statutes for guidance. There really is no guidance. It simply says that the Chief Executive, the Governor, appoints and that this Body confirms after review by the Judiciary Committee. There is no standard for that review, so I looked to the Statutes. Quite honestly the only statutory qualification to

become a District Court Judge, really the front line judges of our Judiciary, is that one be a member of the Maine Bar, I would hope that no one in this Body believes that this is the sole qualification that we should require in confirming a judicial nomination. So I looked beyond that, for our Superior Courts and Law Court Judges there is some arcane language which we probably wouldn't use today but can be translated, that nominees be 'learned in the law and having sobriety of manner.' Phrases we would never use today. I think it clearly translates to the standards that the Judiciary Committee and the proponents and opponents of judicial nominees have spoken to in committee. Number one, experience. Experience that will allow them to step quickly into that judicial role. Secondly, temperament. You can't have one without the other. You can be very highly experienced lawyer but not have a good temperament and compassion it takes to deal with those who appear before courts. Compassion alone, or temperament alone, is also not enough. That alone does not make one, in my opinion, qualified to take that leap to the bench.

The District Court deals with myriads of disputes. The common disputes of our society that need to be resolved with compassion but per the law, pursuant to the rules. I am concerned that a person without any practical experience in dealing with that type of law will face too great a learning curve, that the public will need to wait out that learning curve until that nominee acquires the on-the-job experience that allows them to function appropriately, both with the compassion required and with the knowledge and skills required.

We have a number of nominees before us. In each case their experience and their temperament was highlighted at the hearing. The other five nominees have between 10 and 22 years of practical practice either in the public sector or in the private sector, but also courtroom practice, dealing with clients, dealing with the nuances of right and wrong, watching the process occur, learning how the process occurs, and being familiar with the rules of evidence and the rules of procedure. Each and every one of these candidates before us has that experience.

Some point was made that perhaps the lack of experience is almost a plus, that it wouldn't be jaded by the years of dealing with the nuts and bolts, the ups and downs, the problems that appear before a District Court and somehow that experience would somehow jade one against having the correct temperament. I think that is something of an insult to the Bar to suggest that having that experience somehow makes you less able to have and project the correct temperament that our public requires. Every other one of our candidates, in spite of their experience, was extolled as having the correct temperament required.

I look at Mr. Dow's qualifications to see if he does meet what we should require. There is no test as to what is sufficient experience, but let's talk about it. We have four months of private practice followed by two years with the Speaker's Office as counsel and six years in the Attorney General's Office, not as a front line Attorney General but as the Attorney General's Director of Communications and Legislative Affairs. Mr. Dow has acquired huge experience in public policy. I do not question that. I think he has great experience in that area, but I do not believe that this experience translates to the District Court bench. The experience that we should require of our District Court Judges should be that type of experience that will allow them to deal instantly with the types of cases that will be before them in the District Court. We should not expect the people of any part of Maine to wait out that lengthy learning curve.

Much was made at the hearing of the geographical factor. Mr. Dow has shown a willingness to go to Aroostook County. This appointment is not for an Aroostook County seat, it is for a traveling seat. These are the judgeships we created last year and the Chief Justice has made it known that these people are expected to travel. They are going to fill holes and fill needs around the state in the foreseeable future. Ultimately they may be a vacancy in Aroostook County but I cannot accept the fact that the Aroostook County Bar does not have members within it who do have the experience and the qualifications to allow them to step into this role immediately. I find that hard to believe. I find it somehow something of an insult to the Aroostook County Bar to say that it is difficult to find a qualified judge there and that this should somehow excuse the lack of experience or explain away the need for experience in judges that it is so hard to fill one of those vacancies. In fact, it was made quite clear to us that there had been no reaching out to Aroostook County for a member of the Bar with the type of experience we should expect.

Members of the Senate, once again, I have no pleasure in opposing the nomination of Mr. Dow because he is a fine gentleman, but I do feel an obligation on behalf of the people of Maine to insist that our judicial appointments have both the temperament and the experience that we should require. Yes, many people spoke in favor of Mr. Dow. I think we can all say that many on the committee received calls or spoke with practicing lawyers who were concerned about this, but in each and every case they told me that they would never go to that hearing because if he was appointed they would have to appear before him at some point and they did not want that because it would be harmful to their client. I somewhat discount the fact that there were not as many people speaking against him at the hearing because there were these communications made to me by the lawyers. Since we are not formally judges, I will accept that as somewhat hearsay evidence and I think we all do listen to our constituents. With respect to Mr. Dow as a good and fine person, I respectfully request that you would, as I will, cast your vote against the notation of Mr. Dow. Thank you.

**THE PRESIDENT**: The pending question before the Senate is shall the recommendation of the Committee on Judiciary be overridden?
