THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Brannigan.

Senator BRANNIGAN: Thank you Mr. President. Men and women of the Senate. I want to talk a little bit about COBRA, not snakes but an act that the federal government allowed relative to health insurance. It's a very important piece of allow ability for health insurance until we get to a point a few years from now when we will have health insurance for almost everyone. This is for people who get laid off and don't have health insurance. The COBRA bill is federal and it allows for those who have employees of 20 or more to allow those employees, once they have been terminated or laid off or whatever caused them to lose their job other than bad things, to continue their insurance at their own cost plus 2%. It is of value to those who can afford it. It's very difficult, of course, if somebody is laid off to afford to pay their own insurance. At least it's one way some people can have insurance at these times when so many people don't have it. Mini-COBRA is a state law for people who are employed by organizations and companies that have under 20 employees. that's why it's mini otherwise it's not mini at all and you still have to pay the full amount plus 2%, you have to pay it yourself, it's not the cost to the business. It is just allowing you to continue your health coverage until, hopefully, you can get coverage in some other way and you can afford it. Our law only allows it for 12 months, for mini. Regular COBRA is 18 months. What this bill mainly does is equalize those and says that just because you are in a group under 20 why should you be penalized. Why can't you have at least what the federal government allows for those who work at a place that has more than 20 employees? This bill, a very generous, helpful, caring bill, allows those who are employed here in Maine in groups under 20, and we are very concerned about those always, if they can do it and they can swing it, keep their health insurance plan from 12 to 18 months. I really would appreciate you joining with the Minority, the very slight minority and very good minority of good people, in allowing this small increase for the people who can have health insurance. Thank you very much, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Somerset, Senator Whittemore.

Senator **WHITTEMORE**: Thank you Mr. President. Ladies and gentlemen of the Senate, with all due respect to my fellow Senator from Cumberland, Senator Brannigan, this L.D. 60, a lot has already been said in regards to what it is. I would like to just emphasize for a few minutes on what it, perhaps, won't do and the damage that it could do. While the intent of this bill is commendable the practical effect of the legislation could be to solve one problem and indeed create another. To the extent that small business is experienced rated on the cost of health care benefits incurred by their members, L.D. 60 could drive up

premium costs for effected businesses, and that's going to be those businesses with 20 or fewer employees. I don't think I have to tell anybody here today that this is the group of businesses in this state that are suffering dearly, most of which can't even afford to have insurance. The extended cost of cost shifting is due to the fact that typically employees that will use the COBRA are those that are going to be without employment for a period of time. By the way, they already have 12 months to seek other employment or to get other insurance. Typically they are going to a COBRA plan because they do have an issue and they have a six month waiting period before going on other plans. COBRA becomes quite expensive to the insurer and that cost shifting could increase the cost of premiums up to 1.1% or much as \$6.20 per policy. That's per month, by the way. I urge my fellow colleagues in the Senate to join me and vote ves to support the motion Ought Not to Pass on L.D. 60. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Bartlett.

Senator BARTLETT: Thank you Mr. President. From what I understand of this legislation is that it is simply allowing the individual to continue their own health insurance, paying their premium themselves, for an extended period of time. Twelve months may seem like plenty of time to find a job but in this business climate, this economic time, it takes people a lot longer than that to secure employment, particularly employment that has health insurance as a benefit. In fact, anyone who has been unemployed in the last couple of years can tell you just how difficult it is to search for work. I'm a little bit troubled by the concept that we should oppose this because someone who is sick and needs insurance might be able to access it. That's exactly the kind of people that the COBRA law is trying to help, people who could not go out and get insurance on their own. If you freeze people out of the market they will show up in emergency rooms and we will all bear the cost of that. We will pay in a much more expensive way for that care. Helping them to keep insurance helps to keep down the overall cost in the heath care system for all of us. For that reason I would urge you to oppose the pending motion.

THE PRESIDENT: The pending question before the Senate is the motion by the Senator from Somerset, Senator Whittemore to Accept the Majority Ought Not to Pass Report, in concurrence. A Roll Call has been ordered. Is the Senate ready for the question?

Senator ALFOND: Thank you Mr. President. Speaking of the other Body and this Body and looking at Senator Bliss' amazing record, I did a little research to see how many folks today actually have spent more than 10 years in either Body. We're talking about a handful of people today. Part of it is because of term limits but part of it is Senator Bliss' amazing commitment to doing the work, of always wanting to be here. I know, and I've heard him say it many times, how difficult this decision has been, to leave this work that he loves so much. I first met Senator Bliss as a young organizer. He's somebody who is very thoughtful and respectful. I've been very privileged to have him as my seatmate this year and I know that I am going to miss him terribly. Senator **BLISS**: Thank you Mr. President. When I was first elected to the Legislature in November of 1999 I heard a story about one of my predecessors in my House seat. Representative Sam DiPietro allegedly sat on the floor of the House and listened patiently to a lengthy debate about who knows what, something that is lost in the fog of history. He waited patiently for his turn to talk and then stood up and said, "Like all of those who have spoken before me, I have nothing intelligent to say" and sat down. I have been waiting for 11 years but I guess I'm not going to do

that. This is a very bitter sweet time for us. As most of you know, it is certainly my and my partner's preference to stay in Maine. We love Maine. I came here from California, planning to stay for two years and then to back to California. That was 21 years ago. I think that just happens to people. You come here and you just become entranced by the people and the beauty and the friendliness and time just flies by. The situation is such though that jobs have to play a role in our decisions as well and we are going where the job is at the moment. We will certainly be back to visit. Who knows what the future will bring. When I was first elected a friend of mine who had been in the Legislature for several terms before me cautioned me that I would lose a lot of friends because he had. I think that does happen. You spend a lot of time up here and not much time back home where your friends are or were. You stop going to those weekly church socials or bridge games or poker games or whatever it happened to be and people that you hung around with often just sort of fade away. It turns out though that the people who are with you here, who were elected to come represent their constituents, become your new group of friends. Over the years that I have been here I have made some amazing friends that I will never forget and that I certainly will continue to cherish and stay in contact with and scrutinize their votes on a regular basis. The good Senator from York commented that our political philosophies are different. I have regularly said since the election that I believe that we all want the same thing for this state. I think everyone in this room was elected because they believe that Maine can do better, that we can bring economic stability, that we can bring jobs, that we can bring development, and that we can encourage more people to go onto college and find a more profitable life. I believe that we all want the same thing for the state of Maine. My side of the aisle has driven that bus for a long time and we've driven it on the roads that we thought would lead to that future. There is nothing wrong with the people on the other side of the aisle having a turn to drive for a while and driving the bus on their roads that will lead to that same future. The goal, I think, is the same. I will certainly watch from the other side of the country as we move Maine forward. I think it can be done and I don't think it really matters which side drives the bus. I thank you for your good wishes. I'm delighted to have spent as much time as I was able to spend here in the Legislature. I'll miss you all. I'll certainly miss Maine but I'll be watching. Another predecessor of mine who served in this Body, Senator Barbara Gill, tells a story about how, in a debate when she was sitting here, somebody stood up and said something about the debate not being over until the fat lady sings. Senator Gill then, not being the most svelte woman in the world, stood up and started to sing. We live in different times now don't we Mr. President? Thank you for your good words.

He and I didn't get to know each other real well, nor did I get to meet and know everyone that well. I do pride myself on trying to get along with everyone and not try to make anyone angry and stuff. I think it was in my last term in the House, when I actually put an amendment on one of his bills that was near and dear to his heart and I saw him actually get kind of huffy and actually pretty angry at me and stuff like that. I can't even remember what happened to my amendment and what happened to that bill, but the one thing that I do know is he may have been huffy for that few moments but he never held it against me. I really appreciate that. Having the opportunity and being blessed to serve here in the Senate and to have him in the caucus I've learned to get to know him a lot better and stuff like that. That makes me a better person because he is a nice person, a very thoughtful, kind, deliberate, and all I want to do is just say I wish him the best health, happiness, and prosperity that he can find for the rest of his life and look forward to seeing him in the near future.
