Title 36 §6764 directs the Department of Economic and Community Development to submit an annual report each year providing information on qualified Employment Tax Increment Financing (ETIF) businesses to the legislative committees with jurisdiction over taxation and economic development matters.

- The business type (**Exhibit A**);
- The numbers of jobs created as a consequence of the employment tax increment financing development program (**Exhibit A**);
- The aggregate amount of ETIF reimbursements claimed by qualified ETIF businesses in the report year; and (**Exhibit B**)
- The aggregate amounts of wages paid for jobs created as a consequence of the employment tax increment financing development program (**Exhibit B**)
