32 33	This amendment replaces the bill, which establishes a homeowner protection fund and enables contingency allowance funds to be used to reimburse a consumer in the even

1	of a water system failure that causes damage to the consumer's property. This
2	amendment clarifies that the use of contingency funds by a consumer-owned water utility
3	does not waive a utility's immunities or limitations on damages that exist under the Maine
4	Tort Claims Act, any other statute or the common law. This amendment also increases the
5	annual contingency allowance from 10% to 12% for a utility with annual revenues up to
6	\$85,000 and from 5% to 7% for a utility with total annual revenues in excess of \$85,000.
