Re: AFA letter of August 18, 2009

Dear Senator Diamond, Representative Cain, and Members of the Appropriations Committee,

This is in response to the AFA Committee letter of August 18, 2009. You have requested that all "agencies submit a list of programs grouped in such a way that it is clear which programs are "high priority" or "mission critical and which programs are not vital to the core mission."

As the Committee knows, in the Judicial Branch we have no programs. We have people and buildings, which exist for one reason: to resolve disputes arising under the constitution and laws of the state. To the extent that anything could be said to resemble a "program" it would be in the nature of a "diversion" from the court process such as mediation, which is supported by fees on litigants.

In recent years, like much of state government, we have operated with a bare-bones Judicial Branch budget. Unlike much of state government, however, we have no control over the Branch's workload. We must provide a forum for every case that comes before us. I am enclosing a copy of our five-year case filings that I am sure you will find interesting. The civil filings, such as foreclosures and small and large claims, have seen a steep increase in recent years due to the economy.

We very much appreciate the difficult task before the Committee. We also appreciate your recognition that further across the board cuts will endanger the core mission of government. The core mission of the judiciary has already been affected. In the last biennium we managed the budget shortfall and the increased indigent legal services costs by maintaining vacancies. This resulted in reduced public hours in many of the courthouses - particularly in southern Maine, and a substantial reduction in security such as entry screening. Additional cuts can only further decrease Maine peoples' access to justice.

Please let us know if we can provide further information.
