§18702. Purpose

(CONTAINS TEXT WITH VARYING EFFECTIVE DATES)

(WHOLE SECTION TEXT EFFECTIVE 1/01/26)

The purpose of this compact is to facilitate interstate practice of physical therapy with the goal of improving public access to physical therapy services. The practice of physical therapy occurs in the state where the patient is located at the time of the physical therapy services. The compact preserves the regulatory authority of states to protect public health and safety through the current system of state licensure. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. - **1. License recognition.** Increase public access to physical therapy services by providing for the mutual recognition of other member state licenses;

- **2. State powers.** Enhance the states' ability to protect the public's health and safety; [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- **3. Multistate practice.** Encourage the cooperation of member states in regulating multistate physical therapy practice;

- **4. Military spouses.** Support spouses of relocating active duty military personnel; [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- **5. Information exchange.** Enhance the exchange of licensure, investigative and disciplinary information among member states; and

- **6. Compact privilege.** Allow a remote state to hold a provider of services with a compact privilege in that state accountable to that state's practice standards.

§18703. Definitions

As used in this chapter, unless the context otherwise indicates, the following terms have the following meanings. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]

- 1. Active duty military. "Active duty military" means full-time duty status in the active uniformed service of the United States, including members of the National Guard and Reserves of the United States Armed Forces on active duty orders pursuant to 10 United States Code, Chapters 1209 and 1211. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- 2. Adverse action. "Adverse action" means disciplinary action taken by a physical therapy licensing board based upon misconduct, unacceptable performance or a combination of both. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- **3. Alternative program.** "Alternative program" means a nondisciplinary monitoring or practice remediation process approved by a physical therapy licensing board, including, but not limited to, addressing substance use disorder issues.

- **4.** Compact privilege. "Compact privilege" means the authorization granted by a remote state to allow a licensee from another member state to practice as a physical therapist or work as a physical therapist assistant in the remote state under its laws and rules. The practice of physical therapy occurs in the member state where the patient is located at the time of the physical therapy services. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- **5. Continuing competence.** "Continuing competence" means a requirement, as a condition of license renewal, to provide evidence of participation in, or completion of, educational and professional activities relevant to practice or area of work.

- **6. Data system.** "Data system" means a repository of information about licensees, including examination, licensure, investigative, compact privilege and adverse action information. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- **7. Encumbered license.** "Encumbered license" means a license that a physical therapy licensing board has limited in any way.

- **8. Executive board.** "Executive board" means a group of directors elected or appointed to act on behalf of, and within the powers granted to them by, the commission. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- **9. Home state.** "Home state" means the member state that is the licensee's primary state of residence.

- 10. Investigative information. "Investigative information" means information, records and documents received or generated by a physical therapy licensing board pursuant to an investigation. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- 11. Jurisprudence requirement. "Jurisprudence requirement" means the assessment of an individual's knowledge of the laws and rules governing the practice of physical therapy in a state. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- **12.** Licensee. "Licensee" means an individual who currently holds an authorization from a state to practice as a physical therapist or to work as a physical therapist assistant.

- 13. Member state. "Member state" means a state that has enacted the compact. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- **14. Party state.** "Party state" means any member state in which a licensee holds a current license or compact privilege or is applying for a license or compact privilege. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- **15. Physical therapist.** "Physical therapist" means an individual who is licensed by a state to practice physical therapy.

16. Physical therapist assistant. "Physical therapist assistant" means an individual who is licensed or certified by a state and who assists a physical therapist in selected components of physical therapy.

- 17. Physical therapy, physical therapy practice or the practice of physical therapy. "Physical therapy," "physical therapy practice" or "the practice of physical therapy" means the care and services provided by or under the direction and supervision of a licensed physical therapist. - **18.** Physical therapy compact commission or commission. "Physical therapy compact commission" or "commission" means the national administrative body whose membership consists of all states that have enacted the compact pursuant to section 18708. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- 19. Physical therapy licensing board or licensing board. "Physical therapy licensing board" or "licensing board" means the agency of a state that is responsible for the licensing and regulation of physical therapists and physical therapist assistants.

20. Remote state. "Remote state" means a member state other than the home state where a licensee is exercising or seeking to exercise the compact privilege.

21. Rule. "Rule" means a regulation, principle or directive promulgated by the commission that has the force of law.

22. State. "State" means any state, commonwealth, district or territory of the United States that regulates the practice of physical therapy.

§18704. State participation in the compact

- 1. Participation requirements. To participate in the compact, a state must:
- A. Participate fully in the commission's data system, including using the commission's unique identifier as defined in rules; [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]

- B. Have a mechanism in place for receiving and investigating complaints about licensees; [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- C. Notify the commission, in compliance with the terms of the compact and rules, of any adverse action or the availability of investigative information regarding a licensee; [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- D. Fully implement a criminal background check requirement, within a time frame established by rule, by receiving the results of the Federal Bureau of Investigation record search on criminal background checks and use the results in making licensure decisions in accordance with subsection 2; [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- E. Comply with the rules of the commission; [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- F. Utilize a recognized national examination as a requirement for licensure pursuant to the rules of the commission; and [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- G. Have continuing competence requirements as a condition for license renewal. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).] [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- **2. Biometric-based information.** Upon adoption of this compact, the member state has the authority to obtain biometric-based information from each physical therapy licensure applicant and submit this information to the Federal Bureau of Investigation for a criminal background check in accordance with 28 United States Code, Section 534 and 42 United States Code, Section 14616. - **3.** Compact privilege. A member state shall grant the compact privilege to a licensee holding a valid unencumbered license in another member state in accordance with the terms of the compact and rules.

4. Fees. Member states may charge a fee for granting a compact privilege. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]

§18705. Compact privilege

- 1. Compact privilege. To exercise the compact privilege under the terms and provisions of the compact, the licensee:
 - A. Must hold a license in the home state; [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
 - B. May not have an encumbrance on any state license; [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
 - C. Must be eligible for a compact privilege in any member state in accordance with subsections 4, 7 and 8; [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
 - D. May not have an adverse action against any license or compact privilege within the previous 2 years; [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]

- E. Must notify the commission that the licensee is seeking the compact privilege within a remote state; [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- F. Must pay any applicable fees, including any state fee, for the compact privilege; [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- G. Must meet any jurisprudence requirements established by the remote state in which the licensee is seeking a compact privilege; and [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- H. Must report to the commission adverse action taken by any nonmember state within 30 days from the date the adverse action is taken. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]

- **2. Validity.** The compact privilege is valid until the expiration date of the home state license. The licensee must comply with the requirements of subsection 1 to maintain the compact privilege in the remote state.

- 3. Laws and regulations. A licensee providing physical therapy in a remote state under the compact privilege shall function within the laws and regulations of the remote state. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- **4. Regulation.** A licensee providing physical therapy in a remote state is subject to that state's regulatory authority. A remote state may, in accordance with due process and that state's laws, remove a licensee's compact privilege in the remote state for a specific period of time, impose fines or take any other necessary actions to protect the health and safety of its citizens. The licensee is not eligible for a compact privilege in any member state until the specific time for removal has passed and all fines are paid.

- **5. Encumbrance.** If a home state license is encumbered, the licensee must lose the compact privilege in any remote state until the following occur:
 - A. The home state license is no longer encumbered; and [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
 - B. Two years have elapsed from the date of the adverse action. [PL 2023, c. 329, \S 1 (NEW); PL 2023, c. 643, Pt. DDD, \S 1 (AFF).]

- **6. Restoration after encumbrance.** Once an encumbered license in the home state is restored to good standing, the licensee must meet the requirements of subsection 1 to obtain a compact privilege in any remote state.

- **7. Removal.** If a licensee's compact privilege in any remote state is removed, the individual must lose the compact privilege in any remote state until the following occur:

 - B. All fines have been paid; and [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]

8. Restoration after removal. Once the requirements of subsection 7 have been met, the licensee must meet the requirements in subsection 1 to obtain a compact privilege in a remote state.

§18706. Active duty military personnel or their spouses

A licensee who is active duty military or is the spouse of an individual who is active duty military may designate one of the following as the home state: [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]

1. Home of record. Home of record;

§18707. Adverse actions

1. Adverse action authority. A home state has exclusive power to take adverse action against a license issued by the home state.

2. Remote state investigative information. A home state may take adverse action based on the investigative information of a remote state, as long as the home state follows the home state's procedures for taking adverse action.

- **3. Alternative program.** Nothing in this compact overrides a member state's decision that participation in an alternative program may be used in lieu of adverse action and that such participation remains nonpublic if required by the member state's laws. Member states must require licensees who enter any alternative programs in lieu of discipline to agree not to practice in any other member state during the term of the alternative program without prior authorization from such other member state. - **4. Member state authority.** Any member state may investigate actual or alleged violations of the laws and rules authorizing the practice of physical therapy in any other member state in which a physical therapist or physical therapist assistant holds a license or compact privilege. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
 - **5. Remote state authority.** A remote state has the authority to:
 - A. Take adverse actions as set forth in section 18705, subsection 4 against a licensee's compact privilege in the state; [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]

- B. Issue subpoenas for both hearings and investigations that require the attendance and testimony of witnesses and the production of evidence. Subpoenas issued by a physical therapy licensing board in a party state for the attendance and testimony of witnesses or the production of evidence from another party state must be enforced in the latter state by any court of competent jurisdiction according to the practice and procedure of that court applicable to subpoenas issued in proceedings pending before it. The issuing authority shall pay any witness fees, travel expenses, mileage and other fees required by the service laws of the state where the witnesses or evidence are located; and [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. - C. If otherwise permitted by state law, recover from the licensee the costs of investigations and disposition of cases resulting from any adverse action taken against that licensee. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]

6. Joint investigations. In addition to the authority granted to a member state by its respective physical therapy practice act or other applicable state law, a member state may participate with other member states in joint investigations of licensees.

Member states shall share any investigative, litigation or compliance materials in furtherance of any joint or individual investigation initiated under the compact.

§18708. Establishment of physical therapy compact commission

(CONTAINS TEXT WITH VARYING EFFECTIVE DATES)

- 1. Commission established. The member states hereby create and establish a joint public agency known as the physical therapy compact commission.
 - A. The commission is an instrumentality of the compact states. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
 - B. Venue is proper and judicial proceedings by or against the commission must be brought solely and exclusively in a court of competent jurisdiction where the principal office of the commission is located. The commission may waive venue and jurisdictional defenses to the extent it adopts or consents to participate in alternative dispute resolution proceedings. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- C. Nothing in this compact may be construed to be a waiver of sovereign immunity. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]

- 2. Membership; voting; meetings. Membership, voting and meetings are governed by this subsection.
 - A. Each member state has and is limited to one delegate selected by that member state's licensing board. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
 - B. The delegate must be either:
 - (1) A current member of the licensing board, who is a physical therapist, physical therapist assistant or public member; or
 - (2) An administrator of the licensing board. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]

- C. Any delegate may be removed or suspended from office as provided by the law of the state from which the delegate is appointed. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- D. The member state licensing board shall fill any vacancy occurring on the commission. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- E. Each delegate is entitled to one vote with regard to the promulgation of rules and creation of bylaws and must otherwise have an opportunity to participate in the business and affairs of the commission. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- F. A delegate shall vote in person or by such other means as provided in the bylaws. The bylaws may provide for delegates' participation in meetings by telephone or other means of communication. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- G. The commission shall meet at least once during each calendar year. Additional meetings must be held as set forth in the bylaws. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]

 - **3. Powers and duties.** The commission has the following powers and duties:

 - B. Establish bylaws; [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
 - C. Maintain its financial records in accordance with the bylaws; [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
 - D. Meet and take such actions as are consistent with the provisions of this compact and the bylaws; [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
 - E. Promulgate uniform rules to facilitate and coordinate implementation and administration of this compact. The rules have the force and effect of law and are binding in all member states; [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]

 - (9) Disclosure of information related to any investigative reports prepared by or on behalf of or for use of the commission or other committee charged with responsibility of investigation or determination of compliance issues pursuant to the compact; or

The commission shall provide for the development, maintenance and utilization of a coordinated database and reporting system containing licensure, adverse action and investigative information on all licensed individuals in member states. - **2.** Uniform data set submission. Notwithstanding any other provision of state law to the contrary, a member state shall submit a uniform data set to the data system on all individuals to whom this compact is applicable as required by the rules of the commission, including:

1. Powers. The commission shall exercise its rule-making powers pursuant to the criteria set forth in this section and the rules adopted thereunder. Rules and amendments become binding as of the date specified in each rule or amendment.

- 2. Rule rejection. If a majority of the legislatures of the member states rejects a rule, by enactment of a law or resolution in the same manner used to adopt the compact within 4 years of the date of adoption of the rule, then that rule has no further force and effect in any member state. - **3. Rule adoption procedure.** Rules or amendments to the rules must be adopted at a regular or special meeting of the commission.

If the revision is challenged, the revision may not take effect without the approval of the commission.

§18711. Oversight; dispute resolution; enforcement

- 1. Oversight. Oversight of the compact is governed by this subsection.
- A. The executive, legislative and judicial branches of state government in each member state shall enforce this compact and take all actions necessary and appropriate to effectuate the compact's purposes and intent. The provisions of this compact and the rules promulgated hereunder have standing as statutory law. [PL 2023, c. 329, §1 (NEW); PL 2023, c. 643, Pt. DDD, §1 (AFF).]
- B. All courts shall take judicial notice of the compact and the rules in any judicial or administrative proceeding in a member state pertaining to the subject matter of this compact that may affect the powers, responsibilities or actions of the commission. - C. The commission is entitled to receive service of process in any proceeding under paragraph B and has standing to intervene in such a proceeding for all purposes. - **2. Default; technical assistance; termination.** Default, technical assistance and termination are governed by this subsection.

 - (1) Provide written notice to the defaulting state and other member states of the nature of the default, the proposed means of curing the default and any other action to be taken by the commission; and

In the event judicial enforcement is necessary, the prevailing member must be awarded all costs of that litigation, including reasonable attorney's fees. §18712. Date of implementation of compact; associated rules; withdrawal; amendment (CONTAINS TEXT WITH VARYING EFFECTIVE DATES)

(WHOLE SECTION TEXT EFFECTIVE 1/01/26)

1. Effective date. The compact takes effect on the date on which the compact statute is enacted into law in the 10th member state. The provisions of the compact that become effective at that time are limited to the powers granted to the commission relating to assembly and the promulgation of rules. After the effective date of the compact, the commission shall meet and exercise rule-making powers necessary to the implementation and administration of the compact.

2. Subsequent member states. Any state that joins the compact subsequent to the commission's initial adoption of the rules is subject to the rules as they exist on the date on which the compact becomes law in that state. The provisions of this compact must be severable and if any phrase, clause, sentence or provision of this compact is declared to be contrary to the constitution of any party state or of the United States or the applicability thereof to any government, agency, person or circumstance is held invalid, the validity of the remainder of this compact and the applicability thereof to any government, agency, person or circumstance is not affected thereby. If this compact is held contrary to the constitution of any party state, the compact remains in full force and effect as to the remaining party states and in full force and effect as to the party state affected as to all severable matters.
