I'd like to thank the Senate President for appointing me to this committee and for the chance to work so closely with all of its members, particularly my good friend, the Senator from York, Senator Hill. Our job was to look into the events surrounding the election and make a recommendation to the full Senate on who should be seated. Beyond that, Mr. President, we all knew that our job was to get it right so that the will of Senate District 25 voters would be carried out and all Maine citizens would know that here in our state every vote counts. The end result, of course, was that there was an explanation. unintentional human error in the recount process. At the end of the day, Cathy Breen was the people's choice and I know that all of us welcome her and congratulate her. I can't help but mention, Mr. President, just momentarily the integrity and dignity showed by Ms. Breen's, Senator Breen's, opponent, Cathy Manchester, throughout the process and the graciousness and class with which she handled the entire matter. Also, Mr. President, I'd like to thank other members of the committee: Senator Cushing. Senator Diamond, Senator Gerzofsky, Senator Hill, Senator Mason, and Senator Saviello. You may not have noticed, I listed them alphabetically and not by party because each and every member of the committee approached the task leaving partisanship at the door. When it came to making sure that the Maine people can have confidence in the integrity of the election process, there were no Republicans or Democrats. Again, Mr. President, welcome to our new colleague. Thank you.

Senator **BRAKEY**: Thank you, Mr. President. Members of the Maine Senate, I'm honored to speak to this sentiment today. On January 16<sup>th</sup> the First Congregational-Christian Church of New Gloucester will have its 250<sup>th</sup> Anniversary. For 250 years the church has ministered to the people of the community. On January 16, 1765, Samuel Foxcroft, a Congregational pastor, was ordained at the blockhouse as the first minister in New Gloucester and the same day a church of eight members, all men, was organized. The blockhouse was used as a place of worship until 1773, when a partially completed meeting house began to be used for all functions of the church and town. The church

predated the incorporation of the Town of New Gloucester, which took place on March 8, 1774. At the time, incorporation as a town required the presence of a church and the First Congregational-Christian Church served that role in New Gloucester's incorporation. Most of all, I'm proud to speak to the sentiment because my parents were married in the church and I'm proud to have both my parents here with us here for this moment and also the pastor of the church, Linda Gard, who is our Pastor of the Day today. I want to thank them very much for being here and thank you for the time.
