They were concerned with one aspect of the legislation. I indicated that I would sponsor the amendment to go onto the bill that, from their point of view and mine, solves the problem of what happens when people are going to be drinking beverages around the golf course and have no place where they can go, except in the woods. They were concerned about that. Frankly, that was something that I had never thought of. After talking to the industry and some people from the golf courses, in many cases they have already dealt with this issue and they do not have a problem with the amendment. That is why I am offering the amendment today.
