Joint Resolution in Memoriam:

WHEREAS, the Legislature has learned with deep regret of the death of:

Jane Gray Muskie, widow of former Maine governor, senator and national Secretary of State Edmund S. Muskie, at her home outside Washington, D.C., on Christmas morning. Jane Gray was born and raised in Waterville, where she met young attorney Edmund S. Muskie. They married in 1948 while he was a member of the Maine House of Representatives. In 1954, Mr. Muskie was elected Governor of Maine, and as Maine's First Lady, Mrs. Muskie was the first in memory to have a child while living at the Blaine House. The Muskies moved to Washington, D.C., in 1958, when Edmund Muskie won the United States Senate seat he would hold until President Carter named him Secretary of State in 1980. Mrs. Muskie was devoted to her husband and five children, raising her family in Bethesda, Maryland, and Kennebunk, Maine. She was talented, charming

and well respected, and she was one of her husband's greatest political assets. Mrs. Jane Muskie will be buried next to her husband, who predeceased her in 1996, at Arlington National Cemetery. She will be greatly missed by her loving family, her many friends and the citizens of the State of Maine;

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Martin.

Senator **MARTIN:** Thank you, Madame President and members of the Senate. Obviously, when I read the resolution this morning, one of the things that this thing does to you is brings back memories of some things or of a person in your life. As some of you, of course, were aware, in my younger days, which were many years ago, I was an employee of Senator Muskie, both in Washington and Maine and on the campaign trail. Jane Muskie was a person whom I got to know extremely well, probably through the Vice-President campaign more than other time. One of the things that I was thinking about this morning was when I first met her, in 1952, when I was a very young child and then again in 1953, when Ed Muskie was involved in the party and then made the decision to run for Governor. You may not know, it was a little known fact, that the decision was actually made at a State Democratic Committee at Eagle Lake where my uncle served in the Legislature and was a member of the state committee. That's really going back a long way, but I can tell you that throughout the campaigns, the Congressional, Presidential, Vice-Presidential, and all the campaigns in which I was involved in with the Senator, that Jane Muskie was a force. A lot of people thought that she was in the background, didn't do much, etcetera. I can assure you that she made a lot of decisions for Ed Muskie. I've got to tell you one of them, which really was an interesting one. I won't tell you all the details. We were going to a visit at Camp Waban in York County. I was not supposed to be there but I ended up being the person responsible to drive. As a result, I didn't have a map of southern Maine. Didn't know southern Maine very well at that time. This was in 1970. When I picked up the Senator and Jane in Kennebunkport, I said, 'Do we have a map?' The Senator said, 'I don't need one, I know where I'm going.' So we get on our way and we're driving. He's reading the Sunday paper. We get to a 'T' in the road and I said, 'Senator, which way do I go?' He said, 'Right.' Jane is in the back seat and she said, 'We go left.' At that point I am a very young 20 plus some, fairly scared of all of this, not knowing them very well at that point, and I had to make a decision. I went left. I want to assure you Jane Muskie was right and the Senator was wrong. Through all of this the Senator is saying, 'If we're late, it's your fault, John.' The point that I learned from all of that was to always trust Jane Muskie with directions, knowing where we were going and where we had to be, throughout that campaign. Throughout all of this, my experience with her was that she was a person who was fully grounded in Maine, who knew Maine people, knew where she was, who she was, and where she was going. As a citizen of Waterville, a native of Waterville, she respected, more than anything, the people of Maine. It didn't matter when after he served in the Senate and as Secretary of State and continued to reside in southern Maryland, Maine was still home. I will always

remember her and respect her dearly. I am, obviously, pleased to support this resolution today.

Reports **READ**.

Senator **BROMLEY** of Cumberland moved the Senate **ACCEPT** the Majority **OUGHT NOT TO PASS** Report, in concurrence.

**THE PRESIDENT:** The Chair recognizes the Senator from Aroostook, Senator Martin.

Senator **MARTIN:** Madame President and members of the Senate, I just need to give you a little history before this goes on its merry way. I was asked by the previous President to serve as Chair of this commission that met during the summer. As I remember, the way it was structured by a previous committee, there were about 30 people on the commission. One of the controversial issues was this one. The others, for the most part, were involved in other bills, and frankly, are coming out of committee later. I think the message that the commission was trying to send to everyone is clear here. That is that there is some problems with what is happening in restaurants in this state and throughout this country, and for that matter, elsewhere. It's interesting to note, by the way, that the National Restaurant Association estimates that 4 out of 10 adults will patronize a restaurant in the course of a typical day in this country. Fairly high, which obviously leads to what people are trying to address. There is an assumption here that some people are saying we are trying to put restaurants out of business. What the goal of the commission was is basically to put into some manner, shape, or form that restaurants would put what the calories are and what other things are in front of people that are ready to order. That, frankly, was too expensive an idea, in the light of many. It is interesting that about 1/3 of all national restaurants put that information out on their web site right now. What you need to do, if you want to follow what 1/3 of these restaurants suggest, is to bring the laptop with you to the restaurant and you can access the calories on each item right from the web site. I can see the restaurant owners not being concerned about that and say that it

is intrusion into private enterprise, but it is just a thought and I put it out there. I will hold the Maine Restaurant Association responsible for this because they have indicated that there is a way in which they will start to put out information at various restaurants with a sheet that will be available, inexpensive to the owners, which will provide information so that people will know what is on the menu. You say, 'Why bother?' Let me just point out to you that Maine is a state in which the obesity rate is one of the highest in the country. It is an issue. I will point out that the result of that means more healthcare costs are being picked up by the insurance carriers of this state. This means higher rates. We complain a lot about rates. We complain a lot about the cost of healthcare. It is not the only reason. It is not the major reason. It is part of the problem. At some point in time, we need to do something. This is a minor point of the whole picture, but it is one in which the commission expressed a concern. So I am more than willing today to accept the committee's recommendation and then to look at what may transpire in the years to come as to what the Maine Restaurant Association and other establishments will do in order to deal with some of these issues that we face. There is no question that fast food is one of the problems. It is one in which some how, at some point, we will need to deal with because it is an issue and it is something that the commission dealt with. I certainly am obviously voting today for the acceptance of the Majority Report. I'm just telling you what the background was as far as the commission was concerned.

**THE PRESIDENT:** The Chair recognizes the Senator from Lincoln, Senator Dow.

Senator **DOW:** Thank you, Madame President. I'd like to thank the Senator from Aroostook, Senator Martin, for his remarks. I have a little different take on some of the statistics though. Information that I've received indicates that 20% of the meals that Mainers eat each week are in restaurants but only 20% of those restaurants are the fast food restaurants or the chain restaurants, I should say, in question in this bill. It's that statistic that shows less than 4% of the meals per week are eaten at these restaurants. What is being asked is to separate out this small group of restaurants and make them jump through some hoops that the others don't need to. I agree that we have an obesity problem in this state. I don't think putting the information on a menu is going to have any effect on it. I believe that some further education in the school system is more in order for this. It would cost the chain restaurant several thousands or tens-of-thousands of dollars to change their menus every time an item on the menu changed. They would have to change the menus to update the information. Not only that, but I'd say to you that people that want to know this information, that are going to pay attention to it, already know it. They are the ones that are deciding what they are going to eat. My favorite restaurant is not on this list because it's not a chain restaurant, that's Moody's Dinner. One of my favorite desserts is a nice big cream puff. I wish I could eat one every day, but I know that I can't. By the way, they are so good that when I have gone in there and said, 'Well, I'll eat half of it and take the other half home,' the other half hasn't made it home yet. Maybe a whole one has made it home because I've took it with me, but that's all. We need to be more aware of the education that needs to go out there to the people. What really concerns me is what's happened to our school system. That isn't due to the 4% of the meals that are eaten in these chain restaurants per week. I taught back in the 1970's and early 1980's. When I go

into the schools systems today, there is a noticeable change in the way our students look. It disturbs me. There are solutions to this problem. To me, this is not worth consideration and I wish that we would go as the Senator from Cumberland, Senator Bromley, has indicated and vote not ought to pass. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Nutting.

Senator **NUTTING:** Thank you, Madame President. I've always supported and will continue to support the Dirigo Health Plan. I want to ask for a division and I want to support this ought to pass report. To me, the foundation of the Dirigo Health Plan is healthy lifestyles. Not knowing the number of calories on the menu, to me, is exactly counter to that. I think this would make a difference. It's not going to solve the whole problem, but I think it is a step in the right direction. Eating differently and more exercise, I think those two things can have a huge and positive effect in lowering our obesity rate and also lowering our cost of healthcare. Madame President, I ask for a division.

Senator **NUTTING** of Androscoggin requested a Division.
