#### **Non-Concurrent Matter**

Bill "An Act To Eliminate State Licensing of Boxers, Wrestlers and Transient Sellers" S.P. 468 L.D. 1410 (C "A" S-377)

In Senate, February 10, 2004, PASSED TO BE ENGROSSED AS AMENDED BY COMMITTEE AMENDMENT "A" (S-377).

Comes from the House, PASSED TO BE ENGROSSED, in NON-CONCURRENCE.

Senator **BROMLEY** of Cumberland moved the Senate **RECEDE** and **CONCUR**.

On motion by Senator **HATCH** of Somerset, supported by a Division of at least one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT PRO TEM**: The Chair recognizes the Senator from Somerset, Senator Hatch.

Senator HATCH: Thank you, Madame President, ladies and gentlemen of the Senate. I did not intend to be a main speaker on this particular bill, but I just wanted you to recognize that your eliminating state licensing of boxers and wrestlers in the state and transient sellers. While everyone

would have you believe that this is a good thing to do, it is not, in my opinion, especially of the boxers. While we may all feel, especially some women, including myself, that this is a brutal sport, I would have more problem with it happening in this state if it was not regulated at all. By doing away with the licensing in this state you are doing away with the commission that oversees it. You are leaving it up to Massachusetts to regulate the State of Maine. Boxing is on the increase in this state. Many individuals in my area who have been having problems at school, and what not, have been redirected to boxing and are taking courses. They are training in Lewiston and traveling. They have people who are overseeing what they are doing. It's turning them around. So I would ask that you not pass this bill and that we can move on and indefinitely postpone the bill. I looked at the amendment that was striped off in the House and I can honestly tell you that even with the amendment it did not make this any better. Take a good look at this. Do you really want our young people not having a board or commission that is overseeing the boxing in this state? I don't think it's a good idea. It wasn't a good idea two years ago, it wasn't a good idea four years ago, and it's still not a good idea. It's the same old bill. When you vote, would you please vote no on the recede and concur so that we can move on and indefinitely postpone this. Thank you.

# JOINT RESOLUTION RECOGNIZING THE HONORABLE GEORGE J. MITCHELL, ARCHITECT OF THE LANDMARK FEDERAL CLEAN AIR ACT

WHEREAS, the Clean Air Act Amendments of 1990 is the most recent version of a law first passed in 1970 and is designed to make sure all Americans have air that is safe to breathe by requiring that

the United States Environmental Protection Agency set national health-based air quality standards to protect against common pollutants and work with state governments; and

WHEREAS, by any objective measurement, the Clean Air Act has been a tremendous success. The air is cleaner than before and public health has improved because of it. Emissions of toxic lead have dropped 98%, emissions of sulfur dioxide have dropped 35% and emissions of carbon monoxide have dropped 32%, even while driving has increased 127%; and

WHEREAS, the chief architect of this Act is the Honorable George J. Mitchell, one of the most respected and renowned Maine citizens of our time. Born and raised in Waterville, Maine, he attended Bowdoin College and received his law degree from Georgetown University Law Center; and

WHEREAS, a trial attorney in the United States Justice Department before he joined the congressional staff of Senator Edmund Muskie in 1962, George J. Mitchell entered private practice in 1965 and then was appointed Assistant Cumberland County Attorney in 1970, United States Attorney by President Jimmy Carter in 1977 and United States District Judge by President Carter in 1979; and

WHEREAS, George J. Mitchell served in the United States Senate from 1980 to 1995, being reelected with overwhelming majorities and serving as Senate Majority Leader from 1988 to 1995 with great distinction. He then was prevailed upon by President Clinton to be Special Advisor to Northern Ireland and there played a key role in peace talks; and

WHEREAS, Senator Mitchell was responsible for much notable legislation, particularly in the areas of the environment and health care. He sponsored the Clean Water Act of 1987 and the Clean Air Act Amendments of 1990, which reduced acid rain in Maine and the Northeast, as documented by the state-of-the-art research led by the University of Maine's Senator George J. Mitchell Center for Environmental and Watershed Research; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-first Legislature, now assembled in the Second Special Session, on behalf of the people we represent, take this opportunity to honor and applaud one of Maine's most famous native sons upon the occasion of the 10-year assessment of the Clean Air Act, which has proved beneficial to all Americans; and be it further

# JOINT RESOLUTION MEMORIALIZING THE PRESIDENT OF THE UNITED STATES, CONGRESS AND THE UNITED STATES POSTAL SERVICE TO MAINTAIN CURRENT LEVELS OF SERVICE

WE, your Memorialists, the Members of the One Hundred and Twenty-first Legislature of the State of Maine now assembled in the Second Special Session, most respectfully present and petition the President of the United States, Congress and the United States Postal Service as follows:

WHEREAS, the United States Postal Service, founded in 1775, provides a means for commerce and communications and provides postal services to all communities, rich and poor, urban and rural, with uniform postage rates and it has for nearly 230 years provided dependable, affordable mail service. The United States Postal Service remains an important part of our nation's economic infrastructure through which nearly \$1 trillion of economic activity is conducted each year and in which 9,000,000 people are employed; and

WHEREAS, Americans currently enjoy the most extensive postal service at the lowest postage rates of any major industrialized nation in the world, and excessive below-cost postage discounts to large business and advertising mailers unnecessarily drain billions of dollars of revenue from the United States Postal Service and ultimately cause small businesses and ordinary citizens to subsidize those discounts through higher postage rates. Millions of older, disabled and economically disadvantaged Americans do not have easy access to the Internet or to electronic banking and bill paying and therefore are heavily dependent on the United States Postal Service for communication and the conducting of business transactions; and

WHEREAS, the President created the President's Commission on the United States Postal Service, which has recommended far-reaching changes to postal operations and services, including severing postal employees from federal employee health, retirement and workers' compensation programs, and the repeal of certain existing laws, which would pave the way towards reducing rank-and-file wages and benefits while eliminating the current salary cap on executive-level postal positions in order to raise postal executive pay on par with that of corporate CEOs and the commission has recommended a new President-appointed, corporate-style board of directors and the new Postal Regulatory Board that would give these new politically appointed governing bodies broad authority to set rates without prior approval, review and refine the scope of the United States Postal Service's universal service obligation and uniform rate structure and change and restrict the scope of services currently protected under postal monopoly regulations; and

WHEREAS, this broad authority would allow post offices to be closed without community input and prices to be set with a complicated postage rate structure or would even turn over postal operations to private for-profit enterprises despite a recent survey whose respondents had an overwhelmingly favorable view of the United States Postal Service, with 3 out of 4 saying no major changes are needed and 3 out of 10 saying the United States Postal Service works extremely well as is; and

WHEREAS, replacing the United States Postal Service's public service obligation with a profitseeking mandate would undermine the United States Postal Service's historical "universal service" obligation, weaken its national infrastructure and divide our nation politically and economically, and here in the District of Maine, the United States Postal Service has unilaterally implemented a cost-saving reduction of hours and access that restricts customer service by curtailing hours; and

WHEREAS, this program has reduced hours of service at over 50% of post offices in Maine, severely affecting customer service, without regard to customers' input and complaints. Maine is a rural state and our elderly and disabled citizens depend on postal services; now, therefore, be it

RESOLVED: That We, your Memorialists, request that the President of the United States, Congress and the United States Postal Service continue to maintain affordable, dependable mail

service at current levels because of its social and economic importance to our nation; and be it further

RESOLVED: That we oppose any effort to undermine the United States Postal Service's universal service obligation and its uniform rate structure, that the service hours be returned to where they were before the report of the President's Commission on the United States Postal Service and prior to the implementation of the Small Post Office Reviews and Standardization Program and that any recommendation from the presidential commission that curtails public services related to our current postal service be rejected; and be it further

RESOLVED: That We, your Memorialists, go on record against any changes that would harm the workers of the United States Postal Service, including legislation to close small offices, take away or modify the collective bargaining system of postal workers or change the current bargaining system for employee benefits; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Honorable George W. Bush, President of the United States; the Postmaster General, United States Postal Service; the Honorable Richard Cheney, President of the United States Senate; the Honorable Dennis Hastert, Speaker of the United States House of Representatives; and each Member of the Maine Congressional Delegation.

**THE PRESIDENT PRO TEM**: The Chair recognizes the Senator from Cumberland, Senator Turner.

Senator **TURNER**: Thank you, Madame President, ladies and gentlemen of the Senate. I'm not quite sure why, but this particular division happens to fall along partisan lines. The original intention of the bill was to infuse into the Revenue Forecasting Committee input directly from a member of the private sector. As the bill was originally crafted, it sought to replace one member and add a member from the private sector. The minority report, which I hope you will move on to and accept, increases the membership of the committee by one and insures that we have private

sector input directly on the committee. It is my opinion that this will only enhance the work of the Revenue Forecasting Committee and I hope you will join me in voting against the pending motion so we can move on and accept the minority report. Thank you very much, Madame President.

**THE PRESIDENT PRO TEM**: The Chair recognizes the Senator from Penobscot, Senator Cathcart.

Senator **CATHCART**: Thank you, Madame President, men and women of the Senate. I hope you will support the Ought Not to Pass majority report. The Appropriations Committee spent quite a bit of time on this subject, looking at the original legislation to decide whether, indeed, it would be advisable or necessary to change the makeup of the Revenue Forecasting Committee. We asked the Revenue Forecasting Committee and the Consensus Forecasting Commission for their advise on this. While, of course, they did not tell us that we should not add another person to that, they did not come up with any reason why it was necessary to add another person. We questioned that, if we did decide to add another person, if we added someone from a private for-profit business should we also add someone from a private not-for-profit business? The majority concluded in the end that 'if it ain't broke, don't fix it', that the Revenue Forecasting Committee and the system we have in place is working very well the way it is. I hope you will support the Ought Not to Pass. Thank you, Madame President.

On motion by Senator **GAGNON** of Kennebec, supported by a Division of at least one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT PRO TEM**: The Chair recognizes the Senator from Cumberland, Senator Turner.

Senator **TURNER**: Thank you, Madame President, ladies and gentlemen of the Senate. If I could just make one more point to you, with respect to the commission. I would readily agree with the Senator from Penobscot, Senator Cathcart, that the commission has done good work and we continue to rely on its findings. That's not to suggest to you that it couldn't be made even better. I think if you were to defeat the majority Ought Not to Pass report and we moved on to the minority report, it would be an opportunity to enhance the information that flows to us and will only strengthen what we get from the Revenue Forecasting Committee. Thank you.

**THE PRESIDENT PRO TEM**: The pending question before the Senate is the motion by the Senator from Penobscot, Senator Cathcart to Accept the Majority Ought Not to Pass Report. A Roll Call has been ordered. Is the Senate ready for the question?

THE PRESIDENT PRO TEM: The Chair recognizes the Senator from Waldo, Senator Weston.

Senator **WESTON**: Thank you, Madame President, men and women of the Senate. You just received a notice about this particular bill. Everything in it, I'm sure, is accurate. That's not the issue at hand. This bill bans a product just because we have the power to do it. It is not tied to science. It is not tied to FDA approval. It is not tied to anything other than the fact that we have the power to ban it. We may not like water that has nicotine in it. We may not like nicotine gum or patches or the rationale for any of them. We may not like smoking. I have never tried any of those products. I certainly an not going to be party to passing a bill just simply because we want it banned. We could go on to another report that ties it to all other tobacco products and treats it in that same manner. That is the proper way to deal with this product. What we previously had before us did tie the sale of nicotine water to FDA approval. That is gone. What you have before you is just a total ban because we have the power to do it. I ask you to vote against this motion and move on to the minority report. Thank you.

**THE PRESIDENT PRO TEM**: The Chair recognizes the Senator from Aroostook, Senator Martin.

Senator **MARTIN**: Thank you, Madame President and members of the Senate. This bill came to the Health and Human Services Committee as a result of a bill that I sponsored which deals specifically with the question of putting nicotine into water. In fact, the company that owned the franchise and was marketing it in Maine did subsequently pull it off the market and actually has sold the trademark. In fact, the company owned it actually went to the Federal Drug Administration and asked for approval. It was denied. Subsequently what they did, when they didn't get the FDA

approval, was to turn it over and say that it was something that you would use like, for example, herbs, thus circumventing the law. That is the reason why the bill is here.

What has happened since that time, as you may or may not know, is a different company now owns the franchise. Now they are talking about also putting it in juices. My initial concern, of course, is what I see as the potential danger through sports at the high school level because the ad actually appeared in the Portland Press Herald paper in the sports page. It said if you can't smoke for whatever reason, and you can't because of whatever it is, here is a way which you can maintain your nicotine habit. Imagine students bringing it with them on the school buses. How is a coach ever going to know that you are not violating the team rules because you are maintaining your nicotine habit. Of course, once sports are done in the summer, you can go back to smoking your cigarettes and continue your smoking habit. That is the reason why I put in the bill. That is the reason why we should outlaw it in Maine. If we are the only state in the country, so be it. We ought to be. Let's lead.

**THE PRESIDENT PRO TEM**: The Chair recognizes the Senator from Cumberland, Senator Brennan.

Senator BRENNAN: Thank you, Madame President, men and women of the Senate. I think both previous speakers have made several very good points and I think that the good Senator from Waldo, Senator Weston, has also made a number of points that I think bear some response. I think it is logical to say that we should tie this product to ways we currently treat products that have nicotine in them now. The one fault in that logic is that this particular product has no FDA approval. In fact, what I'd like to do is just read to you, briefly, the comment from Dr. Dora Mills, who is the Director of the Bureau of Health, and her opposition to this particular product as it was available in the State of Maine. 'Nicotine is one of the most addictive substances. The sale of certain products that contain nicotine, such as Nicorette or Nicoderm, are regulated by the Food and Drug Administration. There is very little data suggesting that nicowater is effective as a nicotine replacement therapy. Moreover, it is likely that the FDA will determine that nicowater is a drug that requires appropriate testing prior to being marketed to the public. For these reasons, we support the legislation before you to ban the sale of nicotine laced water products in the State of Maine.' We have the Chief Health Officer for the State of Maine that believes that this is appropriate legislation, that this product does, in fact, have no medicinal purpose to it. We can cite research that supports that. As the Senator from Aroostook, Senator Martin, already pointed out, if it were to become available, we have companies now that are looking at different strategies that would circumvent FDA approval in order to bring this to market. I think, at this time, the most appropriate thing for us to do, as a state, is to support this legislation and I urge you to support the pending motion.

Senator **WESTON**: Thank you, Madame President, men and women of the Senate. As usual, my good friend from Cumberland, Senator Brennan, has also made some good points. I wonder if that testimony from Dr. Dora Mills was for the original bill that did tie approval and sale of this product to science and to the FDA? What you have before you ties it to nothing except the whim of the legislature. It's a very bad precedent for us to be deciding on any product without tying it to science, if it was in someway harmful to our citizens. To simply ban a product is a bad precedent. I would hope that you would join with me in voting against this motion.

On further motion by same Senator, supported by a Division of at least one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT PRO TEM**: The Chair recognizes the Senator from Kennebec, Senator Gagnon.

Senator **GAGNON**: Thank you, Madame President, men and women of the Senate. It's been implied that somehow we're setting a precedent in some way by banning this product. Certainly that is not the case. In fact, this legislature's job is to set standards. Our job is to determine what the values are for the people of this state. I think it is important that we let people know, particularly

the 4<sup>th</sup> graders that might be sitting upstairs, that we are not going to tolerate nicotine products entering in to the State of Maine. We're going to protect them. We're going to protect children from nicotine. We're going to do our best to set our standards in this state and to establish what our values are in this state. I would encourage a positive vote.

**THE PRESIDENT PRO TEM**: The pending question before the Senate is the motion by the Senator from Cumberland, Senator Brennan to Accept the Majority Ought to Pass as Amended Report. A Roll Call has been ordered. Is the Senate ready for the question?
