THE PRESIDENT: The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator SAVIELLO: Thank you, Mr. President. Ladies and gentlemen of the Senate, it's really my pleasure to stand and recognize my friends and their family, Russell Black and Susan Black. I want you to know I'm going to tell you the rest of the story because behind every good farmer there's a good farmer woman. Let me tell you, let me give you some examples. Russell is involved in the Farm Bureau. Sue is home taking care of the cows. Russell is in the Legislature. Sue is home making jelly. Russell is the King Lion. Sue is home canning. Russell is at the farmer's union. Sue is home tending the farm. You see Russell likes animals. It seems he always brought them home all the time and he told the kids, "Don't tell Mom." Eventually she found out, was quiet for a couple of days, and came around to the idea that the animals were okay. One time Russell even brought, recently, chickens home and brought them into the house so they could stay warm. One time when Russell was working alone Sue and her daughter heard Russell velling down at the barn. They figured, "Oh my goodness, something happened to Russell." They ran down only to find a cow couldn't get up out of the snow. Russell always treated his children well, taught them how to pull weeds, do chores, and so forth. What he didn't know was when he left, when he drove away, they went in the house to watch TV. When they heard his old beater truck coming down the road again they ran outside to continue to pull the weeds. Russell was always known for leaving on the teakettle, melting the handle. There was Sue to clean up the mess. One time Russell even turned on the stove without lighting it. Many of you, I think, took

the time this weekend to visit Maple Syrup Sunday at the farm. It was great. Great ice cream, great sausage, great comradery. There was Sue, doing all the work. Russell just touring everybody around.

Let me share with you a little poem that I found this morning. I think it really sums up who this family is and the face of a farmer's wife. God made a farmer's wife. On the ninth day God looked down on his planned paradise and said, "Oh dear, the farmer is going to need help." So God made the farmer's wife, Susan. God said, "I need someone will get up before dawn, make breakfast, work all day in the kitchen, bank, school, or work alongside her farmer, and then come home to fix supper, wash dishes." So God made the farmer's wife. God said, "I need someone willing to sit up all night with a newborn son and watch him grow, then pray every morning and teach the children to say please and thank you. I need someone who can make a fried egg sandwich, stretch a paycheck, or thicken chicken soup; or can clean her house with vinegar, baking soda, and hot water; and who's painting, planting all the time and harvesting season; who can finish her 40 hour week on Friday then join her farmer in the field for another two days, six meals, and five loads of laundry." God made the farmer's wife. God said, "I need someone strong enough to plant trees and heave bales; to cosign a loan for a half a million with a steady hand; yet gentle enough to tame and show lambs, raise kids, and calm the farmer when he's upset or higher rent or lower corn; who will stop her work for an hour to talk on the phone for a neighbor," actually it's Russell who usually stops to talk an hour on the phone with his neighbor, "who just found out her mother was sick; someone who could cook and clean and not cut corners; someone to wash and dry and iron and tidy and feed and rake and water and dry and check the homework and pack the lunches and remember the basketball schedule and replenish the refrigerator and finish a hard week's worth of work with a five mile ride to church; someone who sews a family together with strong soft stitches of sharing, who would laugh and then sigh and then reply with smiling eyes when her daughter would say she wants to spend her life doing what her Mom does."

Let me close with two thoughts her children shared about their parents because, as I've joked a little bit about Russell, I think this says why this farm is so successful. One child said, and they're not children any more, but as young adults they've said, "What I learned growing up from a farm with the hardest working Christian parents I know is truly irreplaceable. It helps me in everything I do in life as I continue to use what I've learned every day." The second gave me this information, "Our childhood was really amazing. I would not change it for the world. Mom and Dad have instilled hard work ethics in all of us kids. They should get Parents of the Year." The farm is wonderful. I ask all of you to come and visit Russell and Susan. Russell will ride you around while Susan does the work. My congratulations on this wonderful award, it is well deserved. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Alfond.

Senator **ALFOND**: Thank you, Mr. President. Ladies and gentlemen of the Senate, everything that the good Senator Saviello said is absolutely true. Yesterday I had the opportunity to be at Russell and Susan's farm, Black Acres Farm. It was awesome. What I loved most about it was this, Russell was the tour guide. He brought my family all over the farm. We saw all

the conservation projects he's done. We saw new piglets. We saw horses. It was amazing. Then when we went in to go buy some maple syrup what I found very, very important to me was that Susan was collecting the money. Susan was doing the work, collecting the money, making sure things were going from A to B. It was an incredible, incredible day for our family and I would encourage everyone to go to Wilton and go to their farm because it is very, very special. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Piscataguis, Senator Davis.

Senator **DAVIS**: Thank you very much, Mr. President. I certainly feel a little bit overwhelmed and I cannot, in any way, match the eloquence of what my seatmate just said, nor can I reproduce what my good friend from Portland, Senator Alfond, just said. I do want to say a couple of things about Russell and Susan. First, I have always believed that every family has a center and that the wife, or the woman in the family, is the center of it. It certainly is true with this family. She is the center. Susan runs the household. She runs the farm. She does it all. She has instilled in all of her children the work ethic that was spoken of a short time ago. I know, in my heart I know, that she's very diligently over the years and has tried to instill work ethics in Russell. However, like everything in life, sometimes we come up a little short and perhaps that occurred there.

I would tell you a little bit about them. My wife and I have become friends with them. As I've said before here in the Legislature, how we treat each other is one thing that we always remember and I'm sure that Russell will remember what my seatmate had to say about him. The other thing that I have found is the friendships remain. The quality of people that are here. I have friends on both sides of the aisle. I have friends all over the state that I never dreamed of having. It's all because of how we treat each other and being here and learning from each other. Russell and Susan are some of the most generous people that I know. I know of a lot that they give away. Last summer I had a young person contact me and was looking for a piglet. Couldn't find one. I contacted Russell and the folks wound up with two piglets from Russell and Susan.

My seatmate spoke of his truck. That is an experience all in itself. If any of you have ever climbed Borestone Mountain you can compare getting into his truck along the same way. There are a number of rock slides and that type of thing that you have to overcome. Getting into Russell's truck is quite similar. I guess you couldn't say that it was real tidy, perhaps a little unsanitary, I don't know. However, I would recommend a shower, perhaps lye, after you get into his truck.

They have a wonderful farm. They raise everything you can imagine. Maple syrup is just part of it. They raise beef. They raise pork. He and I have a common interest in honey bees. They get a lot of honey. They raise vegetables. The entire farm is covered with chickens and they get eggs. They sell them all. It's an honor system. You go to their farm and the cash box is there, all the produce is there. You get what you want and put your money in and go home. Over the years Russell has told me that very, very, very few times have they had a problem. Very few. The honor system has worked very well. They also have firewood. They sell hay. They're absolutely a great family and absolutely great friends with all of us, that of course includes my wife and I. Mr. President, when the final sentiment is passed, I

would like to move that all members of the Maine State Senate be listed as co-sponsors. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Lincoln, Senator Johnson.

Senator JOHNSON: Thank you, Mr. President. Ladies and gentlemen, I stand in opposition to the pending motion so that we could move on to a more substantive alternative. I just want to point out a few things that have changed since we implemented L.D. 718 in the previous legislature. First of all, Connecticut has passed a similar law with a trigger. Vermont passed a similar law without a trigger. The federal court in Vermont ruled that Vermont's GMO labeling law is constitutional, which answers some of the original concerns raised as a reason for us having a trigger on our GMO labeling bill. Five major food companies, Campbell Soups, Conagra Foods, Kelloggs, General Mills, and Mars Inc., have all announced that they will label food products that contain GMOs and none of them have said that they are going to be raising prices because of a cost for that labeling, which points to the original concern over costliness of GMO labeling having no merit. Beyond that, the World Health Organization has concluded that glyphosate, as used in roundup ready genetically engineered crops, probably causes cancer. I realize that GMO labeling is not glyphosate labeling, but I also realize that many of the GMO crops are engineered specifically to tolerate glyphosate so glyphosate can be used on them. That's how they are intended to be used. People who buy this GMO seeds for their roundup ready buy glyphosate and put it on those crops and it's on the food and not tested in our food. It is recognized by the World Health Organization as probably causing cancer. Then, beyond that, 97% of Maine people now support GMO labeling. I would ask that, with the safety, long-term impacts, and safety of GMO foods being unproven, and with these risks now being established to go along with GMO crops use, and with these counters to all of the arguments and caution that led to our having a trigger condition in this bill when it was passed in a bi-partisan way and very strongly in this Body and the other Body previously, that we recognize that it's time that we shouldn't rely on whether New Hampshire has the wherewithal to pass the GMO labeling bill to make the decision for Maine people. I ask you to join me in opposing the pending motion so we can go on to putting this question before Maine people, as it deserves. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Dill.

Senator **DILL**: Thank you, Mr. President. Ladies and gentlemen of the Senate, I would just like to say a couple of things here if I may. I certainly am in favor of the Ought to Pass as Amended "A". What this does is extends the time period out until 2022. We worked long and hard several years ago to pass the GMO bill that we now have in place. As a scientist, I'm not going to get up here and argue the whats and the wherefores of GMO because it's really a personal thing that I found while I've been out here dealing with this issue. I have no problem with the right to know

and on some issues certainly this fine. When it comes to the safety issue of this, as a scientist, I have not seen any real problems with safety issues here. I think keeping it the way it is, going out until 2022, my hopes is that there will be some standardized labeling. I'm not truly opposed to labeling because I voted for this originally, that does label GMO organisms and I stand by my original vote. What this does is extends this out until 2022, and I think that's the important thing to remember. This isn't killing this. This extends it out so, hopefully, there will be some guidance so that it's similar across the country. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Franklin, Senator Saviello.

Senator SAVIELLO: Thank you, Mr. President, Ladies and gentlemen of the Senate, I rise also to support this amendment before us. A couple of things I want to remind you of is that I have also been in favor of GMO labeling, have been since it started, but I always point out the three concerns that our good Attorney General has taught me about. One is the Commerce Clause, one is the Supremacy Clause, and the other is the Freedom of Speech in the Constitution. All three of those could be very successful arguments if they went to the U.S. Supreme Court. By us putting the five states on that, it protects us so that if we have to go we don't go alone, we go with others. If we all think it's over because three or four people have, in fact, put it on, which I give them credit for, a good business decision, we still don't want to go alone. It could cost millions of dollars. That's why we've extended the timeline and I think it's the right thing for us to do. Let me remind the Body, there actually is a law in the books. If people would take the initiative, we could actually label things that are GMO free. That passed before I got here in the Legislature, there just hasn't been any rulemaking done. If someone was a smart marketer they, in fact, could do that today. Thank you very much, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Edgecomb.

Senator **EDGECOMB**: Thank you, Mr. President. Ladies and gentlemen of the Senate, wouldn't it be great if one gene could prevent breast cancer? Wouldn't it be great if agricultural crops could be genetically engineered that would allow crops to be grown in semi-arid counties? It would save on water and save thousands of children that die every day of starvation. Wouldn't it be great if during the Irish Potato Famine that they had an engineered potato that would resist potato blight and save tons of pesticides in this country that we currently apply to potatoes every year to prevent potato blight? Ladies and gentlemen, I think I'll save the rest of my debate in case I need it. I'll rest this at this point. Thank you very much, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Millett.

Senator **MILLETT**: Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise in opposition to the pending motion. I joined the good Senator from Aroostook in saying that, yes indeed, that is all very wonderful and to be supported, but I also would say that my right, as a parent, to know what my children are consuming is also a valid goal to have as a legislative Body. I take very seriously what my children, and what all other

children, consume. We are asked to look at the amount of sugar, the amount of fat. All of that is on the label. I believe that at one point in time there was a good deal of opposition to that being provided on those food items. We're now in a situation where, slowly but surely, the food producers of our nation and our world are recognizing that this is, too, equally important information and I don't see any reason why, as a legislative Body, we should stand in the way. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Lincoln, Senator Johnson.

Senator JOHNSON: Thank you, Mr. President. Ladies and gentlemen of the Senate, I remind people here of two things. First, the federal circuit court in Vermont ruled that Vermont's GMO labeling law is constitutional and Vermont's law does not have a trigger. If we put this issue, instead of just kicking it down the road, before Maine voters and Maine voters decide that we should have a labeling law that actually works today, we would not be alone. Vermont has not only gone ahead of us on this, they've also had positive findings in the federal circuit court about the constitutionality of a law like Maine's. Second, I want to remind you that there is an awful lot of research that's been done, but almost all of it has been very short-term and very limited and has not proven that GMO foods are safe and have no long-term effects for human consumption. That, and the cancer risk of the glyphosate which is used expressly, I would say, because otherwise it kills the crops that are roundup ready, means that parents really do have a strong interest in determining whether they want their family undertaking that risk. It's our responsibility to remove the inherent deception in foods looking the same regardless of whether they have harmful chemicals, potentially harmful proteins, in them that we don't have in organic food, don't have in non-GMO food. An optional labeling program for foods that do not contain GMO is not good enough because if you go to the grocery store and look at how many foods are labeled in that manner today it doesn't leave you enough choices to feed your family, much less a balance and nutritious diet in doing so. It's time we stopped supporting this experiment on families that is, frankly, done without their permission and without their full knowledge because they are not, today, informed what it is they are eating. It's time that we gave Maine people the choice what to feed their families and what risks to undertake on behalf of their families. I'd ask you to stand with me in opposing this motion so that we can give the people of Maine that choice at the polls. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Edgecomb.

Senator EDGECOMB: Thank you, Mr. President. Ladies and gentlemen of the Senate, we've been consuming GMO products for the last 20 years and research has been done for that period of time by universities and graduate students doing research on the safety of genetically engineered foods. The bottom line is that there is no scientific evidence, no scientific evidence, that GMO is harmful and I would be one of the first ones to agree with labeling if there was. Thank you, Mr. President.

Among his many other accomplishments, his family, his career, his love for Marcia, he did have that distinguished career as an umpire in baseball and softball, not only here but all over the world, as we've just heard. In that profession he had to show, Mr. President, many of the qualities we all know that are important to get to that kind of a level in baseball umpiring; have a clear head, incredible sense of fairness, the ability to get along well with people, a willingness to be firm when necessary, and overall just good judgement. I don't know why it comes as a surprise to my good friend from Cumberland, Senator Alfond, that he was also a lifelong Republican. All of those qualities that he had, all those qualities that Marcia loved, were the same qualities that much to her chagrin, I imagine, made him that and it was a good source of ribbing over all the years of their marriage, I'm sure. Many of us, Mr. President, had a chance to meet members of Marcia's family several weeks back and when something like this happens I think we all realize what's important. Marcia said it best, that she considers all 34 of us to be members of her family. This is her Senate family. I know that I speak for all of us when I say to her, Mr. President, that we are all members of her family. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Mason.

Senator MASON: Thank you, Mr. President. Men and women of the Senate, I rise today to speak, in a way, on behalf of the Senate Republicans. As the Senator from Kennebec. Senator Katz, just said, when one of us or one of our staff loses someone we really do all feel it. When Marcia lost Jim we definitely all felt it. Over the past few weeks I've had the opportunity to watch Marcia as she's walked around the Capitol. She has been a pillar of strength and she has been a beam of light, the same as she was before Jim left us. That's been a blessing to me. The arts folks, the Arts Commission, the art community was very excited about the project but a little leery of how it would actually get implemented. At the end, I would say that, not that it's not a good idea that doesn't warrant being done, I just felt that at this point in time it was just a little bit unmanageable. Not that I objected to anything that's in this, just that the implementing was going to be a little difficult. Thank you for listening.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Mason.

Senator **MASON**: Thank you, Mr. President. Men and women of the Senate, this bill was put in on behalf of a constituent. It did create a lot of fun, a lot of debate, and I think that it's really awesome when you can get Maine people involved in Maine history. A lot of people know that I have an affinity for the archives and museum and I think it was a fun project. It got a lot of people paying attention and probably best that it goes the way of the archives at this point. It was a lot of fun and it got a lot of people involved. I thank everybody for putting a lot of time and effort into this project. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Cushing.

Senator **CUSHING**: Thank you, Mr. President. Ladies and gentlemen of the Senate, I think this is a noble effort but I think it takes it a little bit too far, the effort, now. I commend the Senator but I guess we're ready to move on.
