I've been trying to figure out what I ought to do with it and decided that, frankly, the time had come to at least raise the issue. Initially I was going to amend it, but upon reviewing it, I find that it deals only with hunting moose.

Two years ago we dealt with the issue of allowing electrical calling for turkey and now we are moving to the one animal that can't defend itself from anything. The moose is easily called now. It can be called, as some of you who are around know, by using a coffee can and a string. There is absolutely no reason to move to the point where we are going to allow electronic calling devices. I know there are some who believe that we ought to, basically, let anyone who wants to devise any particular item to be used in the woods to go after game. Some have suggested we use cell phones and we allow that. We use, perhaps, GIS to locate were moose ought to be, so we can use that during the moose hunt.

You may remember that two years ago we dealt with the issue of planes. I've reached the point where I just think we're going way too far to try to deal with Mother Nature. I just think that, in the long run, we'd be a lot better off to let some of these things be and I firmly believe that we don't need to use moose calling and allow it to be done electronically.

I know this is not the biggest issue that this legislature is going to face. But I can assure you that it is something that, to me, makes no sense. So I guess, Madame President, I'm simply going to ask for a division. I would urge you to vote against the engrossment of this bill.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Bromley.

Senator **BROMLEY**: Thank you, Madame President. I first want to mention my respect for the committee vote on this bond issue and I want to applaud the Executive for his interest in getting this bond before the people early in June so that we can get this package moving. I also appreciate the bi-partisan support for economic development.

There are many important things, in this bond, that are important to all of us in this chamber and to the people that we represent. But, it is also important to say that there is something very important to all of us that is not in this bond, a critical economic development initiative, which is support for Maine's small businesses. Maine owned, Maine operated, rooted here, wanting to remain here, small businesses. I know that this is an important issue to all of us. To many of us, these are people who are our neighbors, our friends, or even some of us. So I want to say that, in supporting this bond issue, I do so with a confidence in the commitment of the Executive, as well as from members of my caucus and many of you across the aisle, to work on this issue and going forward.

I look forward to doing that with each and every one of you. So I hope you will join me in voting for this.

**THE PRESIDENT**: The Chair recognizes the Senator from Lincoln, Senator Hall.

Senator **HALL**: Thank you, Madame President. Maine desperately needs economic development. Unfortunately, it's not clear to me that we have a strategy for the economic development, as a state, today. The fact that it is not clear to me may entirely be my fault or it may be that we have a new administration that is still feeling its way. It may be that, because we're still without a commissioner with responsibility for economic development, we're not hearing the strategy articulated. But it is not, and I say it again, clear to me that we have a strategy.

Madame President, there are many good things in this bond. But it is not clear to me that the funds are committed to supporting any coherent strategy or any vision for the future of our state.

It's not clear to me that the projects that are in this bond have met any tests of cost effectiveness or of generating employment. Worse, it's not clear to me that these projects have been allocated on the basis of need or effectiveness, but rather on the basis of lobbying power.

So I am very reluctant to vote for this and to allocate \$60 million in this way. I just want to say that I hope this is the last time I'll have to protest a bond proposal from this administration in such a public way. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Androscoggin, Senator Douglass.

Senator **DOUGLASS**: Madame President, members of the Senate, I too rise with some very substantial concerns about the bond package that has been presented to us. When we authorize bonds, we are given the state's full backing and authority to the entities that we fund. I'm very much in favor of some of the goals in this package, the goals of housing and university research. But I am concerned that one particular area of investment was specifically left out of this in a last minute change. That was a bond for small businesses, such as the dog grooming businesses in my area or the hair cutting businesses that we are going to depend on in our future, particularly as we lose those large manufacturing or wood-based product industries, and as we are all facing the prospect that we will have in our lifetime, perhaps, six or more different types of occupations. I'm concerned that this micro-enterprise part of the bond package was left out. It is much needed and it is needed now.

As we look at the mill closings around our state, and there are more to come as people are willing to work for a lot less, off our shores, and we are ready to buy those packages of whatever it is that they produce. We really need to have a strategy and that strategy is going to include small business.

This package, as I have said, does address some of the things I think the state does need, in terms of housing and supporting university research, which gets matching leverage funds. But it also supports a private enterprise at great cost to the state and for a very modest return. So I rise to voice those concerns. Frankly, I'm not sure which way I'm going to be voting on this. But I think it's important that we put on the record the concerns we have, those parts we support and those parts that we do not. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from York, Senator Nass.

Senator **NASS**: Thank you, Madame President, men and women of the Senate. I too am disappointed in the package that is in front of us. I have not seen a list of projects, which I would expect to see in a capital bond proposal. I'm very disappointed. In my opinion, building buildings at the university and hiring vice-presidents is not economic development. It does not create jobs. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT**: Thank you, Madame President, fellow members of the Senate. I very reluctantly rise in opposition to this package. I've been contemplating this for some time, and frankly, regret that I have to oppose this package because there is much good in it.

I support the expansion of biomedical research in this state. I think it is critical that we focus on a very promising area of prosperity for our state's economy. I support the research and development packages at the University of Maine.

However, I took an oath, as I've done for three previous sessions, a few months ago. It was an oath to uphold the constitution of this state and I've come to the conclusion that voting for this package would violate that oath because under Article V, part 3<sup>rd</sup>, section 5, it's very clear that the constitution required that the legislature enact a law prohibiting the use of proceeds from the sale of bonds to fund current expenditures. Contained within this bond package are current expenditures. We cannot be funding current expenditures with bond proceeds.

In all of my years in the Senate, we have worked assiduously to avoid crossing that line and it is very difficult to avoid that line at times. I don't believe that there is a wholesale departure from that principle in this bond package, but regrettably there is at least one, and maybe a couple of items, which in my view, clearly cross the line into current expenditures. Funding, planning monies, and essentially staff support which should not be included in a bond package.

I have to say that I share the concerns of some other members today, notably the Senator from Lincoln, Senator Hall, who expressed some concern about lack of direction and clear articulation on our economic development strategy. I too hope that, as we move forward in the coming months, we will be clearer about that. I do believe this bond package does continue us in a productive direction with economic development, focusing on some very promising industries. I support those provisions of it. In so far as this is one package and requires an up or down vote, I cannot, in good conscious, vote for this, mindful of my constitutional oath. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Penobscot, Senator Sawyer.

Senator **SAWYER**: Thank you, Madame President. The handout that our caucus received earlier this morning was entitled 'Economic Development'. I think the bill before us is often times referred to as economic development. I'd like to remind us that this is not the definitive economic development bill that will fix the ills that are growing, apparently, in the State of Maine. Let's not beat our chests that we have solved Maine's declining economic climate.

In my opinion, we will not attain true economic development until we remove the impediments to a healthy economy. Those include reducing our very high utility costs, reducing our very high workers' compensation costs, and obtain a timely response from agencies when businesses and employers are asking for permits. That's not to say that they would be granted permits that were not earned, but a timely response. We will not have healthy economic development until we reduce our property tax, and until we reduce our marginal tax rate. Until then, we are only giving lip service, in my opinion, to the notion of economic development.

So I would just ask that, for those that believe this is a first step, we not stop the process, that we not claim victory, because it's clear that the empirical data will not come in until we see a turn around in the decline of very well paying jobs with excellent benefits. Thank you, Madame President.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Cathcart.

Senator **CATHCART**: Thank you, Madame President, men and women of the Senate. I urge you to vote in favor of this bond proposal so that it can go on the ballot in June, be passed by the voters and allow us to start working on these projects that will, indeed, stimulate our economy. Nobody claims that this is the perfect answer to all of our economic problems. It's not. We could point to other places as sources of some problems. What this does do is provide funding for projects that will get started very quickly, projects that will leverage a large amount of federal funds into the State of Maine to help us improve and strengthen our research and development capacity in both private sector and our university research. I think that is very important.

It provides money that will assist municipalities with projects such as sewer extensions. I have one of those in my district where it has a company that is outside of the town water and sewer line. They could apply for that kind of money from the municipal investment trust fund.

This provides funding for biomedical research. This is very important research that is focusing on the fisheries in the Gulf of Maine. This is something that we have needed more of and it's a very collaborative effort in which the university and private sectors are working together. That is going to be positive for this state.

It provides funds for affordable housing, workforce housing, and housing to assist first time home buyers, which also leverages about \$21 million in federal funds for affordable housing. We all know that our state needs more housing for workers.

So I think that, overall, it is a very important economic package. I think it will be good for the state. It does not have everything in it. I too would have liked to see more for very small businesses and assistance for those people. I hope later on in the session we will be able to figure out a better way to provide that kind of assistance. But, all in all, I think it is a good package. It's an effort made by three parties, really. The House, the Senate, and the Executive. Not political parties, because we've all had to negotiate and work hard together to get this package. We've kept the total amount of it as low as we can, lower than originally proposed by the Chief Executive. I think it will do the state some good. I urge your support for it. Thank you, Madame President.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Turner.

Senator **TURNER**: Thank you, Madame President. I, too, rise and ask that you support this bond package. I would also like to take a moment to thank the chair of the Appropriations Committee and my other Senate colleague, Senator Rotundo. I think we worked very hard together, collaboratively. We really tried to think about this in terms of what we could do in a political environment that would be best for the people of Maine.

As the good Senator from Penobscot, Senator Cathcart, has already indicated to you, this is going to create a whole myriad of construction jobs, in the short term. More importantly, when you get passed that, there are a series of high energy, high value jobs that will be created in several key research areas. I think, when I reflect on this package and go back to our new Chief Executive Officer's speech to us in January at his inauguration, he talked about not leaving behind the natural resource heritage and economy as we move forward in the 21<sup>st</sup> century.

There are many elements in this package that are mindful of that. I think about my own district, and I look at this package and say 'what's in it for my district?' Frankly, the answer to that is not a

whole heck of a lot. In fact, there is almost nothing in it for my district. I've worked hard for the passage of the elements that are in here. I think this is a good first step and I'm mindful of the comments of the other Senator from Penobscot, Senator Sawyer, when he talks about the other pieces that we have to legislatively package around bonds as we go forward. It isn't that this is the end all for us, economically.

It is really a first step. I believe that it is incredibly important for our people. It's important for our economy. I think, in a bi-partisan fashion, as we have worked so far through this session, this can be a continuation of teamwork that I finally think is quite heartfelt and good for the people of Maine overall. I would urge your support of it. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Strimling.

Senator **STRIMLING**: Thank you, Madame President. I rise just to express a couple of thoughts. One is that I am very appreciative of the money that is in this bond for affordable housing and economic development. It is essential that we find ways to deal with the housing crisis in this state and certainly in southern Maine. I had wished that it had been closer to the original that the Governor had put forward of \$13 million, but the \$8 million is a good start or a good continuation.

I also want to express my extreme disappointment that the micro-enterprise money is not in here. It feels very much like whenever we need to find money to support big businesses to expand, we find it. But when it's for small businesses, which are truly the backbone of this economy in the State of Maine, somehow they get left aside. I hope that we can work in the months to come to make sure that the micro-enterprise money does get put back in so we can support that sector of our economy. Thank you.

This being a Bond Authorization Act, in accordance with the provisions of Section 14 of Article IX of the Constitution, having received the affirmative vote of 24 Members of the Senate, with 9 Senators having voted in the negative, and 24 being more than two-thirds of the Members present and voting, was **PASSED TO BE ENACTED** and having been signed by the President, was presented by the Governor for his approval.
