# STATE OF MAINE PROCLAMATION

WHEREAS, there exists in the State of Maine an extraordinary occasion arising out of the need to resolve legislative matters limited to bond authorizations for educational and cultural facilities, highway, bridge, and other expenditures related to transportation, pollution control, parks and other public facilities; tax relief; and legislation correcting errors and inconsistencies; and

WHEREAS, the public health, safety, and welfare requires that the Legislature resolve those pending matters as soon as possible, and in any event prior to the date of the Second Regular Session of the 121st Legislature:

NOW THEREFORE, I, JOHN E. BALDACCI, Governor of the State of Maine, by virtue of the constitutional power vested in me as Governor pursuant to Article V, Part First, Section Thirteen of the Constitution of Maine, convene the Legislature of the State, hereby requesting the Senators and Representatives to assemble in their respective chambers at the Capitol in Augusta on August 21, 2003 at one o'clock in the afternoon, in order to receive communications, and enact bond authorizations and tax relief measures as may properly be brought before this special session of the Legislature.

In testimony whereof, I have caused the Great Seal of the State to be hereunto Affixed GIVEN under my hand at Augusta this twenty-eighth day of July in the Year of our Lord Two Thousand and Three.

JOINT RESOLUTION MEMORIALIZING CONGRESS TO CONTINUE THE FULL EFFECTIVENESS OF THE HEAD START PROGRAM

WE, your Memorialists, the Members of the One Hundred and Twenty-first Legislature of the State of Maine now assembled in the First Special Session, most respectfully present and petition the Congress of the United States as follows:

WHEREAS, the Head Start Program was introduced over 40 years ago and has changed the lives of more than 20,000,000 American children and their families with the simple idea that poor or disabled children will do better in school and in life if they get a "head start" in learning before beginning kindergarten; and

WHEREAS, to prepare preschoolers to function in the classroom and to improve their language skills, the Head Start Program immerses 3-year-olds and 4-year-olds in stimulating activities with other children and trained adults; and

WHEREAS, the Head Start Program most importantly fosters the commitment and involvement of parents and the community in providing educational development for these children; and

WHEREAS, national studies have confirmed that the Head Start Program works as it is now structured, that children improve in all areas of skills and knowledge when they are involved in the Head Start Program and that Head Start graduates are less likely to repeat a grade, less likely to require special education, less likely to be charged with or convicted of a crime and more likely to complete high school and college; and

WHEREAS, on June 19th of this year, the United States House of Representatives' Committee on Education and the Workforce voted to make fundamental changes to the Head Start Program by giving block grants to the states instead of directly funding Head Start, which then would allow diminished services, weaken the role of parents, shift money to states' budgets instead of Head Start and provide no meaningful oversight; and

WHEREAS, these proposed changes would effectively dismantle the Head Start Program, which has been so highly successful over the years. We urge that, rather than undercutting the federal program, direct funding be expanded to ensure that all our nation's children who need this program are included; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-first Legislature, now assembled in the First Special Session, on behalf of the people we represent, take this opportunity to urge the Congress of the United States not to change what is currently a very successful program, to keep the Head Start funding system as it is and to make sure that all the children in America who need this program have the opportunity to be part of Head Start; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Speaker of the United States House of Representatives, the President of the United States Senate and to the members of Maine's Congressional Delegation.

## READ.

**THE PRESIDENT**: The Chair recognizes the Senator from Franklin, Senator Woodcock.

Senator **WOODCOCK**: Thank you, Madame President, ladies and gentlemen of the Senate. I quote from this resolution that the move from the federalized Head Start Program to a state controlled Head Start will diminish services, weaken the role of parents, shift monies to states' budgets, and provide no meaningful oversight. That is one perspective. Another perspective is that the states' control of the Head Start Program might, in fact, enhance the ability of parents to have control over the Head Start Program. It might enhance the diminished services, if you would call them diminished. It might enhance the oversight process, because it would become tied very closely to your community.

The Head Start Program is a valuable program. My children, and children of others in this room, were, in some way, connected to Head Start. Head Start offers valuable assistance to young people. What we are debating tonight is whether or not we have a perspective of a continuation of a federalized funding and oversight process, or the ability of the states and local communities, therefore, to control the Head Start operations.

I am going to be opposing passage of this resolution. I feel that the Head Start Program will be better served with this local control. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Androscoggin, Senator Rotundo.

Senator **ROTUNDO**: Thank you, Madame President, men and women of the Senate. The United States Senate is considering a bill to reauthorize the Head Start Program. I hope you will join me in supporting this resolution that asks Congress and the President to keep the program as it now stands. The success of this program is very well documented throughout this state, and throughout this country. Head Start works for children, and it strengthens families. It also strengthens our economy by helping children to succeed in school, and by helping families to become self-sufficient. Let's not try to fix something that is not broken. Please join me in supporting this resolution. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Androscoggin, Senator Douglass.

Senator **DOUGLASS**: Madame President, I, too, rise in support of this resolution. Head Start is one of the programs that was begun in the 1960's, and has proven results. The proposed changes in the funding of that program are not proven. We need to look towards accountability. Towards where we are headed in the future. In supporting this resolution, we are making the statement that what we have seen Head Start do for those children who enter our school systems ready to read, ready to learn, and with a far better education than they had prior to its start. We are affirming that program, and saying that we must keep it. We need to improve it, but this is not the way. By simply making a block grant without any further reducing of the accountability measures that might come into play with this, we would, in effect, be voting against Head Start rather than for it. I urge you to vote in favor of Head Start with this resolution.

**THE PRESIDENT**: The Chair recognizes the Senator from Franklin, Senator Woodcock.

Senator **WOODCOCK**: Thank you, Madame President, ladies and gentlemen of the Senate. I would reiterate that my vote against this resolution is not a vote against Head Start. It is a vote against the process that is being proposed, and to be given to the states as a control mechanism versus the federalized control. The possibility that this program might be improved has yet to be determined. We have one funding mechanism. We have one oversight mechanism. We have absolutely no idea that, with local control and a more regional operation, we might have a better Head Start Program than we have now. I would say once again, we're not voting against Head Start, we've voting against the process. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Aroostook, Senator Martin.

Senator MARTIN: Thank you, Madame President and members of the Senate. Let me give you a reason why you should be voting for this. How many of you really think that once we have control of the program the federal dollars will continue to flow? Think of all of the other federal programs that have been transferred to the states and what has happened with the federal funding over time. Granted more oversight is entirely possible, if the state were to achieve it. What will happen when the funding gets cut at the federal level? What do we do then? The reason, of course, is that some people at the federal level would like to get it moved onto the states. Then they won't have the pressure that they now bear when they don't fund it. That is why I'll vote for passage of the resolution.

On motion by Senator **BENNETT** of Oxford, supported by a Division of at least one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT**: The pending question before the Senate is Adoption, in concurrence. A Roll Call has been ordered. Is the Senate ready for the question?

**THE PRESIDENT**: The Chair recognizes the Senator from Aroostook, Senator Martin.

Senator MARTIN: Thank you, Madame President and members of the Senate. For whatever reason, over the years we have dealt with the development of Loring in the Transportation budget. Frankly, it should probably be in the Economic and Development budget. The \$1 million, at some point much earlier in the process, probably in February or March, got left out. Frankly, some of us never saw it or caught it. This \$1 million in development at the hangar has the potential of 350 jobs at the center. Without it, this will not occur. If there is anything that can be of economic development to Aroostook County, this is one. Frankly, the number of jobs that would be created at Loring, at the Commerce Center, presently almost exceeds the number of civilian jobs that were there when Loring was an Air Force base. Tremendous progress has been made in 10 years to revive that portion of the county. Without the amount of work that had been done by a number of people in Aroostook, and from other parts of the country as well, we would not be where we are in Aroostook County. That is why I am offering this amendment today, in order to provide economic development. To continue the work that has been done, and to improve the conditions of what has happened at the center. That \$1 million has the potential of bringing back twenty fold because it also has the potential of bringing one major airline back to Aroostook County. I would urge you to vote for it.

On motion by Senator **MARTIN** of Aroostook, supported by a Division of at least one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT**: The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT**: Thank you, Madame President, would request permission to pose a question through the chair to anyone who may wish to respond.

Senator **BENNETT**: Thank you, Madame President. I'm looking at Senate Amendment "M" (S-345) for the first time. I see that there would be a change in the title, I believe, with this amendment and it would change the title to 'An Act to Authorize Bond Issues in the Total Amount of \$94,800,000 et cetera.' I'm wondering where the \$94,800,000 figure comes from and how it relates to this amendment in particular? Thank you, Madame President.

**THE PRESIDENT:** The Senator from Oxford, Senator Bennett poses a question through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from Aroostook, Senator Martin.

Senator **MARTIN**: Thank you, Madame President and members of the Senate. We are somewhat in a quandary in the process of doing amendments. Whenever amendments are adopted, those totals are all going to be restructured, so that if this amendment were to go on and another one and another one, we will, at some point, have to merge them into one amendment. I'm not sure that makes any sense, but keep in mind that we can amend to the third degree. Since you've got the majority report to the bill, you've got a committee amendment, and now you've got another amendment. You can't go amendment to the amendment. That is the reason why you are getting that. You have to, somewhat at this point, ignore the question, because all the questions will be wrong. At some point,

once we have some understanding of what makes up that package, that will have to be restructured by the Committee on Engrossed Bills, of which I happen to be the chair.

**THE PRESIDENT**: The Chair recognizes the Senator from Knox, Senator Savage.

Senator **SAVAGE**: Thank you, Madame President. I maybe confused, but it looks to me, and maybe the Senator from Aroostook, Senator Martin, doesn't agree, but I think we've go in here \$3,600,000. According to a sheet I'm looking at, this amount does include \$1 million for Loring.

**THE PRESIDENT**: The Chair recognizes the Senator from Aroostook, Senator Martin.

Senator **MARTIN**: Thank you, Madame President. I don't want to further confuse the issue, but if you take a look at page 2 of the Senate Amendment you will see that it deals with raising the \$60 million to \$61 million. The problem you have is that we are now working off an amendment that was just adopted on transportation. That was the point I was making in reference to the question posed by the good Senator from Oxford, Senator Bennett. What I am offering right now is \$1 million. Obviously, the amendment that was previously adopted also adopted additional money. The Doorkeepers secured the Chamber. Those figures, at some point, will all need to be totaled up. That is basically what will transpire.

**THE PRESIDENT**: The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT**: Thank you, Madame President. It seems to me, from the answer or the most recent colloquy here, that if we adopt this amendment, the current posture of the bill, or at least of the Committee Amendment, will be for \$2 million for Loring Air Force Base and for the development thereto. Thanks.

**THE PRESIDENT**: The Chair recognizes the Senator from Hancock, Senator Damon.

Senator **DAMON**: Thank you, Madame President, ladies and gentlemen of the Senate. My amendment calls for the change in the bond package in the following ways; an additional \$550,000 be added to the ship program, the small harbor improvement program, which is an economic development program for the coastal harbors of Maine. It's much smaller in individual scope and total scope than the previously voted on economic development package for Loring. Nonetheless, it is designed to be, and it is critical to the continuance of ports and opportunities for fishermen to exit and enter the harbors.

In addition, my amendment calls for the inclusion of an additional \$1 million to fund the replacement in the Maine State Ferry Service for the Governor Curtis class ferry. There are presently seven ferry boats in the Maine State Ferry Service. One of them is 44 years old, one of them is 43 years old, and the newest of them is only 10 years old. The ferry and its function is to the island communities of our coast in our state much like the bridges are for the inland. Most notable of those bridges, and most recently in the news, is the Waldo/Hancock Bridge. If we allow our bridges to our islands to deteriorate, which they are, in fact, doing now in the form of these vessels, we do no service to those small communities that rely on them so heavily.

The final aspect of my amendment, Madame President, is the addition of \$500,000 to the trail and bicycle path improvement program. I urge your support. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT**: Thank you, Madame President. I request permission to pose a question through the chair?

**THE PRESIDENT:** The Senator may pose his question.

Senator **BENNETT**: Thank you, Madame President. To anyone who is able to respond, I note that this amendment would change the total amount in the title of the bills to \$95,850,000. I would ask whether it is the intention of this amendment to create a bond, or a set of bond issues, at that level?

**THE PRESIDENT:** The Senator from Oxford, Senator Bennett poses a question through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from Kennebec, Senator Treat.

Senator **TREAT**: Thank you, Madame President. I believe that the question of the good Senator from Oxford, Senator Bennett, has been previously posed to a different amendment and I believe the answer is the same. This is why we have an engrossing department and an engrossing committee. If, indeed, all three of these amendments are put on, they will need to be engrossed, at which point any inconsistencies will be identified and then corrected, if this body chooses to do so.

**THE PRESIDENT**: The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT**: Thank you, Madame President. Perhaps I wasn't as clear as I ought to be. The nature of my inquiry is to the intent of this amendment and in the context of the overall bond, not the engrossing process. In doing rough math, depending on which baseline one starts from, the previous amendment from the Senator from Aroostook, Senator Martin, that we have already adopted, added to this. It constitutes a bond that would be in excess of \$95,850,000. Again, my question may have been misunderstood. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Aroostook, Senator Martin.

Senator **MARTIN**: Thank you, Madame President and members of the Senate. Let me try to make it somewhat clearer. You take the amount of money that is in the bond amendment offered by the Senator from Somerset, Senator Hatch. You add the figure that I added to it. You then add what is in this amendment. The three figures will give you the figure that will be in the new bond package.

**THE PRESIDENT**: The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT**: Thank you, Madame President. I am grateful for the lesson in arithmetic. I think the point is that we are having a continually elevating number to the total dollar figure for this bond. We just seem to be layering on top of the number that I already felt was a bit high. We haven't necessarily seen the last of all the amendments either. I'm growing increasingly concerned about the size of this bond package. I will be opposing this amendment because of that reason.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Turner.

Senator TURNER: Thank you, Madame President, ladies and gentlemen of the Senate. I will take a slightly different course because if you are to adopt the amendment that I have put forward, it will do several things. First, it wipes out Committee Amendment "A" (S-317), and replaces it with the transportation portion of the Republican offering. Strange as it may seem to you, we went to the Administration and sat with people in the DOT and asked, 'What do you need at a minimum in order to fund the two year program for highway improvements and related transportation matters?' The figure they came back to us with at the time was \$57,500,000. To that we have added \$5 million to deal with the first portion of the request that we need in order to act responsibly with respect to the Waldo/Hancock County bridge. The total request, of my offering to you, is \$62.5 million. That draws down matching federal monies of roughly \$226 million. I think if you pay attention to the phone calls, conversations, or e-mails that you have gotten from your constituents, and I'm sure this is consistent in every one of our districts, what people are really asking for is a transportation bond package that allows us to take care of our transportation infrastructure. That is what my offering to you is this evening. I would urge that you set aside the other pieces. Deal with the essentials that we have to deal with in this special session, and we can come back in January and deal with the other things that are of a less critical nature in transportation. I would urge your support of this amendment. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Aroostook, Senator Martin.

Senator **MARTIN**: Thank you, Madame President. May I pose a question through the chair to the Senator from Cumberland, Senator Turner, in reference to the amendment? Am I correct in assuming that there will be no money for environmental bonds or any environmental issues facing the state in this year's bond package going to the voters? Am I assuming that the only thing this amendment does is deal with highway alone? Is that the intent of the amendment?

**THE PRESIDENT:** The Senator from Aroostook, Senator Martin poses a question through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from Cumberland, Senator Turner.

Senator **TURNER**: I think the answer is yes, yes, and no. There is no environmental piece in this offering. There is no education piece in this offering. However, it is more than just highway. It is freight improvements as well as transportation improvements. For example, you have an amendment that has been passed that puts an additional \$1 million for Loring. This offering before you, that I have presented, has \$800,000 for Loring. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Edmonds.

Senator **EDMONDS**: Thank you, Madame President. In my reading of the amendment before us, there is only \$2.5 million for the Portland rail to Brunswick. I have been listening to my constituents, and that is an unacceptable level. That rail line is key to all future development that has to get from Portland to Freeport to Brunswick to, in fact, open up the

corridor to Lewiston and Auburn and beyond. For that reason, and the fact there is no bonding for higher education or the environment, I will not be supporting this amendment.

**THE PRESIDENT**: The Chair recognizes the Senator from Somerset, Senator Hatch.

Senator **HATCH**: Thank you, Madame President, ladies and gentlemen of the Senate. I assume that this amendment, that was put forth, was put forth in good faith. I have no reason to think it wasn't. I also know, after having spent many months on the Transportation Committee, that there are many needs that are not being met in this state. I know that extends to everything, including education, environmental issues, and lots of other things. I don't think we're asking that we raise and appropriate this money today. We're asking to put this out to the voters and let them decide.

When I talk to people in my district, they would like to have their roads paved, but they also want to have money for higher education, for Lifeflight of Maine, and for other things that we need to do. I think it's up to us to at least put that out to the voters. I would request that you look deep within your heart, follow my light, and vote no on this amendment. I think it was put out there in good faith. There was probably one meeting with the Transportation Department, and they were trying to come to some resolution.

The Appropriations Committee worked long and hard to come to some resolution, and a bond package amount. I give you credit for that. Those long hours, when you sat in a room, faced each other, and tried to decide how much we ought to bond for. There has never been a better time in this state, or more of a cry in this state, for economic development than the transportation bond package and what it will do for this state. There is also a cry that rings out throughout the state to our environmental issues, and other issues. I think the people of the State of Maine are the wisest people in the world. I think they will make the right decisions. Have they turned down bond packages before? Yes, they have. Will they turn this one down? I don't think so. I ask you to vote against this amendment and proceed forward to put the bond package out there in the fall. Let the citizens of this state make the decision on exactly what they want to fund.

Same Senator requested a Roll Call.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Turner.

Senator **TURNER**: Thank you, Madame President. I just wanted to respond to the good Senator from Cumberland, Senator Edmonds. I, too, share your concern about being able to develop the rail corridor from Portland to Brunswick. A very key aspect of that is to make sure that we can take advantage of the significant traffic that now goes through Freeport, often to L.L. Bean and related retail establishments in downtown Freeport. With respect to expanding rail towards Lewiston, in the current plan the department has, you can't get there without going through Yarmouth. This will take care of us, I believe, up to Freeport and we will get there by going through Yarmouth. It was \$2.5 million of bond money and draws down an additional \$10 million from the federal government. I would, again, urge your acceptance of this amendment. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Edmonds.

Senator **EDMONDS**: Thank you, Madame President, men and women of the Senate. I just want to clarify that in all of the conversations I've had with my local officials, this will get us there, but a year and a half later than we need to get there. We need the money now to get us on track and to stay on track. That is the important thing, as far as I'm concerned. Thank you.

**THE PRESIDENT**: The Chair recognizes the Senator from Aroostook, Senator Martin.

Senator MARTIN: Thank you, Madame President. Having served as a Senate Chair in the Natural Resources Committee this year, I do have some knowledge of what will happen if we don't put money in the environmental side of the issue. At this point, the way this amendment would go, there would be no money for the uncontrolled hazardous waste sites that are presently located in Waterville, Dover-Foxcroft, South Paris, and Houlton. There is no money for the overboard discharge grant program, which has already brought back miles of coasts so you can now do clamming on many of those areas. I can read all of them. Ironically, none of them are in my district. They are all on the Maine coast. They run all the way from Gouldsboro to Bath. There is no money in here for the drinking water program, the shellfishery protection program, the small community grants program, or the water quality protection. I can't believe that this Senate would want to tell the people of Maine that we don't care about the environment, and that we are going to lose all the federal money that is presently available from matches in some of these programs. It might be great to say we're going to match the federal dollars for transportation. I support that, but

some of these federal dollars are available with 11-1 matches. So every dollar that Maine puts in on some of these environmental programs, we would get \$11 to do the job. That maybe the desire of some, but I can't believe it is the desire of the Republican Party in Maine.

On motion by Senator **HATCH** of Somerset, supported by a Division of at least one-fifth of the members present and voting, a Roll Call was ordered.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Turner.

Senator **TURNER**: Thank you, Madame President. I think the interesting thing is that, when you look at environmental bonds, education bonds, or transportation bonds, the fact is that both parties have shown a strong history of supporting all such measures. You have one amendment before you. I will confess to having 11 others here as well. I am hoping to deal with these in a serial fashion. I would not abandon the things that you have concerned yourself with, out of respect to the environment or education, but I am simply dealing with the amendment that is before us at the moment.

**THE PRESIDENT**: The pending question before the Senate is the motion by the Senator from Cumberland, Senator Turner to Adopt Senate Amendment "H" (S-333) to Committee Amendment "A" (S-317). A Roll Call has been ordered. Is the Senate ready for the question?

The Doorkeepers secured the Chamber.

The Secretary opened the vote.
