THE PRESIDENT: The Chair recognizes the Senator from York, Senator Bailey.

Senator **BAILEY:** Thank you, Madam President, Men and Women of the Senate. Today, I'm pleased to rise and recognize the Thornton Academy Speech and Debate Team in the Maine Senate.

Speech team members include Abby Lizotte, Sam Drummey, Sophia Farago-Dumsch, Adeline Burman, Olive Homer, and Toby Fidalgo. Lauren Sonneborn is their advisor. Debate team members include Benjamin Blue, Alexa Knox, and Lien Nguyen. Nathan McKenney and Susan Biggs are their advisors.

Earlier this year, these student orators and debaters competed in the Maine State Speech and Debate Tournament. At the tournament, several individuals placed first or second in their respective categories and events. Starting with the debate category, Alexa Knox was the first-place state champion in the Lincoln-Douglas novice debate. For those who are not familiar, a Lincoln-Douglas debate is a competitive speaking activity that involves two debaters arguing for and against a resolution and voted on by coaches. Somewhat like the old debates, the debate focused on the conflicting values of social and philosophical issues, for example, by examining questions of morality, justice, democracy, etcetera. Typically, the debaters concern themselves with deciding whether or not certain actions or state of affairs are good or bad, right or wrong, moral or immoral. Congratulations on being the best debater, Alexa.

Switching to the speech category, Sophia Farago-Dumsch placed second in the original works event. For this event, competitors performed a self-written piece in a creative format such as poetry, prose, or drama. The piece, typically eight to ten minutes long, showcase the competitors' writing and performance skills, emphasizing originality, storytelling, and emotional impact. Judges evaluated the effectiveness of the writing, delivery, and overall engagement of the performance.

Next up, Sam Drummey - yes, that Sam Drummey that we already heard about from Senator Ingwersen. Sam was the first-place state champion in the extemporaneous speaking event. For this event, competitors have 30 minutes to prepare a five- to seven-minute speech answering a current events question that they did not know in advance. They had to use and cite six or more credible sources, construct a clear argument, and deliver the speech without notes. Judges evaluated analysis, organization, delivery, and the ability to speak persuasively and knowledgeably under time constraints.

Last but not least, Abby Lizotte. Abby was the first-place state champion in the original oratory event. For this event, competitors delivered a self-written persuasive speech on a topic of their choice. The speech, typically eight to ten minutes long, had to be memorized, using logical arguments, emotional appeals, and valid evidence to inform or inspire the audience. Competitors were judged on content, delivery, and their ability to engage and persuade effectively.

As a State Senator, I'm always delighted to welcome constituents, especially students, to the Senate Chamber, where my colleagues and I can celebrate your accomplishments and contributions. I'm very proud of all of you. And for those of you who will go on to compete in the national tournament, I wish you the best of luck. Go, Trojans!

And I would also say that hearing the description of these competitions, I think that these students are well suited for a future in the Legislature should they so choose at any time.

Senator **CYRWAY:** Thank you, Madam President, Ladies and Gentlemen of the Senate. I rise to recognize two outstanding people from the town of Benton, Dwight and Kay Gagnon.

Their work has benefited not only their town but the surrounding communities as well. Fortunately, I was classmates with Dwight Gagnon and both him and his wife have been lifelong friends. So, I'm so proud to let you know about their accomplishments. They volunteer at the voting booths over at the Town of Benton. They also volunteer for their church and they have been trying to raise funds for a Paul Revere bell historically that was brought to the Benton Falls Church and raised in the steeple and they're trying to refurbish it and get it back up there. It's a lot of money, and they're trying to do their best to get that done. They also -- Benton has a history back many, many years ago, I think early 1900s, where the -- when the dams were going and then they took down the Winslow dam and the Benton Falls dam still is in operation, but it allows the alewives to come up to the Benton Falls dam and we manage to bring back the history of what they did back in the early 1900s where there was allowing one-third of the profits would go towards paying the town's taxes. And so, they brought that back and I think there's been times when now they're raising almost \$90,000 a year just in profits from the alewives coming upstream. So, Dwight is now the warden for taking care of those alewives and he volunteers his time, which is very demanding.

Also, he was recognized by the artwork he did at Windsor Fair and it was one of the top -- well, it was chosen as the top art piece and used as their theme for Windsor Fair. And also, they're Grange members and they volunteer their time. Kay, she does piano for her church and she sings also with the - I'm trying to remember the name, I can't quite remember the name of the group - but they do a lot of like almost quartet type singing and they do it all over the state and it's very impressive.

So, I'm very proud to introduce these two outstanding individuals for the town and I want to join the Good Senator from

Senator **TALBOT ROSS:** Thank you, Madam President. So, earlier this year, Governor Mills announced that 2025 will be celebrated as Maine's Year of Youth in Agriculture, an initiative that was launched during the Maine Agriculture trade shows to recognize and support the next generation of agriculture leaders.

For the first time ever, today is also Youth in Agriculture Policy Day at the State House, alongside Maine Agriculture Day, a key opportunity to integrate this important initiative is to connect Maine's students directly with policymakers, industry leaders, and hands-on experiences. So, this morning, I'm very proud to introduce you to ten students from across the State of Maine who are joining us in the Gallery. They have been selected as Policy Day participants from the Department of Agriculture, Conservation, and Forestry, and the Department of Education, and will attend a committee meeting, Senator Black, they'll be in committee at the ACF this afternoon. They are learning about the legislative process, how to submit a bill, attend a work session, and testify at a public hearing.

There are also students throughout the day here from the Maine Academy of Natural Sciences and Easton schools. These are the next generation of students engaged in agriculture policy within our state. Maine agriculture contributes over \$3.2 billion annually to the state's economy and provides tens of thousands of jobs and it strengthens food security across the state. The students here today are interested in animal health, rural prosperity, the environment, food security, and farm viability, just to name a few. So, I hope that we'll give a very warm, warm welcome to some of our students here today in the State House as they begin their journey in agriculture. Thank you all for being here, and I want to just acknowledge and thank Commissioner Beal for her hard work in making this possible. Thank you all.

The following Joint Resolution:

H.P. 578

**JOINT RESOLUTION ACKNOWLEDGING THE HOLODOMOR
AS AN ACT OF GENOCIDE AGAINST THE UKRAINIAN
PEOPLE**

WHEREAS, the Ukrainian famine-genocide of 1932-1933, known as the Holodomor, was a human-made famine that caused the deaths of at least 5,000,000 innocent men, women and children in Ukraine, resulting in the annihilation of an estimated 25% of the rural population of the country, an area that at the time was one of the most productive agricultural areas of the Soviet Union; and

WHEREAS, the human-made famine also resulted in the deaths of an estimated 1,000,000 to 2,000,000 people in regions outside Ukraine, mostly in the largely ethnically Ukrainian North Caucasus territory; and

WHEREAS, these people were starved to death by forced agricultural collectivization and grain seizures by the Soviet Union; and

WHEREAS, Western observers and scholars who accurately reported on the existence of the famine as it was occurring were subjected to disparagement and criticism; and

WHEREAS, the Soviet Union and many scholars in the West denied the existence of the famine until the collapse of the Soviet Union in 1991 made access to Soviet Union archives, and thereby the documentation of the premeditated nature of the famine and its harsh enforcement, possible; and

WHEREAS, the final report, delivered to Congress on April 12, 1998, of the United States Commission on the Ukraine Famine concluded that the victims "starved to death in a man-made famine" and that Soviet dictator Joseph Stalin "and those around him committed genocide against the Ukrainians in 1932-1933"; and

WHEREAS, although the famine resulted in one of the largest losses of human life in the 20th century, its occurrence remains insufficiently known in the United States and throughout the world; and

WHEREAS, official recognition of the famine by the government of Ukraine, including by the country's parliament, the Verkhovna Rada of Ukraine, represents a significant step in the reestablishment of Ukraine's national identity and the advancement of efforts to establish a democratic and free Ukraine that is fully integrated into the Western community of nations; and

WHEREAS, whether it was political oppression or religious persecution that caused Ukrainian immigrants to pursue better lives for themselves and their families, their desire to live in peace

and enjoy liberty was so strong that generations of Ukrainian immigrants came to the United States in an effort to rebuild their lives; and

WHEREAS, since 2006, Ukraine has marked an annual commemoration for the victims of the famine; and

WHEREAS, a memorial to the millions who perished in the Holodomor was erected in Washington, D.C. in 2015, and the dedication ceremony took place in November of that year; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-second Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to commemorate the Ukrainian Famine-Genocide of 1932-1933, known as the Holodomor, to solemnly remember and honor its millions of victims and to recognize the Holodomor as an act of genocide against the Ukrainian people.

Comes from the House, **READ** and **ADOPTED**.

THE PRESIDENT: The Chair is pleased to recognize the Senator from Hancock, Senator Grohoski.

Senator **GROHOSKI:** Thank you, Madam President, Colleagues of the Senate. Today, with the passage of this Joint Resolution, Maine will join 35 other states, the European Parliament, and 33 United Nations member states in recognizing the Holodomor as a genocide against the Ukrainian people.

Thank you to my constituent and Ukrainian refugee, Levko Fedorak, for helping to bring the Holodomor atrocity to light.

The Holodomor was a manmade famine in Ukraine from 1932 to 1933, resulting in the deaths of an estimated five to seven million people. This tragedy was the result of deliberate policies by the Soviet regime aimed at suppressing and destroying Ukrainians as a people. The term Holodomor translates from Ukrainian as death by hunger or killing by starvation.

This atrocity meets the criteria outlined in the United Nations Convention on the Prevention and Punishment of the Crime of Genocide as follows. In the present Convention, genocide means any of the following acts committed with intent to destroy, in whole or in part, a national, ethnical, racial, or religious group as such: (1) Killing members of the group; (2) Causing serious bodily or mental harm to members of the group; (3) Deliberately inflicting on the group conditions of life calculated to bring about its physical destruction in whole or in part; (4) Imposing measures intended to prevent births within the group; and (5) Forcibly transferring children of the group to another group.

The Soviet Government's actions, including extreme grain requisition quotas, confiscation of food and restrictions on movement were calculated measures that led to mass starvation and suffering. The regime made no effort to help those affected and, in fact, actively prevented them from escaping to seek food elsewhere.

Today, the Russian Federation, as the successor state to the Soviet Union, continues to deny the Holodomor as genocide and tragically continues aggression against the Ukrainian people. While history cannot be changed, our recognition of these crimes is a powerful act of truth telling. By passing this resolution, Maine

acknowledges this dark chapter in history and honors the millions who perished. We also affirm our support for the many Mainers of Ukrainian heritage and stand with those working to preserve human rights and dignity in the face of oppression both past and present.

JOINT RESOLUTION RECOGNIZING MARCH 2025 AS BLEEDING DISORDERS AWARENESS MONTH

WHEREAS, bleeding disorders, which are distinguished by the inability to form a proper blood clot, are characterized by extended bleeding after injury, surgery, trauma or menstruation and can lead to significant morbidity and can be fatal if not treated effectively; and

WHEREAS, many individuals with hemophilia became infected with HIV and hepatitis C in the 1980s due to the contamination of the blood supply and blood products; and

WHEREAS, Bleeding Disorders Awareness Month will generate greater awareness and understanding of not only hemophilia but all inheritable bleeding disorders, including von Willebrand disease, which alone affects an estimated one percent of the U.S. population, or more than 3.2 million individuals; and

WHEREAS, Bleeding Disorders Awareness Month will foster a greater sense of community and shared purpose among all individuals with inheritable bleeding disorders; and

WHEREAS, Bleeding Disorders Awareness Month will elevate awareness of and engagement in the inheritable bleeding disorders journey for the general public, enabling the prevention of illness, unnecessary procedures and disability; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-second Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to recognize March 2025 as Bleeding Disorders Awareness Month.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Guerin.

Senator **GUERIN:** Thank you, Madam President, Ladies and Gentlemen of the Senate. In 1941, a boy named Lee Henry was born. Just 14 months later, he was diagnosed with hemophilia, a condition where the ability for blood to clot is greatly reduced and even just a small cut can lead to significant bleeding. Eight years later, his father, Robert Lee Henry, began the Hemophilia Foundation in New York State. In 1975, Senator Edward Kennedy introduced the creation of hemophilia treatment centers through legislation.

While many years of research have been conducted, legislation passed, and vaccinations for bleeding disorders introduced, in 1986, President Ronald Reagan designated the month of March as Hemophilia Awareness Month. According to the U.S. CDC, there are approximately three million people nationwide affected by bleeding disorders. Through ongoing research, medical advancements, and greater public awareness, Hemophilia Awareness Month has been expanded and recognized since 2016 as Bleeding Disorder Awareness Month. In doing so, it promotes greater education and awareness amongst the public and policymakers of hemophilia, von Willebrand disease, rare factor disorders, and more.

While it's fresh on our minds, I encourage everyone to take this opportunity to do a little more research on the topic that impacts the lives of so many of our constituents.

Thank you for the opportunity to speak on this important issue, Madam President.

JOINT RESOLUTION DESIGNATING MAY 4, 2025 TO MAY 10, 2025 AS TARDIVE DYSKINESIA AWARENESS WEEK

WHEREAS, serious mental illnesses like bipolar disorder, major depressive disorder and schizophrenia often require treatment with antipsychotic medications for effective management, and antipsychotic prescribing rates continue to rise; and

WHEREAS, while prolonged antipsychotic use may be essential for the treatment of certain conditions, it is associated with tardive dyskinesia, or "TD," a condition marked by uncontrollable, abnormal and repetitive movements of the face, torso, limbs or extremities; and

WHEREAS, people at higher risk of TD include those older than 55 years, Black individuals, women, individuals with mood or substance use disorders, intellectual disabilities or central nervous system injuries and those with high cumulative antipsychotic exposure; and

WHEREAS, approximately 60% of the estimated 800,000 adults in the United States living with TD remain undiagnosed, and even mild TD symptoms can be stigmatizing and impair physical, social and emotional well-being, underscoring the urgency of early screening, detection and intervention; and

WHEREAS, the American Psychiatric Association recommends routine TD screening in their clinical guidelines for antipsychotic treatment, and individuals treated with antipsychotics or experiencing abnormal movements should consult their healthcare providers to assess TD risk, receive TD screenings and determine appropriate treatment together; and

WHEREAS, United States Food and Drug Administration-approved treatments for TD can provide options for symptom management and improved quality of life for many individuals living with TD; and

WHEREAS, the Maine Legislature can encourage TD screening education and awareness for health care providers, patients and care partners to help ensure patients prescribed antipsychotics receive care and support that aligns with clinical best practice, including regular TD screenings; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Thirty-second Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to designate May 4, 2025 to May 10, 2025 as Tardive Dyskinesia Awareness Week; acknowledge the importance of early detection and intervention to improve outcomes for people living with mental health conditions and prescribed antipsychotics; and express our support for efforts to raise awareness about the causes and symptoms of TD and the importance of routine TD screening.

**JOINT RESOLUTION
HONORING THE ROLE OF IRISH IMMIGRANTS AND IRISH-AMERICANS
IN THE AMERICAN WAR OF INDEPENDENCE**

WHEREAS, in April 1775 at Lexington and Concord, Massachusetts, the American War of Independence began with "the shot heard round the world," which continues to echo to this day. That war 250 years ago inspired Ireland and others in many nations to continue to struggle to be free and to choose their own destinies; and

WHEREAS, just a month later in May 1775, Maurice O'Brien of Cork in Ireland and his 5 sons struck the first blow against the British at sea. The O'Briens and a group of local fishermen in Machias Bay, Maine captured the HMS Margaretta in a bold boarding action. When 2 more British warships were sent to reclaim the prize, the O'Briens and their neighbors captured them as well; and

WHEREAS, if the fights at Lexington and Concord were where the American nation was born, it was on June 17, 1775 at the Battle of Bunker Hill that the young American nation came of age; and

WHEREAS, at the heart of this fierce clash were the Fighting Irish and the names of Casey, Collins, Flynn and McGrath were among the names of the fallen. Among the New England militia who rushed to defend Boston Harbor were 176 Irish-born patriots and hundreds more who were children of Irish immigrants, many of whom had arrived as indentured servants; and

WHEREAS, seven Irish officers and dozens of Irish-American officers at Bunker Hill, including Colonel John Stark of New Hampshire, were among the heroes of the day, and among those who paid the ultimate price was Major Andrew McClary, born in County Tyrone, Ireland, who fought valiantly until his tragic death at the very end of the battle. McClary, the highest-ranking American officer killed that day, was the last to leave the battlefield; and

WHEREAS, another figure of Irish descent who played a key role in the revolution was Captain Ebenezer Sullivan. His brothers James and John went on to leave their mark on American history as well: James became governor of Massachusetts and John was a general who forced British troops to evacuate Boston, Massachusetts on St. Patrick's Day in 1776; and

WHEREAS, in December 1775, John Barry from County Wexford, Ireland, later known as the Father of the American Navy, was given command of the USS Lexington, the first commission issued by the Continental Congress. He would go on to receive Commodore Commission Number One from President George Washington; and

WHEREAS, the Battle of Bunker Hill and the shots fired at Lexington and Concord inspired Ireland to continue its struggle for independence, and its freedom and its peace were secured with the steadfast support of the United States of America; now, therefore be it

RESOLVED: That We, the Members of the One Hundred Thirty-second Legislature now assembled in the First Regular Session, pause in our deliberations to honor the role of Irish immigrants and Irish-Americans in the American War of Independence.

Senator **STEWART:** Thank you very much, Madam President, Ladies and Gentlemen of the Senate. I would like to wish you all a happy belated St. Patrick's Day. The timing didn't line up quite so well this year with our session days, but we'll send regards either way. And that comes, too, from a friend of this Chamber who has spoken previously in this Chamber, Mark Daly, who is the Senate President in Ireland, who was here I think it was last year or the year before, to commemorate St. Patrick's Day as well as to help foster along the American Irish State Legislators caucus, which some of you are members of already. And he has sent a care package over from the Emerald Isle which I am happy to share with all of you here later today. It does include a flag here for my colleague, Senator Harrington, as well as certificates of initiation into the caucus, and these pins as well that commemorate the caucus and membership thereof. And you don't have to be Irish to be a member of the caucus, you just have to be a friend of Ireland, so it's a rather loose interpretation there. But certainly, we look forward to seeing those ranks grow and I would invite my colleagues after the session is done to join at the well for a photo with the flag and the pins and the certificates.

And I just want to note the significance of this relationship between Ireland and Maine, in particular. I think, you know, I grew up in Aroostook County and the stories that I heard of my ancestors as immigrants was that they fled from Ireland because they were literally starving and that gave roots to the potato farming heritage of northern Maine, of which my family was a part of, and, you know, certainly the military history, both sides in my family have deep roots there in that regard. And so, all of it, there's just so many parallels between both literal relationships with folks in Ireland and the long family lineage that's there as well as the important values and traditions that they brought forward that helped to make not just Maine what it is today but also our country.

And so, I appreciate the opportunity to put forward this resolution to recognize those folks and that history and I appreciate all of your willingness to help recognize that and support that through membership of the American Irish State Legislators caucus here in Maine. So, with that, we'll see you after session and hopefully you got to drink some green beer yesterday. Thank you.

Senator **HICKMAN** of Kennebec moved the Senate **ACCEPT** the Minority **OUGHT TO PASS** Report.

THE PRESIDENT: The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT:** Thank you, Madam President, Fellow Members of the Senate. I rise to encourage a vote against the Majority Ought Not to Pass Report.

Our politics is broken. We see that, unhappily, in this building. I believe our government is corrupted by money. People do not trust the institutions that hold up our society. Our nation as we know it is in peril. Washington is a mess. Profound changes are needed. One area that needs immediate reform is our campaign finance laws. Results from a 2019 poll by the Campaign Legal Center show that 61% of voters believe that major changes need to be made to the campaign finance system and 83% of voters support publicly disclosing contributions to organizations involved in elections. On top of that, 72% say there should be limits on the amount of money individuals can spend on political campaigns, according to a 2023 Pew Research study.

Americans, Mainers, our constituents are desperate for reform. Concerns about political corruption and self-dealing degrade trust in our political systems. The Pew Research study revealed that 63% of Americans believe that elected officials run for office in order to make money. Additionally, 80% of U.S. adults believe that campaign donors have too much influence on congress, and 73% believe that lobbyists and special interest groups have too much influence. This means people feel voiceless. Despite these cries from the American people to fix our cherished institutions, incumbent and entrenched interests for

whom the current system works well continue to frustrate these commonsense reform efforts. We cannot wait for Congress to act. Without our demanding change, they will do nothing.

For a representative democracy to function properly, elected officials must be the voice of their constituents and voters require access to information that allows them to assess candidates for public office and to hold them accountable once elected. Our country's founders recognized the importance of this and wrote the First Amendment to enable we the people to participate in informed debates and scrutinize our Representatives and the election process that chooses them. This democratic promise is threatened when wealthy special interest groups, big donors, and powerful corporations with unlimited money exert their power on our political system.

I strongly urge you to vote against this pending motion because we need to improve transparency and trust in our elected officials and prevent corruption. Our founders created the opportunity for states to propose specific amendments to the U.S. Constitution through Article V Conventions. Article V allows the people of our country, through us, the State Legislatures, to propose amendments when Congress fails to act. Thanks to the founders, we have it within our power here in Maine, here today with this proposal, to stem the erosion of our democratic heritage. Please vote against the motion so that we can give the people a lifeline of hope for true reform.

Madam President, I request the yeas and nays.

On motion by Senator **BENNETT** of Oxford, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Stewart.

Senator **STEWART:** Thank you, Madam President, Ladies and Gentlemen of the Senate. I'm trying -- I apologize to you, I'm trying to pull up the actual text of what the resolution is asking for, because I think that's important.

I have reservations around Article V Conventions just generally speaking, but would want to know how narrowly tailored this particular request is. And I mean, I totally hear what the Senator from Oxford is saying. In fact, in Maine, you know, there's so much money and, in fact, I think it benefits Republicans more than Democrats to address campaign finance reform because you have almost every Democrat running for the State Legislature running Clean Elections and yet the PACs run by the leadership raise millions. I mean, doubling up Republicans or quadrupling up in some election years.

And so, I do think that an even playing field is very important. I do think that getting the money in an actual way, out of politics, makes sense because then the ideas actually have space for breath and, you know, when you're outspent four to one, it makes it really tough to, you know, penetrate any of those media markets and get the message out. So, I would want to know what the actual proposal is and beyond that, I'd like to know, too, whether it would apply to unions who give millions every year to my friends across the aisle on the Democrat side and would treat them the same way as a corporation for the purposes of political giving or not. I think these are all really important things that will weigh on my thought process here as I figure out how to vote on this motion. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Stewart.

Senator **STEWART:** Thank you, Madame Chair, I should've been more clear. I pose all of that as a question through the Chair and appreciate the latitude there. Thank you.

THE PRESIDENT: The pending question before the Senate is Acceptance of the Ought Not to Pass Report. A roll call has been ordered. Is the Senate ready for the question?

And while I'm describing my woman in history, if you want to find -- if Members want to find the To God be the Glory words, we're going to have an opportunity to do some singing in a minute, so be ready. Those are on your desk.

Fanny Crosby's life is a testament to unwavering faith and remarkable resilience. Here's a glimpse into her inspiring story. She was born on March 24, 1820, in Brewster, New York. She lost her sight as a little baby of only six weeks old due to a medical mishap where she had a slight eye infection and they treated it with hot mustard poultices which burned her corneas. Her early life, amazingly, was filled with learning and memorization, especially of the Bible. She attended the New York Institute of the Blind, where she excelled academically and developed her poetic talents.

Fanny Crosby became one of the most prolific hymn writers in history, penning over eight thousand hymns and gospel songs. Her hymns are known for their heartfelt expressions of faith, hope, and love. Some of her most popular hymns include Blessed Assurance, To God be the Glory, Safe in the Arms of Jesus, Pass Me Not, O Gentle Savior. Her hymns have touched the lives of millions nationwide and across the world.

Fanny Crosby dedicated her life to serving others, particularly the poor and the marginalized. She actively participated in rescue mission work in New York City, ministering to those in need. She had a heart for the lost and the destitute and she used her gifts to share the gospel and to offer comfort to others. Fanny was a person of unwavering faith. Despite her blindness, Fanny Crosby maintained a positive outlook and attributed her talent to divine inspiration. She lived a life of selfless service, prioritizing the needs of others. Today, her hymns continue to be sung in churches and homes around the world, inspiring generations of believers.

Fanny Crosby's life is a powerful reminder of even in the face of adversity, one can live a life of purpose, impact, and lasting influence. And as I said, on your desk, you'll find the words to one of her hymns, To God be the Glory, and due to my lack of singing abilities, Senator Moore has kindly agreed to lead us in the singing of this classic American hymn.

THE PRESIDENT: The Chair is pleased to recognize the Senator from Washington, Senator Moore.

Senator **MOORE**: The things I do for buddies, right? All right, everybody sing with me, I know you know this song.

To God be the glory, great things He hath done; so loved He the world that He gave us His son, who yielded His life our redemption to win, and opened the life gate that all may go in. Praise the Lord, praise the Lord, let the earth hear his voice! Praise the Lord, praise the Lord, let the people rejoice! O come to the Father, through Jesus the Son, and give him the glory, great things he hath done.

THE PRESIDENT: The Chair recognizes the Senator from Sagadahoc, Senator Tepler.

Senator **TEPLER**: Thank you, Madam President, and Fellow Colleagues of the Senate. I'm going to join in our tradition today of honoring Maine women for Women's History Month, and I'm rising with both a heavy heart and a spirit of deep gratitude to honor the legacy of Dr. Julia Gamble Kahrl, who those of us who knew her called Judy.

She was a cherished constituent, a trailblazing philanthropist, and a fearless advocate for women's reproductive rights. She was heir to the Procter & Gamble fortune, but she was never a lazy heiress. She was a long-time Arrowsic resident and Judy passed away in January of this year. Her tireless work in advancing women's rights and family planning not only transformed lives here in Maine but also around the world. Her remarkable journey began at 19 when she participated in the Planned Parenthood international conference in Stockholm, Sweden. After she graduated from college, she began serving on the board of her family's international NGO Pathfinder International. Her activism infused her work as she raised her own children and served on the boards of directors of their schools.

In 1995, Judy came to Midcoast Maine to retire, living for three decades in Bath and Arrowsic, where she became deeply connected to the Maine community, particularly supporting women's and men's access to full reproductive healthcare. She traveled many times to Peru, Kenya, Tanzania, and Rwanda to support the work of promoting safe motherhood, reproductive healthcare, environmental conservation, and healthcare education.

In 2010, the Peruvian government recognized her with the Daniel Alcides Carrion award for her work to reduce maternal mortality in Peru. She traveled to Tanzania where she helped Pathfinder International to pioneer work in the field of population health and environment. In 2013, Judy founded the Grandmothers for Reproductive Rights. And I wish I was wearing my yellow scarf and button today, but I'm not. She tirelessly lobbied in Washington and in Maine to work to protect women's reproductive freedoms, GRR. In 2022, the state recognized her by inducting Judy into the Maine Women's Hall of Fame.

Judy's journey serves as a powerful reminder of the strength inherent in every woman. As we celebrate the achievements of women throughout history, we honor Judy Kahrl's memory by dedicating ourselves to a future where every woman is free to

choose, to lead, and to thrive. Thank you.
