**STATE OF MAINE
PROCLAMATION**

WHEREAS, there exists in the State of Maine an extraordinary occasion arising out of the need to resolve many legislative matters pending at the time of the adjournment of the First Regular Session of the 132nd Legislature of the State of Maine; and

WHEREAS, the public health, safety and welfare requires that the Legislature resolve these pending matters as soon as possible, and in any event prior to the date of the Second Regular Session of the 132nd Legislature of the State of Maine, including but not limited to the state budget, pending legislation, pending nominations of state board and commission members, and

pending nominations of judicial officers by the Governor requiring legislative confirmation;

NOW, THEREFORE, I, JANET T. MILLS, Governor of the State of Maine, by virtue of the constitutional power vested in me as Governor pursuant to Article V, Part I, Section 13 of the Constitution of the State of Maine, do convene the Legislature of this State, and hereby request the Representatives and Senators to assemble at ten o'clock in the morning in their respective chambers at the Capitol in Augusta on Tuesday, March 25, 2025, in order to receive communications, resolve pending legislation carried over from the First Regular Session of the 132nd Legislature and act upon pending nominations and whatever other business may come before the Legislature.

WHEREAS, forty-one rangers, one forester and one entomologist from the Maine Forest Service participated in the 2024 mobilization season, as did staff from the Maine Land Use Planning Commission and other state agencies and 24 call-when-needed firefighters; and

WHEREAS, the Maine Forest Service sent these personnel and resources to other states to respond to wildfires and natural disasters, but because of our mutual aid agreements, Maine can rely on help from other states when natural disasters occur here; and

WHEREAS, while Maine forest rangers and Maine Forest Service staff, other state staff and the call-when-needed firefighters are highly trained, by mobilizing across the country, they gained invaluable additional training and experience that they can apply to the protection of Maine's natural resources; and

WHEREAS, wildfire suppression and emergency response missions are inherently dangerous, but through training, having reliable equipment, using proper personal protective equipment, conducting medical screenings and relying on peer support systems, the Maine Forest Service was successful operationally and in protecting all personnel both here and away in 2024; now, therefore, be it

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Bradstreet.

Senator **BRADSTREET:** Thank you, Madam President. I rise in opposition to the pending motion for a couple reasons here.

Ranked-choice voting was originally introduced with the understanding that it would decrease the rancor in our elections. I think we can all agree that that hasn't happened. It still remains very confusing for many voters. When they go to the voting booth, they see all this, and they're just first, second, third, or fourth choice, they are still confused. And that's something we don't want when people go to the polls.

I also want to point out that I have a problem when my -- when somebody has a third or fourth choice, even, that that counts just as much as my first choice. And we all ought to keep in mind, too, that a person choosing the least popular person on the ballot maybe shouldn't get another shot at it.

Thank you, Madam President.

THE PRESIDENT: The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT:** Thank you, Madam President. Request permission to pose a question through the Chair?

THE PRESIDENT: The Senator from Oxford, Senator Bennett, has requested permission to pose a question through the Chair. The Senator may proceed.

Senator **BENNETT:** I'm wondering if a Member of this Body could inform me or inform my recollection about how many times the people of Maine have approved ranked choice voting in public votes. Thank you, Madam President.

THE PRESIDENT: The Senator from Oxford, Senator Bennett, has posed a question to the Body to any Member who may wish to respond. Seeing none.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Hickman.

Senator **HICKMAN:** Thank you, Madam President. I rise to attempt to answer the question. At least twice the people have decided that ranked-choice voting is the way that we would like to elect people for our state and local offices. Thank you, Madam President.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Libby.

Senator **LIBBY:** Thank you, Madam President. Ranked-choice voting involves some strategy at the polls, and the strategy is complex. And I think the reason that ranked-choice voting should be an issue that the Legislature decides and not necessarily the people in a statewide vote is because it is that complex. When you go to the polls, you can vote for one candidate straight across, you can rank order your votes, and some people don't necessarily have the ability to determine what the outcome of that

might be, depending on the strategy. Most people obviously do. But the concern is that it's confusing.

So, I have to agree with the Senator from Kennebec -- the Senator from Kennebec that because of that confusion, it deserves our review, and it would be an excellent idea to reject the Majority Ought Not to Pass and accept an Ought to Pass at a later time.

Thank you, Madam President.

THE PRESIDENT: The Chair recognizes the Senator from Oxford, Senator Bennett.

Senator **BENNETT:** Thank you, Madam President, Fellow Members of the Senate. I have not supported ranked-choice voting, I think it's a solution in search of a problem, and it has not lived up to all of the promises that its advocates have suggested that it would.

However, I think that when the people tell us how they want the elections conducted, it's really not our business to second guess them and tell them we know better than they do. And so -- and I believe this to be the case not only on election matters, but particularly on election matters, anything that goes to the heart of deciding how power is distributed in this state, we should listen to the people first. And for the same reason, I have resisted any attempts, and there are lots of them in this Body over many, many years, to change the peoples' will on term limits and a host of other issues. So, I believe that if we're going to change ranked choice voting at this point, since the people have spoken multiple times in this issue, that we should let them do it and not us.

For that reason, I'll be voting for the Ought Not to Pass Report.

THE PRESIDENT: The Chair would recognize the Senator from Kennebec, Senator Cyrway.

Senator **CYRWAY:** Thank you, Madam President, Ladies and Gentlemen of the Senate. I was here during the debate on ranked-choice voting, and I will say that most of the Senators did not understand how it worked, and including both parties. So, if I even asked you right now, is it better to push -- to check off all five positions, Madam President, or is it better to check the one, two, and three and four vote or five, how does it work, you probably couldn't answer it. And that's what we found with talking to the Senate, and both sides were very confused. And so, we expect our population to understand this when our Senate couldn't even understand it. So, it really is very confusing, and I just feel that this should be vetted in a proper way.

So, thank you, Madam President.

THE PRESIDENT: The Chair recognizes the Senator from Androscoggin, Senator Bickford.

Senator **BICKFORD:** Thank you, Madam President. The Constitution says that it must be a plurality. So, where we get ranked-choice voting out of a plurality baffles me. I'd like to pose a question to anyone that can answer how a plurality equals a majority. Thank you.

THE PRESIDENT: The Senator from Androscoggin, Senator Bickford, has posed a question to the Body to any Member who may wish to respond. Going once. Going twice.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator Hickman.

Senator **HICKMAN:** Thank you, Madam President. I rise to attempt to answer the question from the Senator from Androscoggin. A majority is a super-plurality. Thank you, Madam President.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Libby.

Senator **LIBBY:** Thank you very much, Madam President. I rise for a second time to also remind the Members of this Chamber of the cost involved and the delay that is required to be able to process ranked-choice voting. In the last election, I remember seeing the day after the presidential election an Electoral College map on a local television station. And on that map, it was, you know, had completed results. And Maine stood alone with incomplete results.

So, I don't think that the voters were aware when they voted that it would take this much time to process ranked-choice votes, especially if there's a lot of different parties and unenrolled people on the ballot itself. And for that very reason, I -- and similar to my comments earlier, I would encourage the Body to vote against the pending motion. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Brenner.

Senator **BRENNER:** Thank you, Madam President. Good morning, and good morning, colleagues. I rise to recognize and celebrate the extraordinary life and legacy of Mabel Wadsworth, a true champion for reproductive healthcare, women's rights, and public health in Maine.

Mabel's story is one of courage, compassion, and unwavering commitment to justice. She was born in 1910 in Rochester, New Hampshire, and grew up at a time when women had only recently gained the right to vote. From an early age, she understood the challenges that women faced, not just in their homes and workplaces, but in something even more fundamental - access to healthcare and the right to make decisions about their own bodies. She pursued a career in nursing, earning her degree in public health from the University of Massachusetts at Amherst. From there, she embarked on a lifelong mission to improve women's health, advocating for education and services that were often overlooked or denied. Her work in Maine began in earnest in the 1960s when she became the state's first family planning nurse. She saw firsthand the struggles women faced, especially those in rural areas, who had nowhere to turn for birth control, sexual health information, or safe and supportive reproductive healthcare. But Mabel wasn't one to accept injustice. She knew that access to healthcare was not a privilege, but a fundamental right, and she made it her life's work to ensure that every woman, regardless of income, background, or circumstances, had control over her own reproductive health.

In 1984, at a time when reproductive rights were under attack across the country, Mabel founded the Mabel Wadsworth Center in Bangor. It was the first and remains the only private nonprofit health center in Maine dedicated entirely to reproductive and sexual health. This was more than just a clinic, it was a bold statement that women deserved care, compassion, and the right to make their own choices about their bodies. Her work was not always easy. She faced resistance from those who sought to limit access to contraception and abortion services, but Mabel was never deterred. She understood that knowledge is power, and she made it her mission to provide women with the information and resources they needed to make informed decisions.

Today, Mabel Wadsworth Center stands as a testament to her vision. Thousands of individuals - women and men alike - have received care there, benefitting from Mabel's belief that healthcare should be free from judgment, shame, and political interference. Mabel Wadsworth's legacy is not just in the institution that bears her name, but in the lives she touched, the policies she influenced, and the generations of women she empowered. She taught us that the fight for reproductive freedom is never over. It requires vigilance, courage, and a steadfast commitment to justice.

As we honor Mabel's life today, let us commit to carrying forward her work. Let us continue to fight for access to healthcare, for reproductive rights, and for the belief that every individual has the right to make their own choices about their

body and the future. Mabel once said women must have control over their own bodies, there is no equality without it. Let's never forget that truth.

Thank you, Madam President.

At this point a message was received from the House of Representatives, borne by Representative MOONEN of Portland, informing the Senate that a quorum of Representatives was assembled for the consideration of such business as may come before that Body.

THE PRESIDENT: Seeing no objection, so moved.

Senator **BAILEY:** Thank you. Men and Women of the Senate, today I am honored to rise and speak about my great aunt Hilda Brungot in recognition of Women's History Month.

For many years, my Aunt Hilda, or Tante Hilda, as we called her, held the record for longest female legislative service, not just in New Hampshire, but in the entire world. Now, don't worry, I don't plan on breaking that record any time soon.

Aunt Hilda was the first woman to follow her father into legislative service. In doing so, she served 19 terms in the New Hampshire State Legislature from 1931 to 1937 and from 1941 to 1975. In 1931, she was 44 years old and had six children. As she entered politics, she worked as a cook to help her family. And just as an aside, to remind folks that since 1889, New Hampshire has paid its 400 State Representatives and 24 State Senators an annual stipend of just \$100 a year. So, no wonder Aunt Hilda had to work as a cook while she was serving.

For the history buffs among us, that second span of service began with the Second World War and ended with the Vietnam War. It goes without saying that she served during decades of change, conflict, and turmoil. Tante Hilda was born in 1886 and lived until 1982. During her time as a legislator, Tante Hilda served 14 terms on the House Judiciary Committee, and giving my service on that same committee here in the Maine Legislature just goes to prove that old adage about an apple not falling far from its tree. I like to think that maybe it's in our family DNA. She had a reputation in the Legislature as being peppery and argumentative - that doesn't describe me at all - but also the Member who regularly made the motion to allow Members to remove their suit coats in the summer heat, joking that improving the comfort of her male colleagues also improved their dispositions and they were more likely to vote with her. And I'm wondering if the Good Senator from Washington has the same thoughts about making her motion regularly.

In addition to this legislative service, Aunt Hilda served in five Constitutional Conventions held in that same time period, which is another record for women. When she was finally defeated in 1974, at age 88, being the oldest female legislator and working towards her equivalency of a high school diploma in her 80s, a drive began for a portrait of Aunt Hilda to be installed at the New Hampshire State House. A statewide campaign raised the funds to create this portrait, and in 1978, she was present for the unveiling of the portrait, located right outside the New Hampshire State Senate Chamber. And you all received a copy of the portrait on your desk this morning. At the time, Aunt Hilda was the only woman legislator so honored. At the time of her last

campaign, on July 17, 1974, U.S. Congressman from New Hampshire James C. Cleveland read into the congressional record the following tribute to Aunt Hilda, and I'd like to now read it into the record here in Maine.

Mr. Speaker, as some of my colleagues in the House may know, the General Court of the State of New Hampshire is the third-largest English-speaking Representative body in the world. Within this distinguished body of public servants are some truly remarkable and nearly legendary figures. One such person is Mrs. Hilda Brungot of Berlin, New Hampshire. Mrs. Brungot is 87 years young and is running for her 20th term as a state legislator. During each of her 19 terms as a Representative, she has served her constituents and her state with distinction. During these times when the public's confidence in their national political leaders and institution has reached a new low, Mrs. Brungot should serve as an inspiration to all public officials. Her sincerity, judgment, and compassion as a Representative are exemplary. I commend to my colleagues the following article from the front page of the Boston Globe on July 10, 1974, by James Stark, Dateline, Berlin, New Hampshire. Hilda Constance Fredericka Brungot, Grand Dame of the New Hampshire General Court, had to interrupt her campaign for reelection the other day. It was really too bad because Mrs. Brungot, 87, running for her 20th term in the Legislature and facing the strongest opposition of her career, needs all the campaign time she can get. Still, she brought her telephone solicitation and voters to a standstill to deal with a crisis involving a secondhand power lawn mower she bought last year. The venerable machine came to grief when the boys who cut the grass around her home on Main Street ran out of gas and refilled the fuel tank with turpentine by mistake. So, I went out to an auction and picked up an old-fashioned hand mower that runs on elbow grease, she said, no way to pour turpentine into that one. It cost her all of \$2. Thrift has always been the name of the game with me, whether I'm spending my own or the public's money, said the peppery great-grandmother, it's something I learned the hard way by working as a cook to bring up ten children - six of my own, and four state wards. So, I know the value of money. Maybe that's how I've managed to get sent down to Legislature for so long, she said. This will be my 20th term if I'm lucky enough to make it. To tell you the truth, I'm running scared.

Mrs. Brungot's political beginning was back in 1930 when she served as a delegate to a Constitutional Convention at the age of 44. According to Leon W. Anderson, the political columnist for the Concord Monitor, Mrs. Brungot's length of service as a lawmaker is unequalled in the state's history. It's not how long you serve, argues Hilda, who prefers the informality of the first name exchange, it's what you do while you're there. As you know from my record, I'm a hellion against new or increased taxes because I had to work until I was 75 and I know the working man's problems. But I'm not there just because I'm a no-tax advocate, she said. I've been on the Judiciary Committee, one of the most important of them all, for 14 terms. For the first time, I've got opposition on all sides, she said. The Democrats used to leave a place on the slate open so that all of my Democratic friends could write me in, and I'd get both nominations. Now, I've got two Republican opponents in the primary and, if I should win, one of three Democrats to face. This could be my last hoorah, Mrs. Brungot said, but I hope it won't be. I want to go back to Concord because I feel I have a lot of experience to offer the younger ones. Has Watergate affected her reelection? No, she said, the State Representative contests in New Hampshire are beyond the touching of things like Watergate. Every voter is

practically a neighbor. There are so many of us, they vote on personalities, not big issues. I think all the opposition I'm getting is probably because they think it's about time I quit. But now that I filed, I'm going to fight, and I'm good at that. Mrs. Brungot agrees with the late General Douglas MacArthur who said age was not a time of life but a state of mind. That was a nice way of saying you're as young as you feel. Except for a touch of arthritis, I've never felt better or sharper in my whole life. Mrs. Brungot, a product of sturdy Scandinavian stock, her father, Hans Christian Johanson, a native of Oslo, Norway, preceded her in the Legislature, believes firmly that determination, not age, is the key to achievement. I got my high school diploma when I was 80, she said, not because I needed it, but because I wanted to prove I could get it. I just didn't have time before.

Hilda Brungot has no patience for those who constantly push for reduction of the size of the New Hampshire Legislature, said to be the third largest in the English-speaking world. The special interests and selfish lobbyists can sometimes fool 400 legislators, or a majority of them, but they can never buy them, she said. She said the size of the New Hampshire legislature permits representation of all levels of society and all spheres of life in the state. Other places you want to see your legislator, you ask for an appointment and don't always get it, she said. Here in New Hampshire, you knock on his door and when he opens it, you tell him what you think and he has to listen.

Of course, I knew Tante Hilda as a looming and intimidating figure in our family. Hers was the house where you visited in your best clothes and you washed up beforehand. You sat up straight and you said please and thank you, and I never dared to touch anything for fear I would break something. But she would also sit with me over tea and Norwegian pastries and discuss politics. She encouraged me to speak my mind and was proud when I wrote letters to the editor, even though she did not necessarily agree with the views I expressed. Behind the outward gruff formality, she was also kind and caring and you knew that she would give you the shirt off her back if you needed it.

THE PRESIDENT: The Chair recognizes the Senator from Washington, Senator Moore.

Senator **MOORE:** Thank you, Madam President. Continuing on with the Women's History Month, I thought it most appropriate since we watched the astronauts return from the space center last week to talk a little bit about Christa McAuliffe.

In 1986, Christa stepped from the classroom into history. As part of a radical new approach by NASA, she was to be the first civilian in space. While her mission on the shuttle ended tragically, her mission as a teacher continues. By 1984, space shuttle flights had become ordinary occurrences to many Americans. NASA wanted to rekindle the excitement that had once surrounded the space program. They thought that if an ordinary citizen were involved, a good talker who could communicate the excitement of travel in space, the public might once again become enthusiastic. Taking this into consideration, President Reagan made the decision that the first ordinary American to travel onboard a space shuttle would be one of America's finest, a teacher. After all, good teachers have the ability to get people interested and excited.

NASA's media coordinator said we're not looking for Superman, we're looking for the person who can do the best job of describing his/her experiences on the shuttle to the most

people on earth. The search finally led to Christa McAuliffe, a social studies teacher from Concord High School in Concord, New Hampshire. Her students considered her an inspirational human being, a marvelous teacher who made their lessons come alive. Often called the field trip teacher, Christa believed it was the hands-on experience that made the most valuable teaching tool. In fact, she called her impending trip on the Challenger the ultimate field trip.

Sharon Christa McAuliffe, the eldest of Edward and Grace Corrigan's five children, was born on September 2, 1948, in Framingham, Massachusetts. While in high school, Christa met Steve McAuliffe, and then she attended Framingham State College, majored in history, and received her degree in 1970. That year, she and Steve were married. Soon after, they moved to Washington DC where Steve attended law school. Christa taught school until the birth of her first child, Scott, then she attended Bowie State College and earned a master's degree in school administration in 1978. Shortly thereafter, Steve, Christa, and Scott moved to Concord, New Hampshire, and Christa's second child, Caroline, was born.

The McAuliffes settled into an old three-story house, Steve began his law practice, and Christa stayed home with the children. Her love of teaching soon led her back to the classroom. First, Christa taught at Bow Memorial School and then moved to Concord High School. She was also actively involved in the community, church, a tennis club, the local playhouse, the YMCA, and the Concord Hospital. In addition, she was a Girl Scout leader, a jogger, and a swimmer.

When the opportunity came to apply to be the first teacher in space, everyone who knew Christa told her to go for it. She completed the 11-page application, mailed it at the last minute, and hoped for the best. After becoming a finalist, Christa did not think she would be chosen. Some of the other teachers were doctors and authors and scholars, she was just an ordinary person. However, she was chosen out of 11,500 applicants. An ordinary person to whom ordinary people could relate doing the extraordinary. Christa's presence in the space program helped boost public interest and curiosity, and through her participation, she became an inspiration to the teaching profession as well. She felt her exposure as the teacher in space reflected well on all teachers. Regarding the space program, she said, a lot of people thought it was over when we reached the moon, they put space on the backburner. But people have a connection with teachers. Now that a teacher has been selected, they have been starting to watch the launches again.

Christa began her training at NASA's facility in Houston in September of 1985. At first, she was worried that the other astronauts might think she was just along for the ride. She wanted to prove she could work just as hard as they could. But when they met, the other members of the crew treated her as part of the team. Christa trained with them for 114 hours, and when launch time came, she was ready.

Just 73 seconds after liftoff, the Space Shuttle Challenger exploded, killing all seven of the astronauts aboard. While aboard the shuttle, Christa was to have taught two lessons from space. In one, she would've introduced each flight member, explained their roles, shown the cockpit with its 1300 switches and dials, and explain how crew members ate, slept, and exercised in microgravity. Her second lesson would've explained how the shuttle flew, discussed why people explore space, and report on technology advances created by the space program. Throughout her voyage, she was to have kept a journal, inspired by the

journals of the pioneer women who left their homes in search of a new frontier. Christa said that's our new frontier out there, and it's everybody's business to know about space.

Grace Corrigan, Christa's mother, said in her book, A Journal for Christa; Christa lived, she never just sat back and existed. Christa always accomplished everything that she was capable of accomplishing, she extended her own limitations. She cared about her fellow human beings. She did the ordinary, but she did it well and unfailingly.

On January 28, 1986, her mission in space ended in tragedy, as we know. However, her mission continues to speak to us today. Christa's motto was I touch the future, I teach. And she's teaching us still. Her mission continues there with the Christa McAuliffe Planetarium which was erected in her memory. The idea for a planetarium was suggested by Lois Wiley, a teacher from Northwood, New Hampshire, and was chosen from among other ideas because it combined her dream of traveling through space with her dedication to teaching. In April 1988, the New Hampshire Legislature appropriated funds to build a planetarium and groundbreaking took place on October 26, 1988.

Construction was completed in a little more than a year, and on June 21, 1990, the planetarium began its mission to educate, incite, and entertain learners of all ages in the science and humanities by actively engaging them in the exploration of astronomy and space science. Since then, nearly 30,000 school children a year and thousands of others have passed through the doors to participate in the ultimate field trip.
