Senator HASKELL: Thank you very much, Mr. President. Colleagues of the Senate, it's a delight for me to be here today to talk about one of Portland's treasures: its Museum of Art. For any of you who've been there, you know that the Portland Museum of Art is not one of those dusty places where you wander the halls, coughing, looking at old pictures. It is not that at all. It is a vibrant, changing, engaging, and exciting place to be, to see the work that they bring in, and to see their engagement in the community. Today, when I'm recognizing on their behalf, and it's such a pleasure to be able to do it, it's two new grants which have been awarded to the Portland Museum of Art from the Maine Arts Commission at one of the Maine Arts Commission's first partnership grants. This grant supports a lot of the work that the Museum does, but of particular interest is the Free Fridays Program. It's exactly what it says. The Museum's doors open. You do not have to pay to come in on that Free Friday. It's an

extraordinary program and it has served over more than 35,000 visitors annually every year since 1996. It's about a quarter of the Museum's yearly attendance that occurs on those Free Fridays. This also provides a lot of coordination between the Maine Arts and Cultural organizations and it really helps in their engagement throughout the state. The second grant was the Maine Humanities Counsel. Again, this is grant that's going to support a summer exhibition called "Director's Cut, Selections from the Maine Art Museum Trail." If you aren't aware of what that is, it is now being re-launched and its highlights of its most renowned museums: the Portland Museum of Art, the Ogunquit Museum of American Art, Monhegan Museum of Art and History, the Bowdoin College Museum of Art, the University of Maine Museum of Art, Bates College Museum of Art, Colby College Museum of Art, and the Farnsworth Art Museum. This is extraordinary work that's being done by this organization in the city of Portland with, as you can see, a far broader reach and a vibrant and important part of our community and I'm excited to be able to present this to them today, Mr. President. Thank you.
