**JOINT RESOLUTION
RECOGNIZING THE JUSTICE ACTION GROUP'S
ACCESS TO JUSTICE DAY**

WHEREAS, the Justice Action Group is a coalition established in 1995 to provide leadership and coordination in planning for the provision of civil legal aid to low-income and elderly Mainers; and

WHEREAS, equal access to justice is a bedrock principle of a free, constitutional society and no system of laws and constitutional protections can be credible or effective if only those who can afford a private lawyer may avail themselves of it; and

WHEREAS, providing equal access to justice has tangible, widespread benefits for Maine's families, children, schools, communities, businesses, charities and government, and the availability of legal aid has been shown to be effective in reducing the incidence of domestic violence by ensuring that victims receive court protection orders; and

WHEREAS, Maine's employers benefit when employees who receive legal assistance miss less work and are less distracted by unresolved legal issues; and

WHEREAS, legal issues profoundly affect basic human needs such as shelter, sustenance, safety from violence, health and child protection; and

WHEREAS, in the current economic downturn, the need for legal aid and pro bono representation in Maine remains acute; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-sixth Legislature now assembled in the Second Regular Session, on behalf of the people we represent, pause to acknowledge and express our appreciation and strong support for Maine's legal aid provider organizations and Maine's private practice attorneys who provide pro bono service for those otherwise unable to afford legal representation on the Justice Action Group's 2014 Access to Justice Day; and be it further

Senator **KATZ:** Thank you Mr. President. Men and women of the Senate, I just wanted to add my voice to this. I certainly thank the Justice Action Group for being here today and hope that everyone will take advantage of the opportunity to visit them downstairs on the second floor. I also wanted to welcome Justice Mead and Justice Levy, who are here with us today. As I mentioned in caucus, 20 years ago you probably wouldn't even see judges in the State House. Their place was up on the bench, apart from the rest of society. They were there just to judge cases. I think that's changed over the years and much for the better. The fact is that the judges are here today and that they are making themselves available to speak with each of us. In general, judges are making themselves more available, exhibit A being the Law Court holding sessions in many of our high schools and other schools around the state on the theory that the more we understand how our court system works the more confidence we'll have in that system. I'd also like to just give a shout out to my profession, who practice law in the state of Maine. You just heard a little bit about pro bono work that attorneys do. I'm proud to say that Maine attorneys either lead the nation, or are very close to it, in the number of average pro bono hours that they devote to doing work for those who can't afford it. With the combination of these many fine organizations and the good work that pro bono attorneys are doing, we're at least making a dent in the fact that many people just cannot afford access to justice. Thank you, Mr. President.

Senator **CRAVEN:** Thank you Mr. President. Men and women of the Senate, this bill establishes a new formula for non-tribal Head Starts. Tribes are reimbursed in a different formula. This provides an additional \$2 million in funding for state fiscal year 2014-2015. The funding is to be used for services for pregnant women and children to age 5. The funding will enable the state to draw down an additional \$3 million for childcare development block grant funding. All of the funding will be used to provide Head Start vouchers for childcare services. Both Head Start and access to quality childcare for working parents are critical to helping families with low incomes improve their lives. At a time when every four out of five kids are growing up in poverty, we have to find a solution. Since 2012 funding for Head Start and childcare services has been reduced in the following ways; the Maine General Fund Head Start funding was cut by \$2 million a year, federal Head Start funding was cut by \$1.6 million due to sequestration, and the state childcare development funds match from the Fund for a Healthy Maine was cut by \$1.9 million a year.

This is a net loss of \$5 million a year for Maine's programs. The market rate paid to providers for childcare vouchers under the CCDF, which is the Childcare Development Fund, was dropped from the 75th percentile to the 50th percentile. The quality childcare incentive paid to tier four programs was reduced from 25% to 10%. We know for sure that early childhood education is an investment we cannot neglect. The payback is undeniable. I thank you and please vote today in support of early Head Start and early childhood education. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Oxford, Senator Hamper.

Senator **HAMPER:** Thank you Mr. President. Ladies and gentlemen of the Senate, I'll remind you at this time that the federal government does supply Maine's Head Start Program with \$32 million and that Congress passed the Consolidated Appropriations Act of 2014, of which they're increasing funding to Head Start nationwide at 1.025. That would be \$1,025 million extra towards Head Start this year. Is this the right use of scarce state resources? Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Millett.

Senator **MILLETT:** Thank you Mr. President. Men and women of the Senate, I rise to ask for your support of L.D. 1682. Many of us do agree that Head Start plays a valuable role in our communities. We have heard from our law enforcement community, businesses, and the military about their strong support for comprehensive early childhood programs. Research shows that it has a positive lasting impact on our children and their families. It is a resource available to all children from families with incomes at or below the federal poverty line. It provides services for more than 3,000 vulnerable children. There are many methods by which Head Start can be measured a success, including improvements in a child's readiness for school, later academic success, and health. It's a vital program that needs our support. While general funding for Head Start in fiscal year 2014 is strong, without further action funding for Head Start in fiscal year 2015 will drop from \$1.3 million to \$440,000. For me, this should not happen. L.D. 1682 is a continuation of previous legislative efforts to strengthen Head Start and other educational opportunities in Maine. It would provide \$2 million for Head Start services to children in poverty and their parents, establish a funding formula for distribution of those funds, and draw down \$3 million in federal childcare development fund monies to provide childcare vouchers to low income families. While budgets are tight and tough choices must be made, we cannot stop investing in our children. Head Start is too important of a resource. Our kids, our future, are too important. Thank you.

Senator **HASKELL** of Cumberland moved the Senate **ACCEPT** the Minority **OUGHT TO PASS AS AMENDED** Report.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Haskell.

Senator **HASKELL:** Thank you very much Mr. President. This matter came before our committee and I came to understand that we provide tax incentives, advantages, for a variety of reasons. Those reasons are to help support our businesses, to help engage our economy, and to help grow those businesses that are working so hard to make our communities vibrant. We have an opportunity with this bill to provide another tax incentive for those folks who are logging off their property if they will simply take those logs to a U.S. mill. This does not require them to do it. It is completely optional. They can do it if they want to. If they do that they will get an additional tax benefit. I think that's appropriate. I think that's the right way to do tax policy, when we incent activity that works for us and that works for our Maine companies. I urge you to follow my light on this bill. Thank you.

On motion by Senator **KATZ** of Kennebec, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

THE PRESIDENT: The Chair recognizes the Senator from Somerset, Senator Thomas.

Senator **THOMAS:** Thank you Mr. President. Ladies and gentlemen of the Senate, there is nothing more in this world I'd rather have than a brand new shiny green log truck. It needs to have a bright yellow log loader, brand new of course. I promise you that for a quarter of a million dollars I can get it done. The problem is that I can't afford it. This bill is almost as good an idea as my new log truck. The problem is that we can't afford it either. Let me explain. I own a little bit of woodland. If this bill becomes law, there is no reason in the world I would ever have to pay property taxes on it ever again because I would cut enough wood off it and that wood would go to an American mill, it would go to my firewood mill by the way. That wood would go to an American mill and that would mean that I'd pay no tax. No taxes at all. Can you imagine some of the wealthiest corporations in the United States that would send their wood to an American mill and never pay property taxes again. Where does that money come from? Who replaces that money? Do we ask working people in Maine to replace that money? If it's in the Unorganized it's going to come from the General Fund. It's going to come from the state budget. If it's in the organized towns it comes from our schools, our counties, our roads in those towns. We'll just have to go up on the rest of the property tax. If you think the revenue sharing cuts were bad and awful, wait until we pass this. We'll have even more fun. It might send a few logs to American mills, but I'd just wait until I had a whole bunch of logs that would go to Canada and I could get a better price and that one year I'd pay the property taxes. I'd cut the wood. I'd send them to Canada or wherever I wanted to send them and that would be the end of it. Next year I'd be right back to only cutting wood to go to Maine mills. It's a great idea. I'm going to vote against it, but I hope we pass it because if we do I'll never pay property taxes again. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Jackson.

Senator **JACKSON:** Thank you Mr. President. Ladies and gentlemen of the Senate, I actually support the pending motion, Ought to Pass as Amended. This whole idea of property taxes for putting money into U.S. mills I think has actually already been debated numerous times, way before any of us probably ever arrived here. It was through what we know now as the Tree Growth Program, which certainly part of the intent was to make sure that that land stayed in tree growth production so that the mills in this state would have a supply of fiber to go to those mills so that we could have manufacturing in the state, so we'd have good jobs in the state, and Maine would continue on with what it's been known for, being a high quality manufacturing state in the paper industry. That's what the intent of the original bill was. Like many things, even though the intent was there, sometimes people use it differently. They go around and try and make it into something that it hasn't been. In my opinion, this law now is property tax adjustments for people even though that fiber doesn't go to any Maine mills. We see it all the time. People are sending wood out of this country. Sometimes U.S. people don't cut it, don't truck it. It goes to a Canadian mill with no benefit at all to the people in this state, but we're supposed to actually pay the property tax on it. I don't believe that's how the law was originally intended, even though I've tried to, in my opinion, correct that. This bill was a complete 180 from past bills that I tried to introduce. It was an idea that when I took it into the Revisor's Office the Revisor actually said, without any prompting, "This sounds like Tree Growth on steroids." I said that it was probably exactly what it is because the whole idea of Tree Growth, and the way it is currently, would completely stay that way. It wouldn't be changed. If you want to send your wood to Canada, go head. We're still going to give you a property tax break, which I don't understand. It doesn't change. All this does is says that if you want to send your wood to a U.S. mill we won't charge you any property taxes. Currently, under the Tree Growth law, the very little amount of money that landowners are paying under Tree Growth now is so small that it doesn't even make sense. I'm sure Senator Thomas would like to get his green truck. He can do that right now under our current Tree Growth laws. You're going to get a tremendous benefit. I think you said before that you don't get it. You don't want the government telling you how to run your land. Well, this bill's not going to change that, but if you want your new green truck you can get that right now under current Tree Growth. All this does is a 10% that landowners are now paying for their tree growth they won't have to pay even that 10%. It would be 100% deducted instead of 90% deducted. The 10% would be the part that these landowners are saying, "Well, we're too far from U.S. mills. We can't get our wood to U.S. mills effectively." You'd better use that 10% to see if it made sense for you to actually transport the wood to a U.S. mill. If you don't want to, continue flooding the Canadian market I don't care. That's going to stay the way it always has been. You talk about mills that are having a hard time here in the state, we're going to have a bill that many of us in this room have actually sponsored for Millinocket. Cate Street Mill is down. Lincoln is half way what they used to be. New Page and Verso struggling. We have serious challenges in this state with our paper manufacturing mills. This is a small, small attempt to try and help them be able to compete with our Canadian counterparts who don't have energy costs like we do, don't have to pay health insurance like we do. I believe that, while this is small, it's something that we could actually do to try and help them. If you don't believe me, I believe there are actually representatives here from Cate Street

that could tell you that they would like to see this. Whenever they talk about what actually are their problems, the first thing they list is energy costs, which is a bill we obviously had come up. The second thing they list is fiber costs. This would be a way to at least get after the fiber costs. If you're in favor of Maine manufacturing and Maine people I certainly believe that you should be voting for this bill because there's no other way that you can cut this. This is going to help, to some extent, Maine manufacturing and Maine people in this bill. I encourage you to vote in support of it.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Cushing.

Senator **CUSHING:** Thank you Mr. President. Ladies and gentlemen of the Senate, I rise today in opposition to the pending motion. I want to, in full disclosure, indicate that our family has had six generations that we've owned land that would probably benefit from this plan because we now, as I understand it, sell wood to mills in the state of Maine. I also operate yards where we acquire logs from the saw mills. I have tried very diligently to provide quality wood to Maine people who provide Maine jobs. I do commend the good Senator for bringing this forward. I've discussed other proposals that have come forward at his urging regarding the forests products industries. I think this is a novel and positive approach to offer incentives. I commend him for that. This is the Minority Report of the committee for a reason. We have to make decisions here based upon what is effective and good for the citizens of Maine. The difficulty that many of these mills that were mentioned face is not in the acquisition of fiber. Maine has a tremendous wood basket. It's the compilation of other circumstances resulting from policies that do not assist the mill owners that have caused some of these challenges. The landowners, the people who own the property, have changed dramatically due to the environmental concerns. The essence of where you send that fiber still remains a logistical challenge when you're in the northwest portion of the state where the roads lead west to Canada rather than east and south. I think we need to recognize that. While I do commend the Senator for trying to, at this particular point in time, incentivize things for Maine landowners, I, like the good Senator from Somerset, cannot support something that does not benefit all of the citizens of Maine. Thank you, Mr. President.

THE PRESIDENT: The Chair recognizes the Senator from Oxford, Senator Patrick.

Senator **PATRICK:** Thank you Mr. President. Ladies and gentlemen of the Senate, colleagues and friends, I rise today in support of the motion. I think it's a great attempt to try to make our own mills in Maine, and in America, more attractive. Too often we look at doing different things like having tax exemptions, tax breaks, Pine Tree Zones, ways to benefit our businesses, but, from the respect of where our farming, fishing, tourism, and wood industries are going, this, I think, is a good simple attempt at making a positive impact. One of the things with the wood industry is that we have to find different ways to entice finish products, which are value added. If we ship our raw products to other nations and they can ship them back, jobs aren't staying here in Maine. One of the most important things for me is to try to maintain the forest industry. I do work in the forest industry. I work in a paper mill. I do think the cost of fiber is important. I

think this is one way that we can possibly take a look at lowering that cost. I would ask that the members consider voting Ought to Pass. Thank you.

THE PRESIDENT: The pending question before the Senate is the motion by the Senator from Cumberland, Senator Haskell to Accept the Minority Ought to Pass as Amended Report. A Roll Call has been ordered. Is the Senate ready for the question?
