media, particularly Facebook. I would like to stand here in front of  
you today and apologize for these remarks and those posts.  
While it is no surprise to most that I am not President Obama's  
biggest fan, I do have to admit in full disclosure as a former  
Democrat, I did vote for him in 2008. I have been profoundly  
disappointed by his policies and performance over the years, and  
that frustration led me, against my better judgment, to make

several criticisms of the President that were completely  
inappropriate. I think many of us can identify with the temptation

against those with whom we disagree. As a State Legislator I am  
held to a higher standard. We all are. We need to show restraint,  
especially myself in this instance. I would like to publicly
