# JOINT RESOLUTION RECOGNIZING ACCESS TO JUSTICE DAY PRESENTED BY MAINE'S JUSTICE ACTION GROUP

WHEREAS, 2015 marks the 20th anniversary of Maine's Justice Action Group, a judge-led coalition of leaders from Maine's legal community who are passionate about helping all Maine people have access to civil justice; and

WHEREAS, the coalition members include representatives of the state and federal judiciary, the Legislature, nonprofit civil legal aid providers, the University of Maine School of Law, the Maine Bar Foundation, the Maine State Bar Association, the Maine Trial Lawyers Association, private practice attorneys and others; and

WHEREAS, key initiator Judge Frank Coffin described the Justice Action Group as a catalyst, something introduced in small quantities that produces great change, and the Justice Action Group has been an advocate for equal access to justice since 1995; and

WHEREAS, equal access to justice is a bedrock principle of a free, constitutional society, but no system of laws and constitutional protections can be effective if only those who can afford a private practice attorney have access to justice; and

WHEREAS, providing equal access to justice has tangible, widespread benefits for Maine's families, children, schools, communities, businesses, charities and government; and

WHEREAS, legal issues profoundly affect basic human needs such as shelter, sustenance, safety from violence, health and child protection; and

WHEREAS, the need for civil legal aid and pro bono representation for low-income and vulnerable Maine people remains acute: now. therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-seventh Legislature now assembled in the First Regular Session, on behalf of the people we represent, pause on this 2015 Access to Justice Day to acknowledge and express our appreciation and strong support for Maine's civil legal aid providers and private practice attorneys who provide pro bono services for those otherwise unable to afford legal representation; and be it further

RESOLVED: That a suitable copy of this resolution, duly authenticated by the Secretary of State, be transmitted to the Justice Action Group.

# JOINT RESOLUTION COMMENDING THE EFFORTS OF THE PARTIES TO ADVANCE CHANGES IN PRIMARY CARE PAYMENT TO PROMOTE BETTER PRIMARY CARE FOR ALL MAINE

WHEREAS, it is recognized that primary care providers in this country serve as a critical component of the health care system and a fundamental element in efforts to promote health care delivery and payment reform; and

WHEREAS, at the same time, there is widespread agreement that payment for primary care services has not kept pace with payment for other specialties, and that current fee-for-service payment systems undervalue the benefits of primary care services; and

WHEREAS, prominent physician organizations, including the American College of Physicians, American Academy of Family Physicians and American Academy of Pediatrics and the Maine affiliates of these national organizations, together with the Maine Medical Association, Maine Osteopathic Association, Maine Primary Care Association, Maine Association of Nurse Practitioners and Maine Association of Physician Assistants, recognize that patient care can be improved through a patient-centered practice model called the patient-centered medical home, or PCMH, model; and

WHEREAS, the medical home concept has been adopted by key stakeholders in Maine and is grounded in a set of patient-centered, physician-guided principles that promote an ongoing relationship between a patient and a health care provider trained to provide first contact, continuous and comprehensive care and who leads a team of individuals at the practice level who collectively take responsibility for the ongoing care of patients, including care for all stages of life, acute care, chronic care, preventive services and end-of-life care and coordination of care across settings, and promotes enhanced access to care through systems such as open scheduling, expanded hours and new options for communication between patients and their primary health care team: and

WHEREAS, the Maine Quality Forum, Maine Quality Counts, Maine Health Management Coalition and MaineCare convened the multi-payer Maine PCMH Pilot, which was launched in 2009 and expanded in 2012 to include additional practices and to bring in Medicare as a payer through the federal Department of Health and Human Services, Centers for Medicare and Medicaid Services Multi-payer Advanced Primary Care Practice, MAPCP, demonstration, now involving 75 primary care practices and 10 Community Care Teams from across the State; and

WHEREAS, MaineCare has developed its Health Homes initiative, which includes over 200 primary care practices, in alignment with PCMH principles; and

WHEREAS, those 200 primary care practices have now committed to implementing the PCMH model to improve care for their patients; and

WHEREAS, primary care providers involved in these efforts have committed hundreds of hours to implementing the PCMH model with the goals of improving patient experience of care,

improving the quality of health care and health for their patients and controlling health care costs; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-seventh Legislature now assembled in the First Regular Session, on behalf of the people we represent, take this opportunity to recognize the dedication, commitment and efforts of the 200 or more primary care practices involved in the Maine PCMH Pilot, MAPCP demonstration and MaineCare Health Homes initiative and commend these providers for implementing the PCMH model as a means to improve the health care of all Maine citizens; and be it further

RESOLVED: That the State continue its efforts to promote improvements in primary care delivery and payment and commit to identifying additional multi-payer models for primary care payment that move beyond current fee-for-service payment models and expand the PCMH Pilot to better support and provide the necessary resources for all primary care providers in the State to implement the principle of patient-centered, high-value care.

WHEREAS, the Legislature has learned with deep regret of the death of:

Richard John McGee, of Fairfield, a longtime football coach and prominent local citizen. Mr. McGee was born in Providence. Rhode Island. His father, Joe, was the coach of the Providence Steamrollers, a professional football team in the 1930s and 40s. Mr. McGee would travel with his father all around New England, beginning his lifelong love of football. He played for La Salle Academy in Rhode Island, graduating in 1948, and went on to play for the University of Maine. He and his wife, Shirley Harriet Marcia, settled in Fairfield in 1957, where he taught and coached at Lawrence High School. He helped to create the Fairfield Police Athletic League, or P.A.L. program, a recreation program for children, which continues to operate, and served as its director for 54 years, from 1959 to 2013. In 2000 the Town of Fairfield named its new athletic fields the Richard McGee Athletic Complex in recognition of his dedication to the youth of the area. In 1967 he was named head coach of the football team at Colby College. the Mules. He became the college's athletic director in 1974 and became assistant football coach in 1985. He received many awards for his coaching and contributions to the community, including being named Maine High School Coach of the Year and New England College Coach of the year. Ladies and gentlemen of the Senate, I rise before you today to remember Coach Richard John McGee, an influential member of the Fairfield community and our entire region. Coach McGee is a legendary coach in our community, coaching at Lawrence High School and then at Colby College. When Coach McGee began his career he inherited a Lawrence High School team that had a 1 and 26 record the season before. In his first year the Bulldogs. his team, went and won 28 and 1 that season. That impressive turnaround highlights Coach McGee's ability to lead and inspire a team. Later he was an instrumental leader in the Fairfield Police's Athletic League, or PAL Program. He served as the recreation program's Director for 54 years and influenced countless lives while doing so. The program, which is still successfully operating today and serving students from Albion, Benton, Clinton, and Fairfield, honored Coach McGee by naming their athletic fields the Richard McGee Athletic Fields. Richard

McGee was a coach, a mentor, and a philanthropist, but above all a loving father, grandfather, and great-grandfather. He was beloved by all those who played for him and those who had the opportunity to get to know him. He had many qualities. One, he had the language of what he devoted his life to. Two, he has discipline. He had the way to mediate situations. He was giving. He also had the skill of the art of sports. He also had leadership. He had spiritual principles. Last of all, he was loving. I call this Coach McGee as one of life's pieces of masterpieces. His son, Mike McGee, and his family members are here today to accept this memoriam. Mike McGee followed his father's footsteps and became a coach as well, coaching at Lawrence for 31 years. I am honored to present this to his family and to acknowledge our gratitude for their public service to our children and young adults of the state of Maine. Thank you, Mr. President.

Senator GRATWICK: Thank you, Mr. President. Ladies and gentlemen of the Senate, I rise to speak in some perplexity of this Joint Resolution recognizing February 2015 as Self-Care Month. Three basic questions. We got this in March. It was nonetheless recognized in February, so it seems to be an unusually precedent. It was not very well vetted. I think we should have a standard doing better. Second, you may or may not recognize or remember all the specifics, but this is basically a commercial, somewhat direct, somewhat crass commercial or plug. I fully admit that over-the-counter medications are important. I think they have their role. On the other hand, this declaration, this Joint Resolution, as written, is very worse in the terms of the language because it's wholly auditory and really does not have any cautions in it. It makes a number of claims which I think are not appropriate and which we should be very wary about approving as a Body. Third, there are a number of significant medical problems with over-the-counter medications that I think we should all be aware of, particularly the young folks here in the front of our well here. All of us have to know that there are medications. over-the-counter, that you have to read the directions. You should know what you're doing. There is a great abuse potential. Specifically, I'm sure you are all aware that certain cough medicines like Nyquil, Robitussin, and etcetera are good. On the other hand they contain Dextromethorphan. When you take too much of it, it can have many bad side effects. Hallucinogenic side effects. It will certainly affect your thinking processes. The nonsteroidal anti-inflammatories medicines, aspirin, have many side effects. People often take these medicines for pain. You want to get rid of your pain sooner as opposed to later and you take too many. Not a good thing. Side effects. Caffeine has many side effects. A lot of the energy drinks we see around now, I think you should be cautious, be aware of those. Diet pills are advertised and I suspect most people have heard of those past tales of diet pills. The woman who left her diet pills on the counter in a little bit of water and then a day later you saw the little tapeworms coming out of them. These pills need to be very carefully vetted. They should not be used. They should not be advertised in the way that they are advertised on this format here. Laxatives, particularly herbal diuretics, can be troublesome. The reason this is here is because ephedrine and pseudoephedrine, which occur in nasal decongestants, are fairly dangerous thing in your home chemistry laboratory. You can get your pseudoephedrine, your Sudafed, and turn it into methamphetamines. The laws have been restricted somewhat, but there is still the effect. The change of law is really very limited yet and this was a major source, or supply, for methamphetamines for quite a long time. Changed, but still not perfect. My medical concerns and worry is that drug interactions are not emphasized in this. Very important area. Second, it really doesn't distinguish who's getting these medicines. Pregnant women, elderly people, and particularly kids. It turns that kids from age 13 to 16 go to the medicine cabinet and they are one of the major groups that over use overthe-counter medications. Dosing is very important. I think this Joint Resolution is ill advised. It's practicing poor medicine. I think it should not get our seal of approval because it has a

number of false statements. I think it needed to be vetted more carefully. If someone brought this to me in my office I'd recommend quite strongly they find a new healthcare provider. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from Lincoln, Senator Johnson.

Senator JOHNSON: Thank you, Mr. President. Ladies and gentlemen of the Senate, I, too, rise to note that there are some philosophies in this Resolve that are problematic for me. The good doctor has shared the concerns about over emphasis on the drugs themselves and their problems. I'd like to speak to a different perspective for a moment. Self-care, which this Resolution, how it's written, describing self-care flies in the face of evidence and guite a number of meetings in my district that have been happening around how people deal with health issues and live healthier lives; live longer lives with more fulfilling time spent doing so. Over-the-counter drugs do help people cope briefly with symptoms, but real and lasting health is found through a healthier lifestyle, not through reliance on drugs. Better eating, more active habits, and de-stressing or setting aside time to destress through making connections with family, faith groups, positive friendships. Living a life of purpose in which you have a reason that you get up every morning. These are what constitute effective self-care. In light of that, I cannot support and would urge your support for placing what we trust to be important in selfcare somewhere else. Thank you.
