I wanted to share some student input on this item and share this with you guys. What I heard was that the ones who were for it were for it for some of the following reasons: free time, rest, and they also mentioned to save gas and to save on the cost of heat. I do have to say that the letters were very well written and the discussion and the information in them was very well thought out. There were some against the item and here are some of the reasons that they included: parents have a work week of 5-days and this would be difficult for them, there would be less learning time, less Summer vacation, there would be an effect on the teacher's and the bus driver's pay, and there would be an effect on sport schedules with one less day. Here is one that I thought really hit home and I was really impressed that the students brought this one up: some kids only get to eat when they are at school and if we had one fewer day that is one fewer day that some kids would be eating. To summarize the letters for you, that's a little indication on how thoughtful and what insight these 7th graders at the Cohen Middle School had regarding this issue. I took a little tally on the letters just to let us know their thoughts and found out there were 4 that were neither for nor against, they gave me information on both sides to consider, and there were 13 for and 28 against the idea. They were in concurrence with the
