JOINT RESOLUTION RECOGNIZING PARKINSON'S DISEASE AWARENESS MONTH

WHEREAS, Parkinson's disease is a potentially devastating and immobilizing progressive disorder of the brain and spinal cord that causes paralysis, tremor, depression and isolation and is unpredictable in its outcome; and

WHEREAS, Parkinson's disease is estimated to occur in approximately 7,000 adults and in an unknown number of children in the State, and numerous care providers in the State shoulder the responsibility of caring for those affected; and

WHEREAS, in a typical week, a Parkinson's disease patient requires an estimated 7 care providers, making the number of people directly touched each week in the State by Parkinson's disease close to 50,000; and

WHEREAS, Parkinson's disease symptoms are neither clearly understood nor exactly quantifiable by either the medical community or the general public, which creates distress and danger in the lives of Parkinson's disease patients, especially those arriving at emergency rooms in the State's hospitals; and

WHEREAS, upon arrival at an emergency room, Parkinson's disease patients are often treated by medical personnel who are untrained in treating this disease, which causes inaccurate health assessments and leads to the use of inappropriate medications that may exacerbate the symptoms; and

WHEREAS, there are only two movement disorder neurologists in this State who specialize in Parkinson's disease, one in Scarborough and one in Westbrook, which makes access limited for prospective patients, and beyond these two physicians, there are insufficient treatments and no trained personnel at any level in the State; and

WHEREAS, in order to save lives, there is an urgent need to establish and fund a plan regarding Parkinson's disease to train and educate emergency room personnel, law enforcement personnel, firefighters, other public safety workers, emergency medical services' personnel, boat and shipping captains, directors of transportation and supervisors of state parks and recreational areas; and

WHEREAS, there is a network of fifteen Parkinson's disease support groups statewide, located in Augusta, Waterville, Greater Bangor, Biddeford, the Blue Hill area, Bath, Brunswick, Cape Elizabeth, Camden, Greater Portland, Lewiston, Norway, Westbrook, Yarmouth and York, and 2 other groups, a younger onset group in Brunswick and a Parkinson's Plus group in South Portland; and

WHEREAS, the Maine Chapter of the American Parkinson Disease Association, the Maine Parkinson Society and the MaineHealth Learning Resource Center are all jointly established at a central resource at the Maine Medical Center campus in Falmouth, with satellite resources in all MaineHealth Learning Resource Center locations, including Norway, Scarborough, Falmouth, Portland and Maine Medical Center's East Tower; and

WHEREAS, April 11th is known globally as World Parkinson's Day, and April is Parkinson's Disease Awareness Month; now, therefore, be it

RESOLVED: That We, the Members of the One Hundred and Twenty-fourth Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to express our support for and commitment to all efforts being made by the Parkinson's disease community to close the gaps in funding, services, training, education and care that currently exist; and be it further

RESOLVED: That suitable copies of this resolution, duly authenticated by the Secretary of State, be transmitted to the Maine Parkinson Society, the Maine Chapter of the American Parkinson Disease Association, the MaineHealth Learning Resource Center in Falmouth and the University of New England's Medical School, the College of Osteopathic Medicine.

Senator **CRAVEN:** Thank you, Madame President. Men and women of the Senate, Parkinson's Disease is a progressive disorder that affects over 1.5 million people in America and 7,000 of those people are from Maine, which puts us above the national average. I don't know why we are above the national average for suffering Parkinson's Disease. This is Parkinson's Disease awareness month. It's important for us to be aware of this issue that affects our constituents and Maine families. This debilitating disease gradually erodes a person's ability, physically and mentally. I think that we need to be sympathetic to people that are living with Parkinson's. All of those numbers just seem like statistics and that is what they are until they hit a loved one or somebody in your family. My family is afflicted with this disorder. My husband is a Parkinson's Disease sufferer. The sadness and the shifts that happen in your life is very, very difficult when a person is diagnosed with this disease in your family. The lack of ability and the cost of just making sure that the disease is controlled is really something that impacts families. I have nothing to add to this sentiment but that it happens to real people and people struggle with this on a daily basis. Thank you, Madame President.

THE PRESIDENT: The Chair recognizes the Senator from Lincoln, Senator Trahan.

Senator **TRAHAN:** Thank you, Madame President. Ladies and gentlemen of the Senate, I ask that you defeat the pending motion and move to adopt the House Amendment. I'll tell you a little bit of history about this issue that came before the Inland Fisheries and Wildlife Committee some 8 or 10 years ago. That is the use of ATVs on private property. That's really what this issue is trying to resolve. More than that, the abuse of ATVs on private property. For those folks who have a short memory, we were here some 8 years ago trying to find a way forward that would allow ATVs to be used on private property. The reason that came about was because there was such an abuse of ATVs on private property. I am a self-employed logger. I've work for landowners some 26 years now and I can tell you, for landowners abuse of their property was a serious issue. Not by the loggers, but by the ATVs that were coming onto their property, running up and down brooks, tearing them up, creating washouts, using roads during times of the year when they shouldn't be, tearing them up, creating erosion problems, dumping, drinking, going down camp roads and breaking into the camps. There was just a whole array of abuses that were going on and landowners cried out for help. The Inland Fisheries and Wildlife Committee tried to find some common ground and I think we did that with an agreement that allowed game wardens to stop ATVs on private property. That became the law. It was challenged in court. The Supreme Court ruled very divisively, 4 - 3, that these types of stops were allowed. Why I rise to ask you to defeat this pending

motion is because of the ripple effects that will occur if we don't pass this piece of legislation. Many of you know the Brookings Institution did a comprehensive report about how Maine can move forward and invest in our economy. One of their key recommendations was to invest in what makes Maine unique. That was our natural resources. If we don't try to find a balance between landowners, which by the way own the vast majority of land in Maine and are gracious enough to let us use their land, then I believe you will see a serious posting going on statewide. That would be sad. We did strike a balance last year upon my objection and many of the committee members. We passed a bill that we are now trying to repeal. I opposed it then and tried to say to wait for the Supreme Court to rule. Other members did not want to do that and we muscled through this bill that I think we are trying now to fix. I ask you please defeat this motion and support the action of the other Body. I believe it will strike a balance that is desperately needed but it will also allow us to move forward and continue to use private lands. Thank you, ladies and gentlemen.
