I think, as everybody knows, the health care delivery system in Maine is so very expensive and very fragmented. This bill would create a commission that would call in together all of the actors in long-term care, the delivery of medical care, and you name it. They are going to be invited to

the table to see if we could create a system that is less expensive and much more geared towards reducing costs in the community. This was a fairly large bill as it was originally presented to us. It is now amended to a very narrow group of people that would work much more efficiently together. I ask for your support in passing this legislation. Thank you.

Senator **CAIN**: Thank you Mr. President. Men and women of the Senate, it's a very exciting day because today is the day that we award, here in the Legislature, the scholarships that are the results of your generosity and hard work and the contributions of those who work in and around this building to support the Legislative Memorial Scholarship Fund. A little bit of history for your benefit and for the benefit of the award winners and their families today. The Legislature began raising scholarship funds in 1981 after the death of former at-the-time State Representative Steven Gould, who was from Orono, and also the tragic death of a House Page named David Michaud. From that, the Gould and the Michaud Scholarships were formed. Auctions were held on an annual basis to raise funds for those two scholarships from 1981 until 1994, at which time a larger committee was formed and they decided to take the scholarships statewide. The Gould and Michaud Scholarships still exist today and are designed to support students, one who attends the University of Maine and one attends the University of Maine at Fort Kent, in memory of Representative Gould and Mr. Michaud who were from those two respective communities. In 1994 the Legislature took on the larger task of the Legislative Memorial Scholarship program. We expanded the program to include a scholarship winner from every county in the state of Maine and they would be Maine residents who were attending any college or university, two year or four year, in the state of Maine. We have been awarding scholarships, originally, at \$500 and then we increased the award to where now we annually award \$1,000 to one very deserving student from each county across the state. This scholarship doesn't happen by accident. It happens because of your generosity, your fund, and your contributions to the auctions we hold each year. Really the all-stars of the day are the students. As they come up I want you to realize that each of these students had to apply for this scholarship. They had to submit their transcripts; get letters of recommendation; and write essays that were read by a panel of volunteer readers, some legislators and some staff, just some volunteers who have been involved with this program for a long time. As someone who has had the privilege of reading these stories for several years, I can tell you it is an often occurrence that I find myself in tears or having my breath taken away by the amazing stories of the dedication of these students, and of the amazing support that their families and their communities show them, often times overcoming great obstacles, financial and otherwise. When you look at each one of these students today and congratulate them and celebrate them

and give them the scholarship that they came here to take home with them, I hope we can all realize that every one of these students is special. Every one of these students is deserving. I hope each of them success, and I know we all do as well, as they continue their studies here in the state of Maine and that they make a future here as well. Thank you, Mr. President.

Senator **TUTTLE:** Thank you Mr. President. Members of the Senate, I think I owe this Body an explanation of why I'm on the Minority Report. The current statute of Maine Revised Statutes under Title 19-A, known as the Grandparent's Visitation Act, provides for grandparents who may be petitioning the court for reasonable rights of visitation and their access to their grandchildren. The statute provides direction to grandparents as they ask the court for standing to petition for visitation rights as the court is deciding issues concerning the best interest of the child. The death of one or both parents, divorce, or termination of parental rights are examples that may prompt this action. Under the statute, in order for grandparents to receive this standing the petitioner must demonstrate that they have a significant and existing relationship with the child. Under current statute, this term is not defined. The bill attempted to provide the definition needed for grandparents who are seeking contact with their grandchildren under this statute. All 50 states have enacted grandparent visitation statutes that specify circumstances under which grandparents have standing to petition for court ordered visitation. Because these laws affect fundamental parental rights, the courts have subjected them to a strict scrutiny standard and have applied all due process and equal protection requirements under the 14<sup>th</sup> Amendment. I've had many of my constituents call me on this issue, not just this year but for many years, about the difficulties that many grandparents have had involving their grandchildren. I have a constituent myself that could not see their grandchildren for 15 years. Then when the children finally got to legal age, they were finally able to see their grandparents. That's why I did sign onto the Minority Report. I think this is an important issue that we have addressed over the years and hopefully will continue to address in the years ahead. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Valentino.

Senator **VALENTINO:** Thank you Mr. President. Men and women of the Senate, we do have, currently, a grandparent's visitation act and is one of the things that we put a lot of weight on the committee, certainly. I am a grandparent and parent of four children and I certainly understand that there is a relationship there. The law court did reach an interpretation of what sufficient existing relationship was. They did this in order to save the statute from a Constitutional attack. The law court noted that forcing parents to defend against a claim for grandparent visitation may infringe on the fundamental right of parents and such an infringement is subject to strict scrutiny. We did run this through the Maine Family Law Advisory Commission and their conclusion was that the bill purports to broaden the definition of sufficient existing relationship beyond what would likely pass

Constitutional muster under current law and, therefore, such an amendment would not be prudent at this time. Thank you.

This amended bill would, and I'll read the amendment, "Beginning on January 1, 2014, the Department shall enroll in MaineCare each foster child on the child's 18<sup>th</sup> birthday, providing the individual with a MaineCare card, an explanation of MaineCare coverage, and notice for future requirements. The Department shall also publicize in appropriate venues the availability of MaineCare for foster care children under 26 years old, including by notifying foster parents who have served in that capacity." This does not have a fiscal note. This is merely to inform children who are brought up in foster care that they are eligible for this

benefit. Just to remind the Body, children who have suffered through such enormous trauma really benefit a lot from having medical and mental health services available to them as they are trying to get their feet under themselves for the rest of their lives. Thank you, Mr. President.
