THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator McCormick.

Senator **McCORMICK:** Thank you, Madame President. Ladies and gentlemen of the Senate, I rise in opposition to the current motion. This particular bill would take away what's been practiced in law in this state for many years. Basically, if I were involved in an automobile accident and my insurance company made payments for medical causes on my behalf, it is a long held practice that they may go to the other insurance company and try to recoup those expenses from the at-fault person. In addition, if I, personally, were to sue the at-fault person and if I was to get an award or a settlement and they had not recouped their medical

expenses they could take part of that settlement and apply those to their expenses. The whole idea being that they represent me. They are trying to keep my insurance costs down. This bill would eliminate that subrogation of penalties. On the original bill, when it was first voted in Committee, there were three members of this Body that thought it was a bad idea and opposed it. A couple of weeks later we entertained an amendment that would say that it would modify this bill to where if the settlement was more than \$20,000 they would allow the subrogation, if it was under \$20,000 it would not. In my opinion, I was opposed to this. It was a bad bill when it began and it is still a bad bill and sets a precedent that's not custom in many other states. I encourage you to oppose the pending motion. Thank you very much.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Bowman.

Senator **BOWMAN:** Thank you, Madame President. The committee amendment to this bill allows subrogation only when an insured's award or settled damages exceeds \$20,000. I want to read to you, just very briefly, the sponsor's testimony on this particular bill. 'Medical payments coverage is part of every automobile insurance coverage issued in the state. It is intended to promptly pay your medical bills regardless of who is at fault in the accident. Typically this amount is \$5,000 or less and your insurer pays this amount to you. This is coverage that you pay for in your own individual policy. The coverage is especially important to someone who is involved in an accident and has no other health insurance to pay for medical bills and for those with medical insurance so that it can cover any deductibles or co-payments that they might have. The problem with this coverage in Maine is that when you attempt to settle a claim for damages against another party who is responsible for the accident your own insurance company then wants to be reimbursed for the medical bills that they paid. This action by your own insurance company is called subrogation and in fact, even though you purchased this coverage, your insurance company wants the money back, which is taken from your settlement with the other insurance company. This action by your own insurance company is almost always a shock to the victim of the accident and often makes it extremely difficult to settle cases, especially if they are small, which is most of the time. If cases cannot be settled they are then pursued in court, which is costly to all involved.' I believe that this is a pro-individual as opposed to a pro-insurance company measure that we are taking here. It's only in small amounts that we are talking about, less than \$20,000. It would decrease the court workload and for those reasons I believe that this bill, as amended in Committee, ought to pass. Thank you.

On motion by Senator **McCORMICK** of Kennebec, supported by a Division of one-fifth of the members present and voting, a Roll Call was ordered.

THE PRESIDENT: The Chair recognizes the Senator from Aroostook, Senator Sherman.

Senator **SHERMAN:** Thank you, Madame President. Ladies and gentlemen of the Senate, may I pose a question through the Chair?

THE PRESIDENT: The Senator may pose his question.

Senator **SHERMAN**: Thank you, Madame President. During the testimony on this bill, I gather the insurance companies opposed, was there any financial figures given as to the amount of money they felt they would lose?

THE PRESIDENT: The Senator from Aroostook, Senator Sherman poses a question through the Chair to anyone who may wish to answer. The Chair recognizes the Senator from Cumberland, Senator Bartlett.

Senator **BARTLETT**: Thank you, Madame President. I rise in support of the pending motion. I think what is important to understand here is that what we are talking about is shifting money around within the system, not new costs to anyone. It's just a matter of how it gets paid. Currently, if you are in an automobile accident, as the good Senator from York had mentioned, your own insurance company will typically pick up \$5,000 in med pay. When you go in to settle your personal injury claim against a third party you are going to have to turn around and pay that \$5,000 back to the insurance company. It's an administrative issue. It's complicated. People don't realize it, necessarily, when they are settling. All this is saying is when the \$5,000 is paid by your own insurance company you don't have to pay it back when you settle your case. If anything it's a shift just from one auto insurance carrier to the next. There is no net added cost to the system. When you settle your case it will be taken into account that you don't have to reduce it. Other states already do this, for example New Hampshire, our neighbor, does not allow recovery of subrogation. It just affects the value of the settlement. It's just a matter of shifting money around between insurance companies and avoiding the hassle. When you are injured you are trying to deal with getting your case settled. Having this additional hassle is just complicated. People don't understand it. This is streamlining it. Simplifying it. It shouldn't overall affect the cost of policies.

THE PRESIDENT: The Chair recognizes the Senator from Penobscot, Senator Plowman.

Senator **PLOWMAN**: Thank you, Madame President. Men and women of the Senate, as a former legal secretary and clerk for most of my life before I came here, I can tell you that every law firm I worked at had the new associates do the subrogation. I also worked for many of the trial lawyers that you see in the halls here today. The net result of this is that the 25% to 30% that is owed to an attorney is based on how much money does not go back to the insurance company. That \$5,000 that stays in the settlement becomes the part of the settlement from which you take your 25% or 30%, depending on whether it goes to trial or not. Also in many cases where there is a settlement the attorneys actually will make phone calls and try to dicker with the providers and the insurance companies to get them to take a certain amount. That's also a representation that's done by attorneys. Basically, when you are talking about making someone whole that is the insurance company's problem and it should be the problem of the person who caused the action and should be on the hook. Your insurance company is there to make sure you get the care you need, when you need it, as quickly as possible so that you don't have to wait for a suit to be cared for. It should be their ability to turn around to the party who created your situation and say to them, 'We took care of them first, we did the right thing, but those costs don't belong to us.' Those costs belong to the party

who actually caused the action and caused the damages. It's a long held principle that you are making the party whole. There is a long held principle that you do pay your attorney for what you do and it's a long held principle that you should be able to recover the costs that you incurred to make sure that your client, your customer, got everything they needed. Changing this changes the relationship all the way around. I don't think it's necessary and I think that it was a bad bill and I think that the addition on it makes it just as onerous. If you don't think that it's going to have some kind of impact on rates, especially your rates because now this becomes your experience with your insurance company. I don't see how you can leave that logic out of it. I would urge you to reject this. Thank you.

THE PRESIDENT: The Chair recognizes the Senator from Cumberland, Senator Bartlett.

Senator **BARTLETT**: Thank you, Madame President. I rise to make one correction. This will not have any impact on attorney's fees. Currently if your own insurance company pays for \$5,000, for example, and you pay that back out of the settlement, it's reduced by the amount of attorney's fees so the net effect, in terms of the costs to attorneys is indifferent. It really comes down to the amount of money that stays in the pocket of the person who is injured.

THE PRESIDENT: The Chair recognizes the Senator from York, Senator Bowman.

Senator **BOWMAN**: Thank you, Madame President. I just want to reiterate what has been said before. New Hampshire, our frugal neighbor, which we often refer to enviously in certain circumstances, already figured out the concepts expounds by this bill as modified by the amendment a long time ago. In New Hampshire med pay coverage is considered a contractual coverage that you have purchased and is not subject to subrogation. I believe that the public policy in Maine should be the same. I ask your support for the bill.

THE PRESIDENT: The Chair recognizes the Senator from Kennebec, Senator McCormick.

Senator **MCCORMICK**: Thank you, Madame President. I would just like to make one comment about the claim that this would not add any cost to the system. If my insurance company pays \$5,000 for my medical benefits and your insurance company pays me \$5,000 for my insurance benefits there is a \$10,000 cost now to the insurance industry as a whole, not \$5,000 if they had just swapped it within the system as somebody else claimed. Thank you very much.

THE PRESIDENT: The pending question before the Senate is the motion by the Senator from York, Senator Bowman to Accept the Majority Ought to Pass as Amended Report. A Roll Call has been ordered. Is the Senate ready for the question?
