> JOINT RESOLUTION RECOGNIZING FEBRUARY 3, 2024 AS TOPICAL STEROID WITHDRAWAL SYNDROME AWARENESS DAY

WHEREAS, Topical Steroid Withdrawal Syndrome, also known as Topical Steroid Addiction or Red Skin Syndrome, is a severe, debilitating condition that can arise from intentional or unintentional exposure to topical steroids; and

WHEREAS, topical steroids are widely prescribed and purchased over the counter to treat acute and chronic skin conditions such as eczema, psoriasis, vitiligo and alopecia areata; and

WHEREAS, Topical Steroid Withdrawal Syndrome is characterized by skin flushing, inflammation, diffuse spreading rashes, profuse skin flaking and a burning and itching worse than the original condition, symptoms that typically appear after the use of topical steroid treatments, between treatments or after discontinuing treatments; and

WHEREAS, symptoms may take several months to several years to subside, leaving some Topical Steroid Withdrawal Syndrome sufferers bedridden and housebound, unable to work, care for children or go to school; and

WHEREAS, a prolonged withdrawal and recovery period can take a significant toll on a person's mental and physical health, and 81% of adults and 56% of children experiencing Topical Steroid Withdrawal Syndrome report feeling anxious or depressed and 47% of adults and 11% of children experiencing Topical Steroid Withdrawal Syndrome report suicidal ideation; and

**WHEREAS**, the prevalence of topical steroid addiction is unknown due to a scarcity of published research; and

WHEREAS, the scarcity of research on Topical Steroid Withdrawal Syndrome impedes efforts to define diagnostic criteria; understand the causes, mechanics and effects of the syndrome; develop appropriate treatment protocols; and educate providers and patients about the syndrome and steroid stewardship; and

WHEREAS, a lack of awareness of and education about Topical Steroid Withdrawal Syndrome among patients and providers can lead patients to question their providers' medical oversight and providers to suspect their patients of medication noncompliance and occasionally parental neglect; now, therefore, be it

**RESOLVED:** That We, the Members of the One Hundred and Thirty-first Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to designate February 3, 2024 as Topical Steroid Withdrawal Syndrome Awareness Day and to express our support for increased awareness and prevention education on the signs of topical steroid dependence and the risks of Topical Steroid Withdrawal Syndrome.

Senator RAFFERTY: Thank you, Mr. President. Grace Campanella could've been the daughter or granddaughter of anyone in this room. In my case, she was a former student, and from my view, Grace was always very happy. She was a talented athlete, passionate about tennis, and had a genuine love for animals. Grace as a sophomore and junior was a two-time state champion in tennis and if not for COVID in 2020, she was the favorite to win a third. She did win a scholarship for the Division I tennis program at the University of Rhode Island, where she wanted to study to become a veterinarian. The pandemic did more than strip Grace of her last high school season and her momentum. The forced isolation and accompanying anxiety spiraled into despair and depression. She became estranged from the college tennis team, she lost interest in her academics. and her darkest hour came late last month. Grace committed suicide while on break during the winter of her senior year. She was 22. Her parents wrote in her obituary she struggled the past two years to see a life ahead of her, and they were quoted as saving we will now struggle to see a life without her. Karen, Kevin - her mom and dad - and her sister, Rose, are hopeful that by sharing Grace's story, which they -- that was published in the Portland Press Herald recently, they can chip away at the stigma surrounding suicide, raise awareness of mental illness, and encourage those who see a friend and a loved one in crisis to offer support. My ask is that each of us keep Grace and the many people across our state struggling with mental illness in mind as we deal with related legislation moving forward. # JOINT RESOLUTION RECOGNIZING FEBRUARY 2024 AS BLACK HISTORY MONTH

WHEREAS, Maine's Black history and the story of Maine's role in the global economy of enslavement have been largely effaced from our narratives and from our collective consciousness; and

WHEREAS, from the earliest arrivals of people from Europe and Africa in the Americas, Africans and African Americans have been part of the story of this land, and researchers have identified over 1,900 people of color who lived in what is now called the State of Maine prior to the year 1800; and

WHEREAS, Africans who were brought involuntarily to these shores suffered generations of enslavement, and their descendants faced the injustices of lynch mobs, segregation and the denial of basic fundamental rights; and

WHEREAS, people living in Maine engaged in the slave trade for at least 112 years, with the earliest known slaving voyage departing from Maine's shores taking place in 1749 and the last known slaving voyage on a Maine-built vessel taking place in 1861; and

WHEREAS, a total of 63 Maine-built vessels are known to have transported enslaved people, representing only the tip of the iceberg, and slaving vessels were constructed in at least 26 Maine towns; and

WHEREAS, Maine merchants were deeply entangled in the global economy of enslavement, as were the banks that handled their accounts and the insurance firms that secured their investments, and at a time when Havana, Cuba was the hub of the illicit slave trade, Portland was that city's number one trading partner; and

WHEREAS, it was not only Maine's coastal towns that were complicit in the global economy of enslavement through shipbuilding and merchant trading activities, but its inland regions as well: crops and livestock were routinely shipped in the "coastwise" trade to provision the sugar plantations of the West Indies, along with salted fish and even ice from this region; and

WHEREAS, great quantities of Maine timber were processed into barrel staves and shipped throughout the 18th and 19th centuries to the West Indies, where enslaved Africans were forced to fashion them into barrels; they then filled these barrels with the sugar and molasses that were shipped back to Portland and distilled into rum, which was used as currency in purchasing more captive Africans; and

WHEREAS, African Americans in all walks of life have shown resilience despite suffering under slavery and injustice and have made significant contributions throughout the history of the State and across the United States; and

WHEREAS, from the Revolutionary War through the abolitionist movement, to marches from Selma to Montgomery and across America today, and in this State, African Americans have remained devoted to the proposition that all of us are created equal, even when their own rights were denied; and

WHEREAS, the month of February is officially celebrated as Black History Month, which dates back to 1926 when Dr. Carter G. Woodson set aside a special period of time in February to recognize the heritage and achievements of African Americans; now, therefore, be it RESOLVED: That We, the Members of the One Hundred and Thirty-first Legislature now assembled in the Second Regular Session, on behalf of the people we represent, take this opportunity to recognize the significance of Black History Month as an important time to honor the contributions of African Americans in the nation's history and encourage all people in the State to learn more about the past and to better understand the experiences that have shaped the State and the nation.

**THE PRESIDENT**: The Chair recognizes the Senator from Cumberland, Senator Duson.

Senator **DUSON**: Thank you, Mr. President. I have deferred the spotlight of Black History Month to spotlight this Resolve, and I thank you for reading the Resolve. I also wanted to announce that there will be an event celebrating Black History Month, a luncheon today in the AFA committee room after session.

**THE PRESIDENT**: The Chair recognizes the Senator from Kennebec, Senator Hickman.

Senator **HICKMAN**: Thank you, Mr. President. My father would say sometimes you have to toot your own horn. And I will say to my colleagues in the Senate that we recognize the black history in this Chamber. Senator Duson is the first black woman ever to serve in this body and I'm the first black person ever to serve in both Chambers of the Maine Legislature. Thank you, Mr. President.

**THE PRESIDENT**: The Chair recognizes the Senator from York, Senator Lawrence.

Senator LAWRENCE: Thank you, Mr. President. And as we recognize Black History Month, I would be negligent if I didn't stand and say the history in my district. This Chamber used to have the picture of William Pepperrell adorning up here on the Chamber. And I grew up in Kittery, which is where Maine was founded in the 1620s, and I remember as a child, I went to the church down in Kittery Point and would play over in the old cemetery across the street. This was the original parish of the Town of Kittery and of the Berwicks. And I used to play down by the shore and there was a gravestone down there of -- marked the grave in the 1600s of African slaves who were brought over and died on Gerrish Island in Kittery in a shipwreck and they were buried in that cemetery along the shore. The history of slavery goes very far back in the district of Maine. We sometimes don't think of that. We don't think of how much it has impacted the state of Maine. But there's a woman who was a constituent of mine for a long time. Patricia Wall, who wrote a book called Lives of Consequence, in which she chronicles that history, and if you want a good historical read of African American history in Maine and early history in the Berwicks and Kittery when Maine was first founded, that is a very good read on the history. There's also a movie that has come out recently by another constituent of mine on Sir William Pepperell that sheds light on the fact that sometimes we glorify some people because of he accomplished great things, but we don't recognize the times they lived in and what that meant for slavery in this country. The New England

colonies, they were very much a part of supporting the slave trade, and Maine was, too, at that time, and I think as part of Maine History Month -- of Maine Black History Month, we need to recognize and accept that history. Thank you.
