Senator **HICKMAN:** Thank you, Mr. President. I rise to honor this historic victory and in doing so, if you'll indulge, I will read part of the reporting by Dave Dyer after this was achieved by these young men. It was Maine high school basketball at its finest. Fending out Mount View throughout the fourth quarter, the Monmouth Academy boys basketball team managed to hang on and take a wild 52 to 50 victory in the Class C final at the Augusta Civic Center earlier this month. It's the first gold ball in program history. It feels crazy, said Monmouth senior forward Sammy Calder, who led the team with 17 points. It feels even better to get it right after winning a state title in soccer, just to keep the ball rolling. Three gold balls for this school after 12 months? It's insane. It also capped a dramatic postseason for run for Monmouth, which won all four postseason games by a total of 23 points. Monmouth beat Mount Abram 46 to 43 in the Class C South final after needing overtime to edge Hall-Dale 73 to 67 in the regional semifinals. Kyle Palleschi scored 13 points for Monmouth, nine of which came in the third quarter. Bingham Abbott added eight points. I don't think I could put into words how proud I am of this team, Monmouth head coach Wade Morrill said. This day marks the 104th day of basketball in a row. Our boys grind. I don't think a lot of people thought we could be here, I think we've been counted out most of the year, really. We had to prove it every night. We adapted that mindset. It was a game of runs in the first half. Mount View went on a 12-0 run in the fourth quarter, then Monmouth responded with an 11-0 run in its own late in the second quarter. Noah Hurd and Wyatt Evensen each scored nine points in the first half while Calder led Monmouth with eight points. Monmouth then went on a 7-0 run in

the third quarter and outscored Mount View 18-11 in that period. But Evensen and Hurd scored seven points early in the fourth quarter, tying the game 45 to 45 with 4 minutes left to play. Me and Luke Harmon were just trying to calm the guys down, and then I tried to calm Luke down, said Calder, who also had seven rebounds. I just told the guys to keep their heads, try not to do stupid turnovers, don't do anything crazy, just play our game and play as hard as we can on the defense. Baskets by Calder, Abbott, and a free-throw by Jacob Harmon helped give Monmouth a 52-50 lead. On Mount View's last possession of the game, Hurd found Evensen, who dribbled to his right, took a shot at the side of the basket, but it bounced off the glass. The Mustangs are the champions. At the end of the day, Coach Morrill was most impressed with his group's depth than anything after their show of resilience. Kyle got in foul trouble, Luke fouled out, we ended up using eight guys. Rory hasn't played all tournament, came in and played two great minutes for us. Jake, a freshman, stepped up big, Levi gets banged up, sucks it up for a few minutes. I just can't say enough about our boys' mental toughness. Mr. President, I'd like to say congratulations to Steve Bell, the athletic director, Coach Wade Morrill, and the entire Monmouth Academy boys basketball team on their historic victory. Congratulations. Thank you, Mr. President.

Now, last year, I was talking to the coach, and they fell just shy of a state championship and they were fully committed to bringing the championship home this year and they accomplished their mission. As a basketball coach, I often coach teams that win by razor-thin margins and it doesn't matter if you win by a razor-thin margin or if you win going away, if you win a state championship, it's something that you can celebrate for the rest of your life. There were some clutch efforts by these gentlemen that are up in the Gallery behind me, we all want to recognize them and tell them just how proud we are to represent them. Congratulations once more to all of you for your efforts in winning the state championship for Massabesic High School. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Harrington.

Senator **HARRINGTON:** Thank you, Mr. President. Mr. President, I rise today to recognize an incredible group of young men from Massabesic High School. A little over a month ago, the Massabesic Boys Wrestling Team won a Class A State Championship, something they had not done since 2008, when their new coach, Joe Eon, was on the team. After a crushing second place -- after crushing second place at Noble the years before at the state championship, the seventh runner-up finish since 2008, the Mustangs were determined to reverse the trend. As you may know, the most important thing at a regional meet is to place as many wrestlers as possible in the top four of their weight class, thus qualifying for the state meet. After this year's regional championship, it seemed like Noble may be in for another state title. And I have to be careful here, because I also represent wrestlers at Noble. They ended with 201.5 points and sent ten plus one who wrestled as an alternate of their 14 wrestlers to the state meet. Massabesic finished second at the regionals with 176 points and sent seven wrestlers to the states. But as we know, quality is more important than quantity, and these seven proved it. At states, Massabesic put five wrestlers into the final. Jack Harriman, Dominick Bubar, as well as brothers Isaac Broulard and Evan Broulard won titles. Nicholas Chenard, at 132 pounds, lost one of the most exciting matches in the finals 11 to 9. Massabesic won the title with 114.5 points, Noble which had entered the state championship finals with a slim 5-point lead, were second with 109.5. Mount Blue of Farmington, where our colleague from Franklin County wrestled in the 1970s, finished third with 91 points. Furthermore, at the end of February, Massabesic went to take 21st out of 187 teams at the New England Championships in Rhode Island. I'd be remiss if I didn't mention Mustang's phenomenal coaching staff, head coach Joe Eon, who was a four-time state champion himself, assistant coach Leo Amabile, who was a state champion and a hundred-win wrestler, and assistant coach Lucas Labbe, who also coaches football and baseball. They bring out the strength and talent of their wrestlers and bring a renowned energy to the team, with an attitude there's no option but to win. That attitude paid off. I want to congratulate these young men on a fantastic season, and I hope to see you back here next year.

Senator **BENNETT:** Thank you, Mr. President, Fellow Members of the Senate. I rise today to maybe jostle some recollections and some memories from days gone by and to say a few words about an extraordinary Mainer, Bill Dunlop, and explain why it's important that we name this bridge after him. Forty years ago, Bill Dunlop of Mechanic Falls disappeared while sailing his tiny sailboat, Wind's Will, somewhere in the South Pacific. The stories of his trips and adventures in a boat a little larger than a bathtub are legendary. Bill is best known for his 1982 transatlantic crossing in Wind's Will, which set a world record for a solo eastbound crossing in the smallest boat. Sailing in the days before the use of GPS was widespread, he relied on a \$16 sextant for navigation. His boat had a radio, but no backup engine. After his courageous 78-day voyage across the ocean, Bill was given a parade in Mechanic Falls and honored with a speech from Governor Brennan. Many locals were calling the town Dunlopville on the day of the celebration. So, ready for a new challenge, Bill decided to circumnavigate the world in the Wind's Will. He left in July 1983, and he always started all of his adventures from DiMillo's in Portland, from the wharf there. And so, he left in July of 1983, sailed down the Atlantic coast, through the Panama Canal, and across the Pacific. He was sailing from the Cook Islands, 3,000 miles east of Australia, when he was hit by an incredible storm that caused 50 mile per hour winds on land - much worse, likely, at sea. Bill was only 43 years old when he went missing in 1984. A note in Bill's handwriting was found in a

margarine tin, washed ashore in Queensland, providing hope that he was still alive. Unfortunately, despite search efforts, Bill was never found, and a few years later, declared dead. For those of you of a certain age, I'm certain that you remember reading about Bill and his adventures in the newspapers. Bill took death-defying trips and traveled the world, bringing world attention to Mechanic Falls and inspiring people to take adventures for their own. He continues to inspire all who are adventurers, which I think in some way encompasses all of us. It is fitting that this bridge in Mechanic Falls, Maine, be named after such a remarkable man. Thank you, Mr. President.

**THE PRESIDENT:** The Chair recognizes the Senator from Hancock, Senator Grohoski.

Senator **GROHOSKI**: Thank you, Mr. President. I'm pleased to share an amazing history today as part of Women's History Month. I'm going to share some information about Cornelia Thurza Crosby, also known as Fly Rod, who was born in Phillips, Maine in 1854 and is famous for being the first registered Maine guide. Crosby took to the woods to hunt and fish after contracting tuberculosis. Her success fishing local trout ponds is what earned her the nickname Fly Rod. She used this nickname as a pseudonym in the columns she wrote, which are credited with bringing thousands of hunters, fishers, and outdoorsmen to Maine, as well as tourists who visited to experience the state's beauty as she had described it. Her outdoors column was picked up by national publications, including the Chicago Evening Post and the St. Paul Times in Minnesota. Not only did Cornelia have skills with the fly rod, she was also a talented hunter. One of her noted accomplishments is that she is the last hunter to have legally killed a caribou. A famous quote from her concludes by her saying, 'I would rather fish any day then go to heaven.' Cornelia became close with members of the Penobscot Nation. They are cited as helping teach her the intricacies of working as an outdoor guide. Her public involvement in this male dominated industry made her an icon and a mentor to young women across the U.S. who read her column. Fly Rod also worked for the Maine Central and Sandy River and Rangeley Lakes Railroad to

market the Maine woods for tourists seeking clean air, natural beauty, and a big fish. She traveled to sporting expos to market the Maine woods. At Madison Square Garden in New York City she set up a life-size log cabin with animal mounts and she wore a purposely short skirt to make a point. Fly Rod was also a conservationist. She worked with the state's first committee to establish fishing and hunting bag limits to help preserve Maine's natural resources. In 1897, legislators passed a bill which she had helped craft that required hunting guides to register with the state. Over 1,000 guides were registered that year, with Cornelia holding the spot for license number 1. The Legislature recognized that everything that Fly Rod had done for the outdoor industry made it so that she was deserving of the number 1 spot, the first registered Maine guide. Cornelia passed away in 1946 at the age of 92 in Lewiston and her grave can be found at the Strong Village Cemetery in Strong, Maine. And I just wanted to note for you all that there are two really remarkable recognitions, that I'm aware of, of Fly Rod in our state. The first is a statue of her that is visible at the Department of Inland Fisheries and Wildlife headquarters in Augusta, that I believe is supposed to move to the Maine State Museum once the renovations are complete, and the second is that there is a trail in Western Maine called the Fly Rod Crosby Trail. This trail is envisioned to be a 45 mile hiking trail that will wend its way from Strong to Oquossoc along the Sandy River, Orbeton and Hardy Streams, will cross the Appalachian Trail and Rangeley Lake to end at the Sporting Heritage Museum and there are currently two sections open, comprising already over 20 miles of continuous trails and I just wanted to mention that because I've had the great honor of working on some of the maps for this trail and if you would like to visit after we adjourn this year I would recommend learning more at a website called Maine Trail Finder.com that I work on and the state also supports. There's a lot of great opportunities to appreciate the part of Maine that Fly Rod really grew up in and cut her teeth in and I hope you will take a visit there, even though it's not actually in my district. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from Androscoggin, Senator Rotundo.

Senator **ROTUNDO:** Thank you, Mr. President. I am honored to close out our series on extraordinary Maine women by lifting up the life of Judith Magyar Isaacson. Judith Isaacson was a Holocaust survivor, a brilliant student and academic who was fluent in five languages, an advocate for women's rights, a best-selling author, and, despite all she had endured, a person who inspired those around her with her grateful, optimistic outlook on life. Isaacson was born into a close-knit extended family in Kaposvar, Hungary in 1925. She was an only child. An excellent student, she had hoped to study poetry in France until the Nazi occupation of Hungary in 1944 sent her and her family into Jewish ghettos and, ultimately, concentration camps and slave labor. Isaacson, who was known as Jutka, arrived at Auschwitz days after turning 19 years old. Upon getting off the train, head shaved and stripped of clothing, she was separated from her mother by the notorious Nazi doctor, Josef Mengele. She

resisted, deciding she might as well be shot then and there if living meant being separated from her remaining family. Somehow, she was allowed to live. In her month in Auschwitz she was fed soup made of sticks and leaves and was forced to witness the horrors of the camp. Eventually, she was sent to work for over one year in an underground munitions factory at the Hessisch Lichtenau slave labor camp in Germany. Most of Isaacson's family was murdered in the Holocaust. Upon arriving at Auschwitz, her grandmothers and one aunt were immediately sent to the gas chamber. Her father was sent to a labor camp in Hungary and then on to the Buchenwald concentration camp. He died of starvation at the Muhldorf concentration camp complex near Dachau. Isaacson's mother and one aunt survived. Shortly after liberation in 1945, Jutka met U.S. Army Intelligence Officer Irving Isaacson in the German city of Leipzig. The two married in Nuremberg City Hall that year, a marriage that lasted seven decades. Irving, an attorney by trade, returned with Jutka and Jutka's mother to the Lewiston/Auburn area where his family was from and where they settled to live and raise a family. In the early sixties, after raising three children, Jutka turned her attention to academics. In 1965, she earned a bachelor's degree in mathematics from Bates College, after which she began teaching math at Lewiston High School and chairing the math department. In 1967, Isaacson was one of the first women to receive a degree from Bowdoin College, earning a master's degree. In 1968, she joined the faculty at Bates College as a lecturer in mathematics. She also became Bates's very first computer science teacher. After excelling as a faculty member at Bates, Isaacson became the Dean of Women at the college in 1969 and Dean of Students in 1975. It was during this time that she sought to create a more equal environment for women and modernize the rules around social conduct at the school. She overturned a rule against students visiting the rooms of students of the opposite sex. She also worked hard to increase athletic opportunities for women. She retired as Dean in 1978. Isaacson spoke freely at Bates about her experience during the Holocaust. In 1976, during a talk at Bowdoin College, Isaacson could not answer a student's question about how she could still smile given all she had been through. The question inspired her to write her memoir, 'Seed of Sarah: Memoirs of a Survivor,' published in 1990. The book made her a regular speaker in classrooms all over the state. And I have just wanted to add that I would highly recommend this beautifully written memoir. It helped to understand the rise of Nazis. How casual taunting and bullying give rise to increasing dehumanizing language to describe vulnerable groups of people and how that dehumanizing language, if not stopped, gives rise to violence. Isaacson's accolades were many. She received honorary degrees from Bates College, Colby College, and the University of New England. She received the Deborah Morton Award for Outstanding Women from Westbrook College, the Gordon S. Hargraves Preservation of Freedom Prize from Bowdoin College, the Maryann Hartman Award for Distinguished Maine Women from the University of Southern Maine, and the Remember Me Award from the Maine Healthcare Association. She was recognized as one of the Women of Distinction by the Kennebec Council of Girl Scouts and she was a member both of the Maine Women's Hall of Fame and the Maine Jewish Hall of Fame. Judith Isaacson inspired this acclaim by radiating grace and thankfulness while still struggling with the aftereffects of her lived experience. As one friend said, 'In her presence, you were just happy. She told me she woke up every morning and thanks the good Lord for every bone and muscle that didn't hurt. I think



that said it all about her. She looked at what was good, not what was bad.' Her honorary Doctor of Laws degree from Bates read in part 'Your strengths touch the lives of not only your family and your colleagues but those countless others who read in your personal and professional life the inextinguishable force of human worth.' Perhaps the most appropriate tribute for this extraordinary woman should be left to the Hungarian poet, Endre Ady, whose poem Isaacson chose to open her memoir, 'All who live, rejoice, rejoice.' Thank you.

Senator **CARNEY:** Thank you, President Jackson, I just would like to share my reflections on the remarks of my good colleague from York. The bill will have a public hearing that will be noticed consistent with the rules of this Body and with the practices of the Legislature that we've all followed this session and during this Legislature. I also just wanted to reflect that having listened to the testimony presented on the other bills that were before the Judiciary Committee, I for one think that this legislation is really important. I am very grateful that we have a legislative vehicle to consider the adoption of a crisis intervention order, and I think it's a really important policy for our state to take up at this time. Thank you.

**THE PRESIDENT:** The Chair recognizes the Senator from York, Senator Harrington, and wants to remind members that we're not going to get into a debate on the merits of bills going forward.

Senator **HARRINGTON:** I would just be curious to know how much notice the public is going to get on this before a public hearing.

**THE PRESIDENT:** The Chair recognizes the Senator from Cumberland, Senator Carney.

Senator **CARNEY:** We have endeavored to have ASL interpreters present for bills related to firearms, and I do not know their availability, and so the scheduling depends to some extent on that, and so I'm not able to answer the question simply because I don't know the availability of the interpreters. But there will be plenty of advanced notice. Thank you.
